RACE COMMENTS:

Race 1	SAM WEATHERLEY CHAMPION APPRENTICE 1600
<p>KATIE PERRIE (R Jones) - Fractious in its barrier before being slow to begin, shifted outwards to obtain clear running near the 300 metres making contact with VERMONT. Returned to the enclosure with blood present in the left nostril which upon veterinary inspection was found to be from a small abrasion caused by external trauma.</p> <p>GO FOR DOUGH (M Coleman) - Began awkwardly then crowded and steadied. When questioned regarding performance rider advised that the gelding had never travelled well and been disappointing with a post-race veterinary inspection revealing a laceration to the right hind coronary band where the gelding had struck itself during the running.</p> <p>NEDDY NADEEM (S Spratt) - Blundered on jumping away, held up behind the weakening KEEPELLA HEIGHTS rounding the bend passing the 400 metres, again held up passing the 150 metres.</p>	

SUSPENSE (J Waddell) - Raced three wide without cover.	
VERMONT (C Lammas) - Bumped 300 metres.	
DANELYN (S McKay) - Held up entering the final straight near the 300 metres and was unable to obtain clear running until approaching the 100 metres.	
BEASTMODE (T Thornton) - Inconvenienced near the 125 metres when SUSPENSE shifted in under pressure.	
Race 2	SAM COLLETT CHAMPION JOCKEY 1400
CAPELLANI (R Elliot) - Began awkwardly. Raced wide from the 800 metres.	
CHARRED (L Satherley) - Began awkwardly, placed in restricted room near the 800 metres.	
OVERINDULGE (S Spratt) - Raced ungenerously for a distance when being steadied shortly after the start.	
AMBITIOUS SHOWGIRL (T Thornton) - Raced keenly outside the leader in the early and middle stages.	
DISPATCHED (C Lammas) - Raced three wide without cover.	
TASMAN WARRIOR (J Nason) - Raced greenly in the run down the back straight and lay in going into the bend near the 800 metres placing CHARRED in restricted room.	
VERNANME (D Johnson) - Held up rounding the final turn and continued to have difficulty obtaining clear running until near the 150 metres.	
Race 3	FASTTRACK INSURANCE-CHARLES ROAD 1400
FURIOUS WALK (C Lammas) - Raced ungenerously when being restrained shortly after leaving the barriers, raced ungenerously when being restrained in the middle stages making the bend near the 800 metres awkwardly.	
MAESTRO BLU (A Sims) - Began awkwardly losing considerable ground.	
ARCTIC LADY (D Johnson) - Began awkwardly losing ground. When questioned regarding performance rider was of the opinion that the filly would be better suited over more ground and with the addition of blinkers.	
JUST A PHOEBE (R Norvall) - Slow to begin.	
RIPPA EAGLE (V Colgan) - Had a tendency to over race in the early to middle stages.	
DELLE QUARTZA (R Jones) - Race three wide without cover.	
KING OF COOL (M Cameron) - Held up near the 400 metres.	
THE MAGNATE (M Coleman) - Held up rounding the final turn and early in the straight before obtaining clear running near the 250 metres.	
Race 4	RICHARDSON RACING-VOLPE VELOCE 1200
ANGELICA (C Lammas) - Restrained soon after leaving the barriers, inconvenienced when placed in restricted room near the 200 metres.	

MASTER PAINTON (T Newman) - Began awkwardly losing ground, raced in restricted room over the concluding stages when ARROGANT lay out away from DAWN PATROL.

AMANO (M Coleman) - Began awkwardly losing ground.

GOBONIEGO (B Grylls) - Raced keenly in the early to middle stages, angled inwards in an attempt to obtain clear running approaching the 200 metres then become awkwardly placed on the heels of GARADOS which had been taken in by DAWN PATROL with GOBONIEGO then having to steady and shift inwards abruptly to avoid the heels of GARADOS.

ARROGANT (J Bayliss) - Raced three wide without cover.

DAWN PATROL (J Waddell) - Lay in under pressure in the final straight inconveniencing GARADOS passing the 200 metres.

THE GLINT (S McKay) - When questioned regarding performance rider advised that the gelding had raced very greenly in its race day debut.

Race 5	FORTUNA-MELODY BELLE 1200

NUCLEAR FUSION (R Elliot) - Began a little awkwardly then briefly crowded, raced ungenerously in the middle stages.

BELLE FASCINO (D Johnson) - Began awkwardly.

LINK ROAD (A Calder) - Raced three wide without cover.

PACIFIC COAST (J Waddell) - Raced keenly in the lead through the middle stages

IT'S BEN AGAIN (L Satherley) - Raced ungenerously when being restrained going into the bend near the 800 metres.

ARMAGUARD (A Goindasamy) - Following the race apprentice A Goindasamy weighed in 0.8kg under the weight at which he had weighed out and was consequently disqualified from its 6th place under the provisions of Rule 648(3). Enquiries revealed that a large towel which had been part of the riding gear weighed out with, had not been placed on the horse when saddling. Trainer Mr S Ralph admitted a charge of being neglectful in saddling and was fined \$300 by the Judicial Committee.

Race 6	WEXFORD STABLES CHAMPION STAYER 2000

AIGNE (A Goindasamy) - Jumped away awkwardly, raced three wide without cover rounding the first bend before improving to sit outside the leader near the 1200 metres.

KYRIE ELEISON (C Lammas) - When attempting to improve to the outside of WINDY HEIGHT rounding the bend near the 350 metres, WINDY HEIGHT lay out when making the bend awkwardly resulting in KYRIE ELEISON being placed in restricted room and shifting outwards making contact with WOODEN EDGE. Prior to the authorisation of dividends connections of the second place WOODEN EDGE viewed Steward's film footage before electing not to proceed with a protest.

WOODEN EDGE (T Yanagida) - Bumped rounding the bend near the 350 metres.

MODEL AYE (J Bayliss) - Slow to begin.

JAYLA MONET (J Waddell) - Knuckled soon after leaving the barriers.

REPO SUN (T Yanagida) - Raced wide without cover.

Race 8

WAIKATO STUD-SIX TIME BREEDER OF THE YEAR 1400

LAGERTHA (J Nason) - Slow away.

EL COOLIO (T Thornton) - Crowded leaving the barriers, raced wide without cover, unbalanced when contacted near the 250 metres, checked passing the 50 metres.

CLARIOS (J Bayliss) - Jumped away awkwardly then commenced to race ungenerously near the 1100 metres and continued to do so for a distance making the 800 metre bend awkwardly.

AZAMOUR QUEEN (S McKay) - Over-raced for a distance passing the 1000 metres having to be firmly restrained to avoid heels.

HARBOURSIDE (M Coleman) - Had to be firmly restrained off heels passing the 900 metres, when improving to the inside of AMEN CORNER approaching the 250 metres was crowded and forced inwards by that runner making contact with EL COOLIO and continuing to race in restricted room for a distance. Again crowded near the 75 metres when AMEN CORNER again shifted inwards under pressure with HARBOURSIDE being forced inwards causing a check to EL COOLIO passing the 50 metres. When being checked EL COOLIO made contact with the hind quarters of ACRE. Following the race a protest was lodged by the connections of the 3rd placed HARBOURSIDE alleging interference by the 2nd placed AMEN CORNER in the final straight. After viewing films and hearing submissions the Judicial Committee upheld the protest relegating AMEN CORNER to 3rd placing.

T Yanagida - Admitted a resultant charge of careless riding with the Judicial Committee suspending his licence to ride at race meetings from the conclusion of racing on Saturday 29th September until the conclusion of racing on Friday October 12th, 8 National riding days.

ACRE (J Waddell) - Raced three wide without cover, received contact to its hind quarters passing the 50 metres.

PALAMEDES (V Colgan) - Held up rounding the final turn then becoming awkwardly placed near the heels of BELLE SOUTH before striking a heel of that runner and blundering near the 250 metres.

BELLE SOUTH (T Miles) - Lay out rounding the final turn before being corrected by its rider. Apprentice T Miles was advised to exercise care. Required veterinary treatment for a laceration to the right hock requiring sutures.

SWISS STINGER (S Spratt) - Checked when placed in restricted room to the inside of PALAMEDES approaching the 250 metres.
