GENERAL:

A Schwerin was indisposed and did not attend the meeting.

RACE COMMENTS:

Race 1	WAIKATO EQUINE VETERINARY CENTRE 1200
SNAPPER (C Lammas) - Contacted leaving the barriers then commenced to buck shortly after and continued to do so for a distance becoming tailed off. After regaining contact with the field was held up early in the straight until passing the 200 metres. Co-trainer P Gerard was advised that SNAPPER would be required to barrier trial to the satisfaction of Stewards prior to racing next.	

STORM SHADOW (M Coleman) - Began awkwardly. When questioned regarding performance rider advised that the gelding had raced greenly in its race day debut and would benefit from the experience.

BRAZIER (O Bosson) - Began awkwardly then knuckled soon after leaving the barriers losing ground. Raced ungenerously in the early stages getting its head up. Had some difficulty obtaining clear running until near the 200 metres.

MEKELLE (D Johnson) - Raced ungenerously when being restrained in the early and middle stages.

PINCHED (O Bosson) - Had to be steadied away from the heels of ROCKET FUEL which shifted inwards near the 1200 metres when not fully clear. M Kareem was advised to exercise greater care. When being steadied PINCHED shifted outwards inconveniencing NEW YORK JAZZ which had to steady.

NEW YORK JAZZ (A Goindasamy) - Steadied passing the 1200 metres.

BOOGIE EASY (S Collett) - Had some difficulty obtaining clear running until inside the final 100 metres.

GABRIEL (R Kozaki) - Began awkwardly making contact with RIP EM UP.

LOIRE (M McNab) - Blundered leaving the barriers.

PINEAPPLE GIRL (M Coleman) - Began awkwardly.

HAKUNA MATATA (S Collett) - Inconvenienced leaving the barriers when COCO BACI jumped outwards.

SHOWBEEL (O Bosson) - Raced ungenerously when being restrained in the early stages.

TRAVELLING LIGHT (S Collett) - Restrained early after jumping from a wide barrier then over-raced in the early stages.

PIMLICO (R Elliot) - Over-raced in the early and middle stages.

SWORD OF FREEDOM (S Spratt) - Underwent a post-race veterinary examination after commencing to give ground appreciably from near the 600 metres which did not reveal any obvious abnormality.

J Riddell (PLATINUM ROAD) - Issued with a warning for his whip use prior to the 100 metres.

MIGHTY CONNOR (R Kozaki) - Slow away. Rider dropped his left rein near the 150 metres.

CARIBBEAN ROSE (S Collett) - Slow away. Held up rounding the final turn and did not obtain clear running until near the 200 metres.

LADY AZAMOUR (A Goindasamy) - Slow away.

DANGERMAN (D Johnson) - Raced three wide without cover.

MOTUMAN (T Newman) - When weakening was briefly steadied when placed in restricted room between MEGHAN and MONLULA which both shifted ground near the 250 metres.

MOIRAS TOWN (S Spratt) - Briefly held up early in the final straight.

Race 7	HERBIE DYKE STAKES

FISCAL FANTASY (M Coleman) - Slow away then further hampered.

GINO SEVERINI (D Johnson) - Raced keenly in the early stages. Had to briefly steady and shift inwards to avoid the heels of the weakening CAMINO ROCOSO near the 350 metres.

THE REAL BEEL (S Collett) - Hampered leaving the barriers when GINO SEVERINI jumped outwards further hampering FISCAL FANTASY. Raced three wide without cover.

LUVALUVA (K Jennings) - Raced wide from near the 1000 metres. When questioned regarding performance rider advised that the mare had travelled into the race nicely entering the final straight but once placed under pressure had failed to respond to his riding. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

CAMINO ROCOSO (C Johnson) - Commenced to over-race near the 1600 metres, continuing to race fiercely through the middle stages establishing a sizeable lead.

ROCK ON WOOD (R Elliot) - Held up early in the straight having to shift ground back to the inside to obtain clear running.

BEAUDEN (L Innes) - Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

O Bosson (TRUE ENOUGH) - Issued with a warning for his whip use prior to the 100 metres.

Race 8	BCD GROUP SPRINT

The start of this race was officially put back 2 minutes at the request of Raceday Control.

T Harris (AVANTAGE) - T Harris advised Stewards by telephone at 1.47 pm that he was unable to make the contracted weight for AVANTAGE, the connections then opting to replace T Harris with D Johnson. T Harris admitted a resultant breach of Rule 330(3)(c) being suspended by the Judicial Committee from the conclusion of racing today, Saturday 8 February, until the conclusion of racing on Friday 21 February (8 national riding days), and in addition imposed a fine of \$1,000.

AVANTAGE (D Johnson) - Began awkwardly.

MORE WONDER (R Elliot) - Slow away.

ENZO'S LAD (M Coleman) - Slow away. Raced three wide without cover.

ENDLESS DRAMA (L Innes) - When questioned regarding performance rider was unable to offer any excuse with trainer Mr T Pike indicating that he would be discussing the horse's racing future with the owners. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

VOLPE VELOCE (M McNab) - Trainer G Richardson reported that the mare had pulled up a little sore behind with Stewards to follow-up its progress in coming days.

Race 9

FAIRVIEW MOTORS 1600

CLEVERCONVERSATION (C Johnson) - Jumped away awkwardly then being further hampered by BARRY'S BOYO which jumped inwards with CLEVERCONVERSATION losing ground. Had a tendency to over-race in the middle stages on a modest tempo.

PRINCESS CATHARINA (L Satherley) - Slow away.

VLADIVOSTOK (R Elliot) - Crowded leaving the barriers. Raced ungenerously in the middle stages on a modest tempo being inclined to get its head up. Had difficulty obtaining clear running early in the straight and was inclined to lay in. Lay out under pressure making contact with STARRING ROLE near the 50 metres.

STARRING ROLE (S Collett) - Restrained in the early stages to obtain cover after jumping from the outside barrier. Contacted near the 50 metres.

STAR TSAR (J Riddell) - Raced three wide without cover from the 1000 metres.

O Bosson (ANGARIA) - Issued with a warning after permitting his mount to shift inwards hampering the weakening BARRY'S BOYO near the 300 metres with BARRY'S BOYO making contact with HUNTER VILLAIN which had shifted outwards slightly at this point.

HUNTER VILLAIN (D Johnson) - Contacted near the 300 metres.

BARRY'S BOYO (R Oliver) - Hampered when weakening near the 300 metres.

ANGARIA and **JAMES BARRIE** came together just short of the finish with the connections of JAMES BARRIE viewing Stewards film footage before electing not to proceed with a protest.
