



Proposed Amendments to the Rules – For Consultation

Transitional Provisions

It is proposed that the following Rules be added:

TRANSITIONAL PROVISIONS

Transition of Trainers

- 120 A person who, on the day before the Transition Date, held a Class A or Class B Trainer's Licence, shall, from the Transition Date, be deemed to hold a Public Trainer Licence.
- 121 A person who, on the day before the Transition Date, held a Class C Trainer's Licence, shall from the Transition Date, be deemed to hold an Owner Trainer Licence.
- 122 Despite anything else in these Rules, a person who, on the day before the Transition Date, held a Class A, B or C Trainer's Licence, may, so long as they hold a Public Trainer Licence or Owner Trainer Licence:
- (a) ride thoroughbred horses at racecourses, training facilities, and Trainer's Premises;
 - (b) **[other matters to receive feedback on]**
- 123 A person who, by virtue of Rule 121, holds an Owner Trainer Licence, may, despite anything else in these Rules, continue to train any horse which that person was training in accordance with the Rules on the day before the Transition Date until 31 July 2022.

Transition of Riders

- 124 A person who, on the day before the Transition Date, held a Class A Rider's licence, shall, from the Transition Date, be deemed to hold a Jockey's Licence.
- 125 A person who, on the day before the Transition Date, held a Class B Rider's licence, shall, from the Transition Date, be deemed to hold an Apprentice Jockey's Licence.
- 126 A person who, on the day before the Transition Date, held a Class C Rider's licence, shall, from the Transition Date, be deemed to hold a Probationer's Licence.
- 127 A person who, on the day before the Transition Date, held a Class D Rider's licence, shall, from the Transition Date, be deemed to hold a Jumps Licence.
- 128 A person who, on the day before the Transition Date, held a Class E Rider's licence, shall, from the Transition Date, be deemed to hold an Amateur Licence.

Transition of Miscellaneous Licences

- 129 A person who, on the day before the Transition Date, held a Class A Miscellaneous Licence which was subject to a condition prohibiting that person from riding horses, shall, from the Transition Date, be deemed to hold a Stablehand Licence.
- 130 A person who, on the day before the Transition Date, held a Class A Miscellaneous Licence which was not subject to a condition prohibiting that person from riding horses, shall, from the Transition Date, be deemed to hold a Stablehand Licence and a Fast Work Licence.
- 131 A person who, on the day before the Transition Date, held a Class B Miscellaneous Licence shall, from the Transition Date, be deemed to hold a Fast Work Licence.
- 132 A person who, on the day before the Transition Date, held a Class C Miscellaneous Licence, shall, from the Transition Date, be deemed to hold a Rider's Agent Licence.

Other Transition Matters

- 133 For the avoidance of doubt, a Licence which a person is deemed to hold under any of Rules 120 to 132:
- (a) may be cancelled, suspended, withdrawn, or have conditions imposed on it in accordance with Rule 332; and
 - (b) expires on 31 July 2023 and may only be renewed if the Licenceholder has met the applicable requirements of the Continuing Professional Development Policy by issued by NZTR under Rule 302.
