Race 6 – ROYAL AMETHYST – racing manners warning – to trial to Stewards satisfaction. Race 6 – POLLY PHILLER – barrier manners warning.

RACE COMMENTS:

Race 1	BIOFEED / NIGHTCAPS CONTRACTING 0 -1 WIN (1200M)	
AMIGO began awkwardly losing ground. RICHARD TRIMBOLE raced keenly over the early		
stages skying its head on several occasions. Passing the 350m WHATA DELIGHT shifted		
ground wider on the track when looking for clear racing room.		
On returning to the birdcage LAUDERCREEK was observed to have blood in its mouth.		
Stewards ordered a post-race veterinary examination which revealed the gelding to have		
suffered a minor laceration to the mouth with no treatment required.		
Race 2	BOOTH AG / SPAIN & SMITH SHEARING & TAILING CONTRACTORS MAIDEN

MOONDANZ ALEXANDER was slow to begin.		
Race 3	STANDALONE TRADING / COUNTRY JEWEL MAIDEN (1000M)	
The start position of this event was moved back approximately 50m when safety concerns		
were raised by riders regarding the 1000m start position being so close to the first bend.		
AZREAL, THE LOGIC and CEEJAY CYCLONE were all slow to begin. MOTORBOAT MIKE and		
ROBERT BROOK made firm contact on jumping away. Passing the 75m STONEY CREEK		

shifted in under pressure making heavy contact with CEEJAY CYCLONE which was improving into a run to the outside of APPARENT resulting in STONEY CREEK becoming unbalanced and momentarily shifting out hampering ELEGANT INSIGHTS.

When questioned regarding the performance of THE LOGIC rider A Tempelman advised the Stewards the mare had been outpaced early despite her urgings but had made up steady ground then scrambled for a stride passing the 300m however had run on well over the concluding stages.

Race 4 SLEEMAN'S ELECTRICAL / H.E.N BATT & SON MAIDEN (1400M)

CALLA QUEEN dipped on jumping away. VITAL LAYDEE was slow to begin. THE GORDONIAN was buffeted between runners as the start was made losing ground.

Rider L Callaway (CALLA QUEEN) defended a charge under Rule 638(1)(d) in that he allowed his mount to shift ground inwards shortly after the start resulting in VITAL LAYDEE (S Muniandy) clipping a heel, blundering and dislodging its rider. After hearing evidence and submissions the Judicial Committee found the charge proved and suspended Mr Callaway's licence to ride from the conclusion of racing on the 17th October until the conclusion of racing on the 30th October (2 weeks). Neither horse nor rider was injured in this incident.

Race 5 TRAVELLERS REST TAVERN / MICHAEL O'MEARA R75 (1400M)

SOCIETY SYD raced wide from the 900m. POSTMASTER BAY had difficulty obtaining clear running in the home straight until inside the final 100m.

Race 6 LINTON CONTRACTING / BULLEID ENGINEERING 0 – 1 WIN (1400M)

ROYAL AMETHYST began very awkwardly and bounded for several strides losing a considerable amount of ground. The connections were advised the mare was on a warning for its racing manners and must trial to the satisfaction of the Stewards prior to racing next. The connections of ROYAL AMETHYST advised the Stewards they would not be persevering with the mare as a racing proposition.

The connections of POLLY PHILLER were advised the mare was on a warning for its barrier manners after POLLY PHILLER which became very fractious at the start area then proved very difficult to load.

When spoken to regarding the performance of favoured runner THE BISHOP apprentice rider A Tempelman advised the Stewards the gelding had run on fairly over the concluding stages and would take benefit from today's outing.

Race 7 SBS BANK / ADVANCED AGRICULTURE R75 (2000M)

The start of this event was delayed approximately 3 minutes and 2 seconds due to SLIPSTREAM being very fractious at the start area before breaking free momentarily. SLIPSTREAM was then checked by the clubs veterinarian and declared fit to start. Stewards gave permission for the tongue tie to be removed from SLIPSTREAM today due to its very fractious nature.

SWEET ABOUT ME blundered as the start was made. THE GUTTERSNIPE began awkwardly with the rider losing the use of her outside stirrup iron momentarily. HARRY HILL was slow to begin. SLIPSTREAM raced wide into the first bend. KRAKATOA raced keenly through the early to middle stages. HEZA KOOL KAT raced keenly as the pace eased passing the 1400m. KRAKATOA was held up from the 500m only gaining clear racing room passing the 150m. NOTABLE was held up in the early part of the final straight. HEZA KOOL KAT was unable to obtain clear racing room in the final straight until inside the final 150m.
