GENERAL:

Canterbury Jockey Club, 17 September 2011.

Andrew Carston, the trainer's representative for John Sargent, advised that **THE GODDAUGHTER** which raced below expectation at Riccarton on the 17th of September underwent veterinary examinations which revealed no abnormalities. He said that **THE GODDAUGHTER** has pulled up well and her preparation will continue.

John Carroll, the trainer's representative for Neil Coulbeck, advised that **PINSGOLD** which raced below expectation at Riccarton on the 17th of September had pulled up well subsequent to the race and it was the stable's intention to continue with the preparation of **PINSGOLD**.

Sara Satherley, the trainer's representative for Lisa Latta, advised that **MASONS RUN** had pulled up well since its last run at Riccarton on the 17th of September and felt the gelding may have got too far back on that occasion.

RACE COMMENTS:

Race 1 PORT FM 3YO SPRINT 1200m

OLE GINGE which at its most recent run at Waimate on the 3rd of July 2011 slipped badly during the race, was inspected by the on-course veterinarian and declared fit to run. **KERRYTOWN LADY** was slow to begin. **DARCI COUP** raced keenly in the early stages. **OLE GINGE** which was inclined to hang in throughout, hung in noticeably under pressure inside the final 400m placing the rider at a disadvantage. **OLE GINGE** and **PATRICE** came together and bumped just prior to the finish. When questioned regarding the performance of **PATRICE** rider R Hannam explained in his opinion the colt pinched behind in the home straight.

Race 2 D'CASH RATING 90 DASH 1200m

The saddle slipped on **DIAMOND JULES** shortly after the start placing the rider at a disadvantage. **DIAMOND JULES**, **THISTLE** and **OUR GENES** were slow to begin. **TURF FIRE** and **ONE NITE STAND** both raced keenly during the early stages. A post race veterinary examination of **BOLINGER** which raced wide throughout failed to reveal any obvious abnormalities. Rider D Walsh advised **BOLINGER** failed to respond to full pressure inside the final 600m and was disappointing thereafter. The trainer's representative R Thistoll undertook to advise the Stewards if anything becomes apparent with the gelding which may have led to the disappointing performance today. When questioned regarding the improved performance of **ANAHERA** co-trainer D Champion advised the gelding is better suited racing around turning tracks.

Race 3 CENTRAL SI RACING OWNERS & TRAINERS R65 SPRINT 1200m

D Walsh replaced A McKay (indisposed) as the rider of **THRILLER. MIGHTY GALAXY** which was slow to begin shifted out and made contact with **ZENAGEN** and lost ground. **TALLYHO TUI** was steadied when crowded by **ZENAGEN** (C Winberg) who shifted in when not clear. C Winberg was cautioned and advised to show greater care when shifting ground in future. Rider J Bullard advised **ROAMING** did not respond to his full pressure inside the final 300m and was disappointing in its efforts in the run to the finish. When questioned regarding the performance of **TALLYHO TUI** rider L Allpress explained the mare did not feel comfortable on the firm track conditions. Trainer S Woodsford stated he agreed with the thoughts of rider L Allpress regarding the firm track. A post race veterinary examination of **TALLYHO TUI** failed to reveal any abnormalities.

Race 4 EQUINE VETERINARY SERVICES MAIDEN 1200 1200m

Trainer D Hutton was issued with a Minor Infringement Notice and fined \$50 for being late to notify a rider for **OUTFOXED**. Trainer P Gerard was issued with a Minor Infringement Notice and fined \$50 for being late to notify a rider for **SUPERTED** in Race 4 and **HANDSOME KASH** in Race 6. **MANY CHANCES, BRAEHILL** and **OUTFOXED** were slow to begin. **REPLACE** was held up for clear running in the early stages of the home straight. Trainer D Hutton advised it was their intention to retire **OUTFOXED** from their racing stable.

Race 5 LION BEVERAGES RATING 80 HANDICAP 1700m

Passing the 300m **WARRANT** had to be briefly steadied when awkwardly placed close to the heels of **MASONS RUN**. Passing the 200m **KIWI HUSSLER** had to be eased around the heels of **MASONS RUN** to continue to improve. **WARRANT** shifted out and away from **KIWI HUSSLER** and bumped **KEEPITINTHEFAMILY**.

Race 6 HAPPY ANNIVERSARY SOUTH CANTERBURY R65 1700 1700m

I LIE KIT and SHIQUAN were crowded on jumping between SANTOS and HANDSOME KASH which shifted out. LASTOFTHEDRAGONS, ALL ABOARD and UNCLE JIM were slow to begin. REGAL PRINCESS got its head up and raced fiercely for some distance in the early stages. Rounding the first turn SIR LUIS hung out forcing HEMINGWAY wider on the track. HEMINGWAY was inclined to race keenly for some distance in the middle stages. SHIQUAN was held up for clear running round the home turn and the early stages of the

home straight. **HEMINGWAY, MANTOVA** and **SANTOS** were held up and unable to obtain clear running at any stage in the home straight.

Race 7 SPEIGHT'S MAIDEN STAYERS 1800m

Trainer M Daly was issued with a Minor Infringement Notice and fined \$50 for being late to notify a rider for CARITA. AQUALINE and LLAVE DE ORO were slow to begin. CARITA was crowded on jumping between ELANOR DITHILIEN and MR REGNER which shifted out. CARITA got its head up and raced fiercely for some distance in the early stages and had to be steadied when awkwardly placed close to the heels of ELANOR DITHILIEN near the 1300m. Approaching the 300m LADY KINLOCH which was weakening became awkwardly placed close to the inside of TWO SUMMERS, shifted in and crowded RIVER BEAR which had attempted a narrow run between SUSPICIOUS KIWI which was weakening and LADY KINLOCH. SUSPICIOUS KIWI had to be steadied in the incident. MR REGNER which was following was held up and had to be shifted wider on the track to continue to improve. Trainer J Bridgman will be spoken to regarding the performance of LADY KINLOCH. A veterinary examination of SUSPICIOUS KIWI revealed that the gelding had suffered from arterial fibrillation and the connections were advised an ECG and veterinary clearance will be required prior to racing again.

Race 8 SUNNYBRAE EQUINE SERVICES RATING 70 STAYERS 2000m

TROPICAL STORM was slow to begin. **CEE GEE JAY, KINGS RAG** and **CAPE FEAR** were all inclined to race keenly in the early and middle stages. **CAPE FEAR** when racing ungenerously down the back straight lost ground. Jockey L McKay in the presence of her employer M Pitman was found guilty of a charge of careless riding under the provisions of Rule 638(1)(d) in that near the 800m she allowed **SUN VALLEY** to improve up onto the heels of **KINGS RAG** then shifted in crowding the running of **CEE GEE JAY** which had to be checked. The JCA suspended L McKay's licence for two riding days after the completion of racing at Otago on the 2nd of October up to and including the 8th of October 2011.
