GENERAL:

Trainer W Hillis reported to the Stewards that STERLING PRINCE, which finished last at Egmont on Saturday 8th October 2011, had undergone a subsequent veterinary examination which revealed the gelding to have heart strain. Mr Hillis advised that STERLING PRINCE would be treated over the next two weeks for the condition. Mr Hillis also undertook to provide a veterinary clearance prior to STERLING PRINCE next racing.

| Race 1 | JJJ STAYERS MAIDEN |
| <p>HEMPSTED began awkwardly and got back. HEMPSTED was held up for clear running until near the 200m. HEMPSTED had to be straightened when shifting out under pressure near the 100m. NOW WERETALKIN' shifted out under pressure passing the 200m and bumped with PRINCE LINCOLN which in turn shifted out bumping with TANQUERAY. Over the final stages TANQUERAY shifted in abruptly and hampered PRINCE LINCOLN and NOW WERETALKIN'. When questioned regarding the tactics adopted on PRINCE LINCOLN which commenced a sharp forward movement near the 1000m, rider D Bradley advised that the gelding, which he described as being one-paced, was unsuited to the slow tempo when racing back in the field and in his opinion was better suited when allowed to stride forward wider on the track and race in unrestricted room.</p> | |

| Race 2 | TIM SYMES SPRINT |
| PRECISION KING jumped inwards abruptly at the start hampering TIC TOC ARNIE which in turn shifted in making contact with BACK N BLUE, which after beginning awkwardly, got back. AUBURN BEAUTY began awkwardly and then raced wide for the remainder. When questioned into the run of PHEASANT rider R Myers said that the gelding had been out-paced throughout. | |
| Race 3 | PATRICK CAMPBELL RACING STABLES MAIDEN |
| <p>PORTRUSH was tightened at the start and got back SCAREAWAY, and OAK PARK were slow to begin. ARIZONA JAZZ jumped out abruptly at the start and bumped with SOLD which in turn shifted out making contact with HACKENSACK which became unbalanced for several strides. Approaching the 900m LAWRENCE OF ARABIA was tightened and steadied when inside RED COUGAR which was dictated inwards by ARIZONA JAZZ (L Whelan) which shifted ground when not clear. Apprentice L Whelan admitted a charge under Rule 638 (1) (d) and after deliberations the Judicial Committee suspended Miss Whelan's licence to ride in races from the conclusion of racing on Sunday 16th of October up to and including racing on Saturday 22nd October 2011. ARIZONA JAZZ hung out rounding the first turn and passing the 600m became unbalanced and lost its footing behind. ARIZONA JAZZ continued to hang out and had to be continually straightened and near the finish, shifted out abruptly tightening OAK PARK. Near the 200m OAK PARK was briefly hampered by HACKENSACK which shifted out under pressure</p> <p>Apprentice M Hudson the rider of PORTRUSH which was unplaced, admitted a breach of Rule 647 (1) in that she failed to weigh in as required. After consideration the Judicial Committee imposed a fine of \$200.00</p> | |
| Race 4 | SUE THOMPSON / MICK BROWN MAIDEN |
| Trainer A Scott (POETIC LUSTRE) was fined \$50.00 under Rule 537a for the late declaration of his rider. DANNY RICARDO was crowded shortly after leaving the barriers and lost ground. LOLLY improved onto the heels of the runner ahead passing the 600m and had to be steadied. STORMY SEAS began awkwardly then raced greenly and shortly after was bumped when in restricted room. YOUTOOFASST raced greenly in the early stages and shifted out into the line of SANDSPEX which had to steady. SANDSPEX made the first turn awkwardly when racing greenly. PEARLE LUSTRE returned to the enclosure with blood present in a nostril. A post-race veterinary examination revealed PEARLE LUSTRE to have sustained minor lacerations to the nasal region. | |
| Race 5 | JOHN BARY RACING STABLES 3YO |
| BEEJAY BELLE had to steady off heels when awkwardly placed near the 800m. SHANGHAI BUND lay out rounding the turn dictating BEEJAY BELLE over extra ground. BRACKENWOOD raced wide without cover throughout. | |
| Race 6 | GUY LOWRY / GRANT CULLEN RACING STABLES 1400 |
| Trainer F Auret (METTERNICH) was fined \$50.00 under Rule 537a for the late declaration of his rider. MINI PEARL reared at the start and struck its barrier becoming unbalanced and dislodging rider K Myers who was uninjured. Trainer N Auret was advised that a warning had been placed on MINI PEARL with respect to its barrier manners. Stewards opened and adjourned an investigation into an incident at the finish where QUEEN OF POP and DOUBLE O SEVEN were tightened and checked. An investigation was also opened and adjourned into the reasons why Apprentice R Hurdle left the course without permission. When questioned into the run of MARGARETS OWN, which finished well back, rider D Bradley had | |

| Race 7 | CORRINA MCDOUGAL MAIDEN 1400 |
| <p>The tongue tie on GOLDBEEL was not able to be applied due to the filly becoming fractious prior to entering the enclosure. MISS RAQUEL began awkwardly and shifted out on to GOLDBEEL which became unbalanced for a short distance. Passing the 400m CHERYL MOANA MARIE was checked when in restricted room between GOLDBEEL and EYE FOR FASHON. After questioning riders it was established that GOLDBEEL had shifted out and away from CHEIMON when being steadied, resulting in CHERYL MOANA MAREE being dictated out on to the heels of EYE FOR FASHON. M Coleman stated that his mount had contributed to the incident by racing greenly, however D Bradley the rider of CHEIMON was reminded of his obligations when shifting ground. CHEIMON was held up in the early part of the home straight and passing the 350m had to be checked off heels when angling inward for a run. A'GUIN ACE and GOLDBEEL bumped near the finish. CHERYL MOANA MARIE raced wide without cover throughout.</p> | |
| Race 8 | JAMES BRIDGE MAIDEN |
| <p>GOK was slow away. CRUZIN raced keenly in the early stages and shifted out abruptly passing the 1000m to avoid heels. THE INNKEEPER raced wide throughout. BOULDER BAY gave ground quickly prior to entering the home straight. A subsequent veterinary examination of BOULDER BAY revealed no abnormalities. MR RIMFIRE lost the off-hind plate during the running.</p> | |
| Race 9 | PAUL NELSON RACING STABLES MILE |
| <p>MY GUY which proved fractious in the barrier, slipped behind on jumping and was slow to begin. V Johnston the rider of JUST CALL ME BLUE was advised to exercise care after allowing her mount to shift in shortly after the start which resulted in crowding to RAISEYOURGLASS. PERFECT TRIP over-raced in the early stages and made the first turn awkwardly. SOPHRONIA was held up near the 300m so was angled out to improve.</p> | |
| Race 10: | HOMESPUN RACING KIRSTY LAWRENCE 1600 |
| <p>VOLKARA began awkwardly and got back. OUR MILLY SMITH was held up passing 200m and bumped with STYLISH BELT when attempting to improve. ISHIDANZIN was held up in the early part of the home straight and had to be angled inwards to improve. VOLKARA raced in restricted room in the early part of the home straight.</p> | |
