GENERAL:

Gate staff reported that after testing the stalls on arriving at the 1200m starting point prior to the start of Race 3, gate 2 was found to have a malfunction after being tested. After stewards had consultation with starting officials and course management, it was decided to start the remaining events from outside barrier 2.

RACE COMMENTS:

Race 1	KOLFINNA CLASSIC

TARANTELLA jumped out at the start hampering NEGOTIATE which lost ground. PLANET ROCK raced keenly throughout. M Coleman reported that PLANET ROCK was never comfortable in the Heavy 11 going. PREPARED was held up for a short distance early in the home straight prior to being angled outward to improve. S COLLETT the rider of KAHNGOFASTA which finished a distant last, reported the filly did not handle the track at any stage.

Race 2	WELL DONE MUFHASA IN MELBOURNE MAIDEN

PERO began awkwardly and lost ground. PAPER MONEY and CHEIMON were slow to begin. PERO was inclined to lay in throughout the final straight and near the 100 metres came together with CHEIMON. DESERT SABOTEUR lay out under pressure over the final stages. Apprentice M Hudson the rider of DESERT SABOTEUR was questioned into her ride particularly over the early and middle stages after she allowed the gelding to dispute the lead with SHARE THE BLAME where in the Stewards opinion, it would have been more beneficial to the geldings chances to take a trail when able to do so, rather than dispute a solid pace. Miss Hudson was shown footage of her ride in the presence of the riding

master and advised that she is expected to demonstrate an improvement in her judgement when placed in similar circumstances.	
Race 3	WELLESLEY BOUTIQUE HOTEL STAKES - Listed
KILLA QUESTION jumped out at the start bumping SILVER CITY. PADDY OWEN was slow to begin. GRACE O'MALLEY began awkwardly and blundered shortly after leaving the barriers however recovered quickly. SOUTHERN LORD shifted out on jumping away taking SELENO out over extra ground. KILLA QUESTION was inclined to over-race in the early stages. SELENO raced greenly in the run down the final straight and was unable to be ridden to full advantage. J PARKES (REAIS), R Jones (KILLA QUESTION) and H Tinsley (PADDY OWEN) all reported that their mounts were never comfortable in the Heavy 11 footing.	
Race 4	VISION ENHANCEMENT NZ LTD PREMIER
REUBEN THORN underwent a veterinary inspection at the barriers and was declared fit to race after being kicked prior to the start. BELLA CAROLINA bounded at the start and shifted out making contact with CALEY MARIE which lost ground. PLATINUM ZANA was slow to begin. JAKADE was inclined to lay out over the final 300 metres. Approaching the 200 metres, KLOSE raced in restricted room between REUBEN THORN and CALEY MARIE. When questioned regarding the run of REUBEN THORN R Hannam said that the gelding was never comfortable in the prevailing track conditions.	
Race 5	RICH HILL STUD THOMPSON HANDICAP – Group III
<p>INTRANSIGENT stood flat-footed when the gates were released and lost several lengths. Connections were advised that a warning had been placed on the gelding's barrier manners.</p> <p>Shortly after the start NO EXCUSE MAGGIE shifted out crowding GUESSING which had to be steadied.</p> <p>Passing the 800m SUPERTURF (M Tanaka) clipped the heel of KAAP KRUIS and blundered dislodging rider M Tanaka who was uninjured. After questioning riders concerned and viewing the footage of the incident, it was established that immediately prior to the incident SUPERTURF, when being hard ridden and struggling to maintain its position, had become awkwardly placed tight to the inside of LADY KIPLING and to the outside of KAAP KRUIS which was dictated outwards marginally by JUSTANEXCUSE which was attempting to improve its position. Steward's inquiries determined that no one rider was culpable. The riders of HURRICANE MICKEY; OURFOREIGNMINISTER and LADY KIPLING all reported that their mounts had failed to handle the prevailing track conditions.</p>	
Race 6	GO THE KIWIS IN THE COX PLATE PREMIER
D Bradley reported that AUTHENTIC DESIRE did not handle the Heavy 11 track conditions. He further added that the 2200 metres of today's race may be a little further than the mare can manage at this stage.	
Race 7	STELLA ARTOIS PREMIER
<p>STILETTO LADY was a late scratching at on veterinary advice at 9.43am. Connections were advised that a veterinary certificate must be produced before the mare next races.</p> <p>DENIS was crowded on jumping away and got back. HULA SISTER commenced to over-race passing the 2000 metres and then pulled hard for some distance. I'M NOT TICKLISH compounded over the final stages. Rider M Coleman said the gelding was unsuited to the going.</p>	
Race 8	NZ BLOODSTOCK WELLINGTON GUINEAS – Group II
WHOSHE was slow away but recovered quickly. LOST WORLD pulled hard in the early and	

middle stages and near the 1000 metres, shifted in crowding JETSET MAN for several strides.

B Lammas reported that MASSIVE NIGHT never handled the Heavy 11 track at any stage.

Race 9	CHRISTMAS AT THE RACES AT TRENTHEM PREMIER

ANOTHERCHANCETAKEN was a late scratching on veterinary advice at 2.55pm after being injured en route. Connections were advised that a veterinary clearance is required before the gelding next races.

PRIMED AND READY was inclined to hang out throughout the final straight.

V JOHNSTON was charged under Rule 638 (3) (c) with striking PRIMED AND READY forward of the shoulder on three occasions shortly after entering the home straight. After hearing all relevant evidence and submissions the JCA found the charge proven and imposed a fine of \$200.
