RACE COMMENTS:

Race 1 WOODVILLE-WAIRARAPA HORSEFLOATS SPRINT

LOLLIESANDLIQOURICE suffered minor abrasions to the near hind hock after arriving at the start and underwent a veterinary examination which cleared the mare to start.

LOLLIESANDLIQOURICE was crowded shortly after leaving the barriers. NAH I'M GOOD was buffeted for several strides near the 1100 metres in restricted room. NAH I'M GOOD made the final bend awkwardly. GUSTO was held up in the early part of the straight and near the 200 metres when attempting a run to inside of SLIPPERY MISTAKE was hampered for several strides when that runner ducked in sharply. COUPE DE VILLE was obliged to race wide throughout.

When questioned regarding the run of GLOBAL PARTNER rider D Bradley stated that the gelding had travelled comfortably during the running however when pressured approaching the turn had failed to respond and finished the race off disappointingly. Stewards ordered a veterinary examination of GLOBAL PARTNER which revealed no abnormalities.

Race 2 MANAWATU RACING OWNERS AND TRAINERS ASSOCIATION STAYERS

MEGA D'INDE jumped out abruptly at the start tightening, VALLEY OF PENTIRE and SAFE BREAKER both of which lost ground. GLADSTONE began awkwardly. MEGA D'INDE raced

keenly into the first turn, hung out and ran wide passing the 1600 losing considerable ground. Trainer C Barber was advised that MEGA D'INDE must trial to the satisfaction of Stewards before next racing. POROTENE CASH gave ground quickly passing the 700 metres and was not persevered with over the final stages. When questioned regarding the performance of POROTENE CASH, K Smith said the mare was not comfortable in the track conditions. A post-race veterinary examination of POROTENE CASH revealed no abnormalities but the veterinary surgeon reported the mare had lost the offside rear hind plate during the running which may have affected its performance.

Race 3 WOODVILLE TRAINERS ASSOCIATION DASH

Part—trainer M Dixon admitted a breach of Rule 537a and was fined \$50 for failing to declare the riders of MR FIRE CAT (R3) and DEPUTY, FIRSTWEDANCE and MISTER DEEJAY all R5 by the required time.

MR FIRE CAT underwent a veterinary examination upon arrival at the course after suffering minor abrasions when being unloaded from the float.

MR FIRECAT bounded at the start and lost ground. UNBELIEVEABELLE was slow to begin. RING OF DESTINY was obliged to race wide without cover throughout. When questioned on the run of RING OF DESTINY rider H Tinsley stated that notwithstanding being obliged to race wide, the gelding was nevertheless disappointing.

Race 4 MANAWATU SOUND SERVICE 3 YEAR OLD

M Oulaghan admitted a breach of Rule 537a and was fined \$50.00 for failing to declare the rider of REASONS UNKNOWN by the required time. HOT LIPS struck the barrier on jumping and lost ground. LA VIE ONZE raced keenly in the early and middle stages. IRISH FLING was held up for a short distance rounding the turn. When questioned on the performance of ERIS, V Johnston could offer no excuses. A post-race veterinary examination of ERIS revealed no abnormalities.

Race 5 TARARUA CLUB METRIC MILE

FABULOUS PRINCESS underwent a veterinary examination at the barriers and was cleared to race after being kicked when arriving at the start. FABULOUS PRINCESS was slow to begin. Passing the 250 metres TURN ON D'LIGHT when being ridden out, shifted in crowding DOUBLE O SEVEN inwards onto COURT IN THE PARK. Apprentice J Shackleton (TURN ON D'LIGHT) was advised to exercise greater care when riding her mounts with vigour. Passing the 100 metres FABULOUS PRINCESS shifted in marginally dictating RUMOUR HAS IT NOW inward into the line of MINI PEARL which had to steady. DOUBLE O SEVEN was denied clear running passing the 100 and had to steady. RUMOUR HAS IT NOW was obliged to race wide without cover throughout.

When questioned regarding the performance of REBEL'S RANSOM B Lammas reported that the gelding was not suited to the prevailing track conditions.

Race 6 STEPHEN MARSH RACING STABLES METRIC MILE

LUCKY LOLA and PATCHES were slow away.

Race 7 TOTALLY VETS SPRINT

JACK'S POINT was slow to begin.

Race 8 DANNEVIRKE DAIRY SUPPLIES DASH

PRINCIPAL SKINNER and ADVENTADOR were tightened at the start between QUALITY ROYAL and FREEBIRD which both shifted ground. MARKET MOVER over-raced in the early and middle stages. APHELION commenced to race keenly passing the 1000 metres and had

to be steadied for some distance. Approaching the first turn, I AM LEO when over-racing got its head up and made the turn awkwardly. I AM LEO continued to over-race for some distance. I AM LEO was held up rounding the turn and only obtained clear running inside the final 100 metres.

When questioned regarding the performance of ALL IN CLOVER rider L Allpress could offer no excuses other than that in her opinion the mare would benefit from today's run.
