GENERAL:

A request for a ruling was filed with the Judicial Committee relating to Race 9 today in that the horse MY SPIRITED STAR was ineligible to start under the provisions of Rule 631(7). After hearing all relevant submissions the Judicial Committee ordered that MY SPIRITED STAR be declared a scratching at 11.50am. Trainer S Cameron subsequently admitted a breach of Rule 802(1)(a) in that by failing to withdraw or scratch MY SPIRITED STAR he had failed to comply with a restriction imposed by the Stipendiary Stewards that the gelding must trial to the satisfaction of a Stipendiary Steward prior to racing again following MY SPIRITED STAR racing on the 1st day of the meeting being Friday 4 November 2011 with the Judicial Committee imposing a fine of \$750.

RACE COMMENTS:

DEE DEE SMASH lay out under pressure in the final straight.

DEE DEE SMASH had to be steadied passing the 150m when AB O'REILLY (M Hills) shifted out. M Hills was issued with a warning.

Race 2 FIRSTLIGHT FROZEN SPRINT

SHARP DECISION lost the off front plate during the running.

When questioned regarding the performance of STORMPATROL rider S Collett advised that in her opinion the gelding would be better suited by some easing of the ground.

A post-race veterinary examination of ARCHETTO which raced poorly did not reveal any significant abnormalities other than the mare possible being slightly lame in the off foreleg. Rider R Hutchings was of the opinion that ARCHETTO had failed to back up after racing on Friday.

LUCKY MAJESTY began awkwardly losing ground.

LUCKY MAJESTY commenced to over-race passing the 1200m on a moderate pace and improved forward quickly to sit outside the leader.

SPLIT ENDZ brushed ICESKATES when improving into a tight run near the 200m.

ICESKATES lost the off front plate during the running.

Race 4 TURIHAUA STATION 1400

LAMBO MAN began awkwardly hampering RICCIOLI which was forced onto LAWRENCE OF ARABIA.

HANDSOME DANIEL shifted outwards abruptly when jumping away from the outside barrier stall.

COUNTRY DANROAD was inclined to over-race in the early and middle stages.

LAMBO MAN which was giving ground had to be steadied when momentarily crowded by LARGE AS LIFE which lay in near the 500m.

COUNTRY DANROAD was inclined to shift ground when racing greenly in the final straight with GOOD THINKER shifting away from that runner passing the 200m inconveniencing GEARIGURU.

Race 5 FARMER AIR FILLIES & MARES

SANDRASCAL began awkwardly losing ground.

ITSA FLUKE raced three wide without cover throughout.

M Hills (AR REALTA) advised that his mount had been inclined to race greenly and may not have been suited by today's very firm track.

Race 6 CRAIGS INVESTMENT PARTNERS 2000

NODDUM and DONNA TRUMP were both slow away.

DONNA TRUMP had to be steadied off heels when racing keenly passing the 1600m and continued to over-race through the middle stages.

NODDUM over-raced in the middle stages.

Race 7 CORSON GRAIN 1600

SLAH shifted in making contact with LA MANZANILLA leaving the barriers.

Race 8 CLASSIC HITS STAYERS

CALGACUS shifted out when jumping away inconveniencing GEE OH.

When being steadied near the 1400m KINGS RAG dropped back on to SAVABEEL STAR which was hampered.

Passing the 900m SAVABEEL STAR shifted in when being steadied crowding GEE OH.

SEA KING (J Parkes) which was racing greenly shifted in abruptly crowding CALGACUS near the 200m. J Parkes was advised to exercise care. SEA KING continued to race greenly for the remainder of the race.

Race 9 LOGANS 1600

MEDIEVAL was slow away.

HILTON JAMES shifted outwards abruptly when leaving the barriers hampering HANAMICHI which lost ground.

KAYCENT over-raced in the early to middle stages.

SLYTHERIN'S raced three wide without cover throughout and hung outwards around the bend.

GUNS AT FIVE was held up rounding the final turn from the 400m until near the 250m.

KAYCENT which was inclined to race greenly in the final straight shifted out under pressure hampering SLYTHERIN'S near the 250m.

C Grylls (PLEASE PLEASE ME) advised that in his opinion the filly had failed to back up from racing on Friday and had felt a little short in its action.

Race 10: GARY BATES LTD 1600

S Collett (SWEET RITA) advised that after trailing on a fast pace the mare had been unable to quicken in the final straight and may not have backed up after racing on Friday.
