GENERAL:

Auckland Racing Club. Saturday 22 October 2011 Race 10, Westbury Stud Mile Trainer Linda Laing reported that Midday Hero had been galloped on during the running receiving lacerations.
Racing Te Aroha. Wednesday 19 October 2011 Race 10, Donaghys Mycotak 1300 Stewards concluded an inquiry regarding the riding of Hallavagal by R Hutchings over the concluding stages. R Hutchings was advised by stewards in the presence of his employer that he must ride his mounts fully to the line when circumstances permit.

RACE COMMENTS:

Race 1	CAMBRIDGE TRAINING CENTRE 1600
Malandrino (M Coleman) was slow away. Partner In Time (C Grylls) and Rio Grand (J Collett) both began awkwardly causing crowding to Captain Cruising (J Waddell). Brave Ali (C Lammas) began awkwardly. Brave Ali , Zonza (L Innes) and Malandrino all over-raced in the middle stages. Lozada (S Spratt) raced wide without cover.	

Tempelten (M Cameron) was obliged to race wide, making the bend awkwardly passing the 600 metres.

Ribbony Rose (A Collett) was inclined to hang out throughout.

Inside the final 100 metres **Savvy Dancer** (O Bosson) was tightened when attempting a narrow run to the inside of **Lozada** which shifted in, hampered as a result was **Vivere** (H Kasim). O Bosson and S Spratt were both advised to exercise care in similar circumstances.

Rio Grand was unable to find clear running over the concluding stages.

Race 2	SEAFOOD BAZAAR 1600

This race was delayed by 2 minutes at the request of TAB control.

Sarsarun (A Collett) began awkwardly shifting in making contact with **Headsup** (J Collett).

Go Danny (N Harris) was slow away.

Doctor Fremantle (J Waddell) began awkwardly losing ground.

Sarsarun over-raced in the early and middle stages, and passing the 800 metres made the bend awkwardly. **Sarsarun** then raced wide for the remainder of the race.

Veronica Franco (O Bosson) was obliged to race wide without cover.

Approaching the 800 metres **Cissy Bowen** (S Spratt) skied its head when being restrained off the heels of **Appleton's Lass** (R Norvall) which shifted in. As a result **Tintern** (M Coleman), **Hot In Black** (H Kasim), **Castle Heights** (C Ormsby), **Headsup** and **Doctor Fremantle** were all inconvenienced.

Passing the 400 metres **Tintern** shifted out and made contact with **Lady Chaparral** (M Hills) in an attempt to obtain clear running.

Sarsarun was held up over the final 50 metres.

When questioned regarding the performance of **Go Danny**, N Harris felt that **Go Danny** had raced disappointingly and could offer no tangible excuses. **Go Danny** underwent a post-race veterinary examination which failed to find any obvious abnormalities.

Pan Dulce (C Parish) knuckled on jumping away.

Gold Message (M Cameron) began awkwardly shifting out making contact with **Repenting** (N Harris).

Gold Cape (S Spratt) began awkwardly shifting in making contact with **Kashin Girl** (A Collett).

Feedback (J Waddell) shifted out on jumping away making firm contact with **Medici** (M Coleman).

Commanding Oak (T Thornton) raced ungenerously in the early stages.

Yourein (V Colgan) over-raced through the middle stages.

Gold Cape raced wide without cover throughout.

Hot Pursuit (J Collett) was held up for clear running until approaching the 300 metres.

Ilka (L Innes) shifted out passing the 200 metres to obtain clear running, inconveniencing **Repenting** and **Kashin Girl**.

Approaching the 50 metres **Hot Pursuit** shifted out making contact with **Pan Dulce** which became briefly unbalanced. L Innes was advised to exercise care in similar circumstances.

Mr R Priscott the trainer of **Hot Pursuit** was fined \$100 under Rule 616(2) for presenting **Hot Pursuit** to race in gear which was not notified (blinkers).

Race 4	VISION FOREST LAKE 2000

He's Under The Gun (C Ormsby) began awkwardly.

Asgoodasitgets (J Collett) began awkwardly and then shortly after had to steady off the heels of **Ballynova** (C Lammas).

Agamemnon (M Vance) was crowded leaving the barriers.

Asgoodasitgets was held up passing the 350 metres.

Little Alfie Brown (L Satherley) raced wide without cover throughout.

When questioned regarding the performance of **Ballynova** C Lammas explained that

Ballynova was feeling the effects of recent racing. Trainer G Old advised Stewards that Ballynova would now be spelled.	
Race 5	JAMES & ANNIE SARTEN MEMORIAL STAKES
<p>Artistic (M Coleman) began awkwardly making firm contact with Antonio Lombardo (S Spratt).</p> <p>Trendy (R Norvall) began awkwardly shifting in causing crowding to Caipirinha (M Hills), Mindy (J Waddell) and Chicharita (C Ormsby). Contributing to this incident was outward movement from Holy Moly (V Colgan).</p> <p>Caipirinha raced ungenerously becoming awkwardly placed on heels near the 800 metres and again near the 600 metres.</p>	
Race 6	SAPPHIRE PROPERTIES 1400
<p>Miss Meena (M Hills) began awkwardly and then was further crowded between Zephyros (C Grylls) and Cap Ferrat (S Spratt) when both those runners shifted ground.</p> <p>Close Encounter (J Collett) stumbled badly on jumping away.</p> <p>Bouvier (M Sweeney) shifted out abruptly on jumping away.</p> <p>When the start was made Mauriemac (H Kasim) shifted out crowding Beautiful Brother (S Collett) and Kitty Russell (A Collett) which shifted out and inconvenienced Groover (B R Jones) and Bouvier (M Sweeney).</p> <p>When leaving the barrier the saddle on Bouvier shifted placing rider M Sweeney at a disadvantage throughout the race.</p> <p>Zephyros raced ungenerously in the early stages skying its head.</p> <p>Approaching the 400 metres Kitty Russell appeared to go off stride and shifted out.</p> <p>Close Encounter was held up for clear running until near the 200 metres.</p> <p>When questioned regarding the performance of Kitty Russell apprentice jockey A Collett could offer no reason for the mare's performance. Trainer J Graham notified the Stewards that the mare was showing signs of being in season.</p> <p>When questioned regarding the performance of Sir Amron D Johnson explained that the gelding would prefer more rain-affected footing.</p>	
Race 7	NEW ZEALAND BLOODSTOCK INSURANCE 1400
<p>Lady Chapel (L Satherley) began awkwardly shifting in and inconvenienced Rio Tonto (D Johnson), then when being corrected shifted out abruptly and hampered Athenry (C Grylls) which shifted out making contact with the hind quarters of Day Walker (M Sweeney) which became unbalanced.</p> <p>Passing the 1000 metres Royal Bliss (M Hills) lay in and away from Society Ruler (A Collett) dictating Alpena Rosea (V Colgan) in crowding Rio Tonto which was racing ungenerously.</p> <p>Rio Tonto continued to race ungenerously and went back on to Day Walker which was hampered.</p> <p>Passing the 400 metres Pui Pui (L Robertson) had to shift inwards off heels to obtain clear running.</p> <p>Passing the 200 metres the saddle on Day Walker started to shift with rider M Sweeney being placed at a distinct disadvantage. The saddle and accompanying equipment were checked by Stewards and were found to be in good condition.</p> <p>C Grylls was questioned regarding the performance of Athenry explaining that the colt had raced greenly and in his opinion would benefit from the experience.</p>	
Race 8	MICHAEL WALLACE BLOODSTOCK 1400
<p>This race was delayed by one minute at the request of TAB Control.</p> <p>Shandream (L Innes) began awkwardly shifting in making contact with Justagem (V Colgan) who then shifted in and dictated Enyaar (M Wenn) and Blinding (N Harris) into the line of Santeria (C Ormsby) which was hampered losing ground. Also contributing was outward movement from Leonucasam (D Johnson).</p> <p>100 metres after the start Justagem (V Colgan) shifted in making contact with Leonucasam</p>	

which briefly became unbalanced.

Justine's Pride (R Hutchings) returned to the enclosure showing signs of soreness, suffering from a tendon injury. Trainer G Rogerson explained that it was his intention now to retire the mare.

Mydiamond Bracelet (H Kasim) raced wide without cover.

Shandream (L Innes) was held up early in the final straight.

Trainer G Richardson was questioned regarding the performance of **Mydiamond Bracelet** and explained that the mare's last two race appearances had been in weight for age company and today's assignment had been a considerable drop in class, further explaining he was confident the mare would perform well in a fresh state.

Race 9	EBONY GROSVUE 1200
---------------	---------------------------

Pubs (M Sweeney) and **Randall** (D Johnson) both began awkwardly shifting out.

Slashing (H Kasim), **Villifye** (V Colgan) and **Kinarne** (C Ormsby) all began awkwardly.

My My Maree (N Harris) was slow to begin.

Khisdar (O Bosson) shifted in leaving the barriers inconveniencing **Final Fling** (L Innes).

The Stewards opened and adjourned an inquiry into the riding tactics adopted by rider N Harris on **My My Maree** interviewing Jockey N Harris and Trainer M Murdoch. **My My Maree** underwent a veterinary examination which failed to find any obvious abnormalities.

The Stewards interviewed O Bosson with regards to the performance of **Khisdar**. O Bosson explained that the gelding had raced greenly and would benefit from the experience.

Race 10:	NEW ZEALAND BLOODSTOCK INSURANCE 1600

Plan Ex (H Kasim) was slow to begin.

Zabisco (M Coleman) shifted out and crowded **Pacific Rose** (L Satherley) leaving the barrier.

Wisecrack (O Bosson) shifted out abruptly leaving the barrier crowding **Pinzee** (P Turner) and **Mackadoo** (J Waddell) who made contact with the hind quarters of **Chapel Bay** (A Collett) unbalancing that runner.

Estrato (S Spratt) over-raced when being restrained and shifted back hampering **Pinzee** (P Turner) near the 1400 metres. **Estrato** continued to over-race through the middle stages shifting out near the 1000 metres and raced wide without cover for the remainder of the race.

Passing the 800 metres **Wisecrack** (O Bosson) made the bend awkwardly, shifting out and hampering **Lovingthelime** (L Innes) which lost ground.

Passing the 400m **Pinzee** clipped a heel and blundered

Postmans Daughter (D Johnson) shifted out near the 100 metres making contact with **Zabisco** who became briefly unbalanced.

Mr D Greene, the trainer of the second placed horse **Zabisco** (M Coleman), lodged a protest against the first placed horse **Postmans Daughter** (D Johnson) for alleged interference near the 100 metres. After considering the evidence the Judicial Control Authority upheld the protest with placings now being 1st **Zabisco**, 2nd **Postmans Daughter**, 3rd **Mangaroa Flyer**, 4th **Sadist**.

Race 11:	THE READY TO RUN SALE 1600

Keenly (M Hills) shifted in on jumping and hampered **Tigris** (N Harris).

Last Picasso (S Spratt), **Atlantis** (M Vance) and **Beyond All Doubt** (V Colgan) were all slow to begin.

Pooka's Sister (M Sweeney) shifted out on jumping and made contact with **Is Da Chief** (T Thornton).

Gottino (M Cameron), **Beyond All Doubt**, **He Kin Talk** (R Norvall) and **Last Picasso** all over-raced in the middle stages.

M Cameron admitted a breach of careless riding in that he permitted **Gottino** to shift out near the 400 metres when not clear of **Iceskates** (J Collett) causing that runner to check. The Judicial Committee suspended M Camerons licence to ride in races, 27 to 30 October,

inclusive.

V Colgan was questioned with regards to the performance of **Beyond All Doubt** explaining that the gelding had only travelled fairly during the running and when placed under pressure near the 500 metres had failed to respond, adding that **Beyond All Doubt** had faltered near the 300 metres and was not persevered with from this stage of the race. A post race veterinary examination failed to find any obvious abnormalities. Trainer R James was asked to report the geldings progress in days subsequent.
