### **RACE COMMENTS:**

Race 1	RACE IMAGES 1150

**Itsa Fluke** (L Satherley) began awkwardly shifting out crowding **Meoww** (D Hain) and **Prickley Princess** (R Norvall) which lost ground.

**Daichi Dancer** (G Cooksley) shifted out on jumping away crowding **Showmethemoney** (M Vance).

Passing the 800 metres **Max Gold** (R Hutchings) made the bend awkwardly running wide and remained wide until near the 400 metres. Trainer K Hawtin was advised that a warning would be placed against the gelding.

Rounding the final turn **Pursue** (S Spratt) had to steady when racing in restricted room to the inside of **Showmethemoney** who shifted away from **Itsa Fluke** which was dictated in by **Max Gold** which had been racing ungenerously.

Passing the 500 metres **Filoli** (B R Jones) went off stride.

Altiyan (L Innes) was briefly held up entering the final straight.

Near the 200 metres **Showmethemoney** made contact with **Max Gold** when shifting out to obtain clear racing room.

# Race 2 EL HERMANO @ CHEVAL STUD 1400

**Red Dragon** (M Wenn) began awkwardly shifting out causing crowding to **Piazza San Pietro** (C Grylls) and **Mr Rimfire** (M Coleman). Also hampered in this incident was **Boninsky** (P Holmes) which lost ground.

**Royal Bliss** (A Collett) shifted out on jumping away.

Ellatain (R Hutchings) raced wide without cover throughout.

**Bouvier** (S Spratt) shifted out passing the 400 metres to obtain clear running and in doing so forced **Latin Rule** (L Satherley) **Vite Fille** (M Sweeney) over extra ground.

Capricious (D Johnson) was held up passing the 400 metres.

**Boninsky** had to steady and shift in to avoid heels passing the 300 metres.

**It Has To Be You** (L Innes) lay in when placed under pressure in the final straight and after being steadied to avoid heels near the 200 metres was not persevered with for the remainder of the race.

**Piazza San Pietro** had to steady off the heels of the weakening **Ellatain** approaching the 200 metres.

When questioned regarding the performance of **Mr Rimfire** M Coleman explained that the gelding had not been entirely comfortable with the tight nature of the track. **Mr Rimfire** underwent a post-race veterinary examination which failed to find any obvious abnormalities.

## Race 3 STEWART ALEXANDER GOLF CLUB 1580

**Stingray** (L Satherley) shifted in on jumping away making contact with **Storm In** (C Ormsby) which lost ground.

**Peace Keeper** (V Colgan) began awkwardly shifting in and crowding **Hoxo** (C Grylls) which lost ground.

**Lukey Dook** (C Lammas) began awkwardly shifting in and crowding **Fonzie** (P Turner). Contributing was outward movement from **Piratess** (S Spratt).

Passing the 1200 metres **Day Walker** (M Sweeney) shifted out making contact with **La Pinnicle** (L Innes) who then became awkwardly placed on the heels of **Piratess**. **La Pinnicle** then made the bend awkwardly.

Passing the 250 metres **Roamin** (H Kasim) shifted away from **Storm In** making contact with the hind quarters of **Peace Keeper** unbalancing that runner. **Peace Keeper** was not persevered with thereafter with jockey V Colgan reporting that **Peace Keeper** had not felt comfortable in the existing track conditions.

Approaching the 150 metres **Day Walker** shifted in simultaneously as **Stingray** was struck with the whip shifting out and becoming awkwardly placed on that runner's heels. **Stingray** then had to shift outside the heels of **Day Walker** to obtain clear running. M Sweeney was advised to exercise care in similar circumstances.

When questioned regarding the performance of **Hoxo** jockey C Grylls could offer no tangible reason for the disappointing performance. **Hoxo** underwent a post-race veterinary examination which failed to find any obvious abnormalities.

When questioned regarding the performance of **Recording** jockey B R Jones explained that **Recording** had not been entirely comfortable due to the tight turning nature of the track, but once becoming balanced in the straight had made ground well.

**Day Walker** lost the off hind plate during the running.

# Race 4 BAIN LIQUIDS DISPOSALS 1580

Just Gordon (D Johnson) began awkwardly making contact with Asworthy (C Ormsby).

Lady Carolyn (A Forbes) began awkwardly making contact with Contest (R Hutchings).

**Blue Ranger** (D Lui) and **Dickens** (L Satherley) were crowded on jumping away between **Re Deel** (P Turner) and **Despereaux** (A Collett).

Superninsky (D Hain) began awkwardly shifting in and hampered Old Trafford (M Hills).

100 metres after the start **Contest** skied its head when being steadied off the heels of **Blue Ranger**.

**Despereaux** was held up passing the 400 metres.

**Lady Carolyn** was held up until approaching the 200 metres, and again over the concluding stages.

**Dickens** had some difficulty finding clear racing room from the 400 metres.

Passing the 150 metres **Blue Ranger** and **Re Deel** were placed in restricted room to the inside of **Mr Toogood** (M Sweeney) which shifted in.

**Changingtheguard** (M Coleman) and **Just Gordon** (D Johnson) both underwent post-race veterinary examinations which failed to find any obvious abnormalities.

### Race 5 TE AWAMUTU CLUB 2000

Leaving the barrier **Safe Access** (D Johnson) shifted away from **Mr Clooney** which began awkwardly shifting out abruptly, crowding **Komplete Control** (M Wenn), **Final Offer** (R Hutchings), **Keepa Lady** and **Raisafuasho** with all those runners being badly hampered losing ground. Contributing was inward movement from **Swap For Kash** (P Turner).

**Keepa Lady** raced ungenerously leaving the straight on the first occasion running wide.

**Raisafuasho** had to steady when becoming awkwardly placed on heels near the 300 metres.

**Stonewashed** (T Thornton) shifted out under pressure approaching the 200 metres and inconvenienced **Keepa Lady** which was steadied.

**Raisafuasho** shifted out near the 100 metres to obtain clear running inconveniencing **Varnish** (M Sweeney).

**Xpress** (M Coleman) which became tailed off passing the 600 metres and was not persevered with. **Xpress** underwent a post-race veterinary examination which found the mare to have an irregular heart beat and was coughing. Trainer M Baker was advised that a veterinary certificate of fitness including clear ECG and endoscopic examinations would be required prior to the mare racing next.

When questioned regarding the performance of **Large Risk** S Spratt explained that the gelding had not been comfortable on the tight turning nature of the track and had not responded after being placed under pressure passing the 400 metres. **Large Risk** underwent a post-race veterinary examination which failed to find any obvious abnormalities.

## Race 6 GYDE WANSBONE CHARTERED ACCOUNTANTS

**Three Wishes** (M Wenn) became fractious in the barriers and reared up. **Three Wishes** was then passed fit to race by the veterinarian. **Three Wishes** beginning awkwardly losing ground.

Viva Roma (L Innes) began awkwardly losing ground and then stumbled shortly after.

Attackum (C Ormsby) was very slow away.

Colorado (A Collett) and Elle Tresor (S Spratt) raced wide.

**Upsala** (M Vance) became awkwardly placed on heels passing the 400 metres.

Viva Roma had difficulty obtaining clear running until near the 150 metres.

**Upsala** was accidentally struck over the head with the whip of A Collett (**Colorado**) inside the final 100 metres.

M Wenn reported that the saddle had shifted on **Three Wishes** when she had left the barrier. Trainer D Guy advised the Stewards that she will try ear covers on **Three Wishes** in an attempt to improve the mare's barrier manners.

### Race 7 WILKSBROOKE MOTORS LTD 1400

**Parnell Prince** (A Forbes) was presented to the plate inspection missing a lead bag and a towel. Apprentice jockey A Forbes was re weighed and **Parnell Prince** re-saddled with the correct gear in place. Trainer S Ritchie was fined \$500 by the Judicial Committee after admitting a breach of being neglectful when saddling.

State Of Elation (D Johnson) and Sanz (R Hutchings) both began awkwardly losing ground.

Skysoblue (T Thornton) and Happyto Keepa (M Vance) came together leaving the barrier.

**Sanz** over-raced in the early and middle stages shifting out off heels passing the 1000 metres, racing wide thereafter.

Passing the 800 metres **Springloaded** (A Collett) made the bend awkwardly. **Springloaded** then raced ungenerously for a distance.

Passing the 250 metres **Rosie Rules** (C Parish) shifted out under pressure becoming awkwardly placed on the heels of **Happyto Keepa**.

**Amadeo** (P Holmes) had difficulty obtaining clear running inside the final 100 metres.

R Hutchings (Sanz)was spoken to regarding his use of the whip in the final straight.

Just Fred (B R Jones) raced greenly over the concluding stages when weakening.

**Orinda** (S Spratt) shifted out under pressure in the final straight inconveniencing **State Of Elation** (D Johnson). S Spratt was advised to exercise care in similar circumstances.

The connections of the second placed horse **State Of Elation** (D Johnson) lodged an objection against the first placed horse **Orinda** (S Spratt) alleging interference inside the final 200 metres. After considering submissions the Judicial Committee dismissed the protest.

### Race 8 THE FLYING FIRKIN 1400

Bartote (L Innes) was slow to begin.

Leaving the barriers **Scottish Mist** (L Satherley) shifted in abruptly crowding **Leadership** (S Shirahama) and **Trapiche** (V Colgan) which lost ground.

Approaching the 1300 metres **Pinot Express** (B R Jones) shifted in placing **Vincent Street** (A Collett) and **Govind** (M Sweeney) in restricted room for a short distance. **Vincent Street** and **Pinot Express** then made contact several times. B R Jones was advised to exercise care in similar circumstances.

**Credit Crunch** (R Hutchings) had to steady when awkwardly placed on heels passing the 1200 metres.

**Leadership** shifted in near the 500 metres to obtain clear running inconveniencing **Bartote**. **Credit Crunch** had difficulty obtaining clear running over the final 400 metres and became awkwardly placed on the heels of **Rochallen** (C Grylls) over the concluding stages.

**Leadership** had difficulty obtaining clear running over the final 400 metres and had to steady when in racing in restricted room over the concluding stages.

**Vincent Street** underwent a post-race veterinary examination which failed to find any obvious abnormalities.
