### GENERAL:

Trainer S McKee reported FIELD OF DREAMS had been examined by a Veterinarian on return to the stable and found to have suffered a minor tendon injury to the off fore leg. S McKee was asked to report the further progress of FIELD OF DREAMS.

### RACE COMMENTS:

<b>Race 1</b>	<b>Polwarth Designs 1800</b>
AL ASKAN (H Kasim) raced wide without cover in the early stages.	
<b>Race 2</b>	<b>Dennis Thompson International</b>
FINAL FLING was a late scratching at 11.40am after being advised the mare had been injured in transit to the races. Stable representative A Peard was informed that a veterinary certificate of fitness would be required for FINAL FLING before being permitted to race again. TIPPERARY LASS (L Innes) was slow away. SVENGALI (D Johnson) over-raced in the middle stages shifting out off heels approaching the 800 metres, SVENGALI then raced wide without cover. WEST END (D Nolan) lay in when placed under pressure in the final straight.	

S Clotworthy was spoken to regarding the form reversal of the winner SIR RAM. S Clotworthy explained that after racing disappointingly he removed the blinkers and added a tongue tie believing the gelding may have got its tongue over the bit at its previous race, further adding that SIR RAM had worked well leading in to today's race.

**Race 3      webb ross Maiden**

EVER SO SHARP (A Collett) was slow away.  
TARIMA (S Spratt) shifted out abruptly jumping away hampering STORM IN (J Collett) which shifted out forcing GOGINGA (M Wenn) across the heels of SPARNON (P Holmes) which had to steady, losing ground. Also inconvenienced in this incident was EVER SO SHARP.  
Leaving the straight on the first occasion TARIMA skied its head when being steadied.  
HEJALLE (L Robertson) raced wide without cover throughout.  
Passing the 200 metres COOL LADY (D Nolan) which was racing greenly shifted away from MOIVARO (P Taylor) crowding EVER SO SHARP which had to steady. EVER SO SHARP then had to be checked when further crowded by COOL LADY which was taken in by MOIVARO which in turn was taken in by SPARNON which was then inclined to shift in and away from TARIMA which was racing greenly. The Stewards were of the opinion that the incident was contributed to by several of these runners with the only action taken being to advise P Holmes that in future he would be expected to straighten his mount more quickly than he did on this occasion and accordingly he was issued with a warning.

**Race 4      City of Auckland Supporters Group 1200**

PINZAARA (L Innes) began awkwardly, shifting in and hampered LION ROCK HILL (G Cooksley) which lost ground.  
BEAUTIFUL BROTHER (S Collett) shifted away from KAREN MARIE (C Grylls) which had begun awkwardly, crowding TEAM PETE (L Robertson).  
SIGHLENT SPUR (M Hills) began awkwardly, losing ground.  
PINZAARA over-raced when being restrained in the early and middle stages. As a result INNOVATION (M Cameron) over-raced when being steadied.  
GEM LOVER (C Parish) and BEAUTIFUL BROTHER both raced wide without cover.  
Passing the 300 metres BEAUTIFUL BROTHER ducked in when struck with the whip making firm contact with QUIN BAY (S Spratt). BEAUTIFUL BROTHER continued to lay in under pressure.  
Passing the 200 metres LION ROCK HILL shifted out inconveniencing GEM LOVER and TEAM PETE.  
Near the 150 metres QUIN BAY shifted in under pressure and inconvenienced PINZAARA.

**Race 5      Stud Breeders Maiden**

SCARED STIFF (M Vance) began awkwardly, losing ground.  
STRAIGHT AWAY (S Collett) was slow to begin and failed to hit out throughout. STRAIGHT AWAY underwent a veterinary examination which failed to find any obvious abnormality. When questioned S Collett advised Stewards that STRAIGHT AWAY had felt short in its action and in her opinion was feeling the firm nature of the footing. Trainer B Wells was advised that STRAIGHT AWAY would be required to barrier trial to the satisfaction of Stewards before being permitted to race again.  
Shortly after leaving the barriers ABEAUTY (H Kasim) and MYTSHARP (C Parish) stumbled.  
HE'S ROCK'N'ROLL (P Holmes) over-raced in the early and middle stages.  
TIMO'SHANTER (M Wenn) raced keenly and was then obliged to race wide throughout.  
BASIC INSTINCT (P Taylor) raced wide without cover throughout.  
MYTSHARP made the bend awkwardly passing the 400 metres, running wide.  
ABEAUTY and MYTSHARP came together near the 50 metres when both runners shifted

ground.

When questioned regarding the performance of RIPPLE ROCK S Spratt explained that in her opinion the mare may prefer some easing of the ground but could otherwise offer no excuse.

<b>Race 6</b>	<b>Mark Cromie Holden Maiden</b>

Trainer K Crampton was fined \$50 by the JCA for presenting TIME PAYS to race without notified gear (side winkers).

ENDORSEMENT (G Cooksley) was slow away.

NOTTOOBAD (P Taylor) and LADY GAGA (S Spratt) came together on jumping away.

PAPAWAI HINE (D Nolan) was crowded shortly after leaving the barriers.

MAURIEMAC (H Kasim) faltered badly 100 metres after the start, being pulled up.

MAURIEMAC was attended to by the Veterinarian but due to an equipment problem, further equipment had to be sourced before the gelding could be euthanased after fracturing an off hind leg. The Club's Secretary and the Veterinarian were both spoken to regarding issues involved in the delay.

PAPAWAI HINE over-raced in the middle stages.

RIO GRAND (A Collett) had to be steadied passing the 800 metres when awkwardly placed on the heels of SOMETIME LATER (M Cameron).

Near the 300 metres ENDORSEMENT had to steady when becoming awkwardly placed on the heels of KINGQUEEN (M Hills).

<b>Race 7</b>	<b>Adams Trimmer Nauman Northland Cup</b>

SO REGAL (C Grylls) and STREET SIREN (C Ormsby) were both slow away.

PENUMBRA (J Collett) shifted out and hampered LETSPLAYTAG (H Kasim) when leaving the barriers.

PRINCESS KYOTO (M Hills) knuckled when leaving the barriers.

MIRROR MIRROR (S Spratt) began awkwardly, shifting out making firm contact with DELAMAN (L Innes).

LADY POMPALLIER (P Taylor) over-raced when leaving the straight on the first occasion making the bend awkwardly shifting out across the heels of LARGE RISK (M Cameron).

PRINCESS KYOTO was obliged to race wide in the early stages before being allowed to stride forward to sit outside the leader passing the 900 metres.

Near the 500 metres LARGE RISK lay in becoming awkwardly placed on the heels of STRAIGHT FURROW (S Collett).

FEEDBACK (J Jago) made the final turn awkwardly when under pressure, shifting out approaching the 300 metres and inconvenienced PRINCESS KYOTO which shifted out forcing DELAMAN out on to LARGE RISK which became briefly unbalanced. STRAIGHT FURROW then lay in crowding PRINCESS KYOTO on to FEEDBACK which had to steady. Contributing was ALDERNEY (D Nolan) which shifted out when placed under pressure. DELAMAN shifted out abruptly over the concluding stages and PENUMBRA shifted in slightly causing crowding to CAPISTRANO ANGEL just short of the finish. Inconvenienced as a result was LARGE RISK. L Innes was advised to exercise care. Following the race the connections of the third placed horse CAPISTRANO ANGEL viewed the Stewards' video footage in view of a protest but elected not to proceed.

When questioned regarding the performance of LARGE RISK M Cameron stated that the horse had not been entirely comfortable on the turning track.

<b>Race 8</b>	<b>Farmlands 1200</b>

FLASH HAPI (M Vance) began awkwardly.

NEARLY STOLEN (A Collett) began awkwardly and shifted out making contact with STAR

BOUND (S Spratt) when leaving the barriers.  
 THE BEEKEEPER (J Collett) was crowded shortly after jumping away.  
 FLASH HAPI had to be steadied when disappointed for a run to the inside of DENVER which lay in near the 300 metres. The connections of FLASH HAPI placed fourth by the Judge lodged a protest against the first placed horse DENVER. After hearing all relevant evidence the Judicial Committee dismissed the protest. A charge of careless riding was issued against Rider D Johnson with the matter being adjourned.  
 STAR BOUND was held up approaching the 200 metres and did not obtain clear running until inside the final 100 metres.

<b>Race 9</b>	<b>Homestead/Taipa/Kamo/Mangonui Hotels</b>

SOPHIA (P Taylor) which had been fractious in the barriers began awkwardly, losing ground.  
 SCATTERCAT (S Spratt) was inclined to over-race when leading in the early to middle stages.  
 BLACK OUT (C Parish) raced ungenerously having to be steadied off heels passing the 800 metres.  
 ADHIRA (A Collett) became awkwardly placed on the heels of OFFANGONE (C Grylls) passing the 600 metres.  
 A protest was lodged by the connections of the third placed horse SIMPLY IRRESISTIBLE (M Cameron) alleging interference by the second placed horse APATCHEE TUTE (M Vance) early in the final straight. After hearing all relevant evidence the Judicial Committee upheld the protest with the final placings now reading – No. 5. PURPOSE 1<sup>st</sup>, No. 9 SIMPLY IRRESISTIBLE 2<sup>nd</sup>, APATCHEE TUTE 3<sup>rd</sup>. A charge of careless riding was lodged against Apprentice M Vance with the matter being adjourned.  
 Passing the 100 metres when attempting a tight run SIMPLY IRRESISTIBLE was buffeted between SCATTERCAT and OFFANGONE when OFFANGONE shifted in slightly.  
 SCATTERCAT was hampered as a result.
