RACE COMMENTS:

Race 1 AQUA SALON & SPA/ST HELEN'S PERENDALES MAIDEN (1400M)

PERSONAL JUSTICE was slow to begin. IGLESIA BAY and ZOE BROOK made contact shortly after the start when both runners shifted ground. Passing the 1300m QUOIN which was racing greenly shifted out abruptly crowding NORAH, MANONTHEMOON, ZOE BROOK and CARBONISTA with those four runners all losing momentum. MANONTHEMOON was held up for several strides passing the 400m. Passing the 100m NORAH which was shifting outwards and MANONTHEMOON which was shifting inwards made contact momentarily.

Race 2 NIND ELECTRICAL/TRAVELLERS REST/JUSTICE PREVAILS/WINTON NIGHT 'N' DAY MAIDEN (1200M)

RIVER OF RICHES began awkwardly losing ground. MELVA JOY shifted out abruptly on jumping inconveniencing STAR ROYALE and VENTURA FOX with both those runners losing ground. DRUMHILL which was racing keenly had to be steadied off heels passing the 800m. STRIKE UP THE BAND (K Selvan) lay out severely over the concluding stages having to be straightened on more than one occasion. Passing the 75m DRUMHILL shifted out and away from STRIKE UP THE BAND. Rider K Selvan was spoken to advisedly regarding his whip

action.

When spoken to regarding the performance of IRISH LAD rider T Moseley advised the Stewards the horse had been out paced early and ran on fairly over the concluding stages. He further added he felt IRISH LAD would take benefit from today's outing.

Race 3 GEOFF JUKES/CHILTON SHEARING/HARCOURTS/CAIRNS FENCING MAIDEN (1200M)

Permission was granted for LA GEE to race without a back racing plate which had become loose and been removed by the farrier.

The start of this event was delayed approximately 5 minutes and 46 seconds firstly due to the Stewards having to recheck the brands and microchip on NO CRUISING, and then due to YOUNG BACHELOR proving difficult to load. The connections of YOUNG BACHELOR were advised the gelding was on a barrier manners warning.

MIKABELLA, YOUNG BACHELOR and NO CRUISING were all slow to begin. YOUNG BACHELOR was held up rounding the final bend. MISS SAN JOSE hung out rounding the home turn and could not be ridden to any advantage over the concluding stages with the connections advised the mare was on a racing manners warning. Trainer L Vaughan advised the Stewards that MISS SAN JOSE will no longer be persevered with as a racing proposition from her stable.

When spoken to regarding the performance of SEASONED GEM rider J Misbah advised the Stewards that although the gelding had felt fine during the running it raced disappointingly and he could offer no tangible excuses. Trainer E Winsloe was also spoken to and he advised that he had been happy with the first up run as it's only jump out was over 800m. He also advised he believed the gelding would benefit from today's race.

Race 4 RYAL BUSH TRANSPORT/TOP END TAKEAWAY/SOUTHSTOCK R65 (1200M)

CAPTAIN OATES shifted out at the start and made contact with DANZATIGER. THE CHOICE shifted out at the start and made contact with SPLIT DECISION. DANZATIGER was held up passing the 500m by the tiring CAPTAIN OATES only gaining clear racing room inside the final 300m. NOBLE REASON shifted in abruptly passing the 150m with rider K Williams advising Stewards she believed her mount had been struck by a gust of wind. GINTY'S CHOICE lay in over the concluding stages with the rider having to change whip hands.

When spoken to regarding the performance of GINTY'S CHOICE rider T Moseley advised the Stewards after having a good run the mare had raced disappointingly and could offer no tangible excuses. Trainer S Anderton advised the Stewards it was his intention to take blood tests from GINTY'S CHOICE and undertook to advise the Stewards of any developments over the coming days which may have influenced today's performance.

When spoken to regarding the performance of THE CHOICE rider A Tempelman advised the Stewards the mare had failed to handle todays prevailing track conditions. Stewards ordered a post trace veterinary examination of THE CHOICE which revealed no obvious abnormalities.

Race 5 BEN MCHUGH BUILDERS/CALDWELL BUILDING & ELECTRICAL R75 BENCHMARK (1200M)

KLASSICPINS began awkwardly losing ground. GOLDEN SPOT was very slow to begin. PETER RICHARD shifted out over the concluding stages and passing the 125m brushed with ON THE TAKE.

S Muniandy (WHATA DELIGHT) reported to the Stewards he accidentally dropped his whip passing the 130m.

Rider C Johnson and apprentice rider A Tempelman were both shown replays of the concluding stages of the race and reminded of their obligations to ensure they ride their mounts out fully to the finish.

Race 6 AB LIME/CLOVERTONE/HEN BATT & SON R65 (2000M) CITY ROY, GUITARZAN and ELITE STREET were all slow to begin. CHINA BO BO raced wide

without cover throughout. PHIL WENNECK had to be steadied passing the 600m when becoming awkwardly placed on the heels of MAXIE BOY. UNCLE JIM was held up rounding the home turn and only gained clear racing room inside the final 200m.

In the shadows of the post THE BISHOP shifted in and inconvenienced BUFFYS BOY.

ELITE STREET was led back to the birdcage by rider D Walsh who felt the mare to be favouring its off fore leg. Stewards ordered a post-race veterinary examination of ELITE STREET which revealed a small cut to a previous hoof injury which appeared to be healing well and although tender to the touch the veterinary surgeon confirmed the small wound would continue to heal. He also further advised he believed a veterinary clearance would not be required.

Following the running of this event the track conditions were officially downgraded to Slow 8.

Race 7 PGG WRIGHTSON AON INSURANCE/CENTRAL SOUTHLAND FREIGHT MAIDEN (1600M)

OOR WULLIE and HULAHAN were both slow to begin. LAST VINTAGE raced keenly in the early stages and had to be steadied off heels passing the 1300m.

Passing the 175m DELA KAYLA had to shift inwards to find clear racing room and in doing so brushed with HULAHAN. When spoken to regarding the performance of LAST VINTAGE rider J Misbah advised the Stewards the mare had failed to handle todays prevailing slow track conditions.

Race 8 BAYSWATER FEEDS WINTON CUP (1600M)

PETER PORTER raced wide throughout. DANZ A ROOK was held up rounding the final bend only gaining clear running inside the final 250m. In the shadows of the post PETTY LANE was crowded for room between PETER PORTER which shifted in and KING PRAWN which shifted out marginally.

When spoken to regarding the performance of OUR BEE JAY rider K Williams advised the Stewards that in her opinion that when placed under pressure rounding the final bend the combination of top weight and today's slow track conditions had a bearing on the geldings poor performance. Trainer L Vaughan advised the Stewards it was her intention to take blood tests from the gelding and undertook to advise the Stewards of any developments over the coming days which may have influenced today's performance.

Race 9 COUPLAND'S BAKERIES R75 (1600M)

D Walsh was the declared rider for IMA DUDE not D Walker as shown in some publications. PALIO was slow to begin. SCHMECKENBECHER lay in during the early part of the run home with the rider having to change whip hands. NOT MY RUBY lay in over the concluding stages and had to be straightened.

Race 10: | SBS BANK/SPEIGHT'S/CENTRAL SOUTHLAND LODGE R65 (1400M)

The start of this event was delayed approximately 5 minutes and 49 seconds due firstly to POLLY PHILLER being very fractious and uncontrollable in the start area with the saddle falling off. Subsequent attempts to resaddle POLLY PHILLER proved unsuccessful and the mare was eventually declared a late scratching at 5.37pm. The connections of POLLY PHILLER were advised the mare will have to trial to the satisfaction of the Stewards including going to the start area and loading into the gates before being allowed back to the races. Following this RUSHINELLA which was also fractious in the start area whilst being loaded into the gates escaped riderless and crashed through the running rail and was subsequently declared a late scratching on vet's advice at 5.40pm. Connections of RUSHINELLA were advised the mare must barrier trial to the satisfaction of the Stewards prior to returning to the races.

MINDREADER was very slow to begin. MONEYORTHEBOX who was laying out shifted out and made contact with I'M INQUISITIVE passing the 1100m. MONEYORTHEBOX had to steady when in tight racing quarters passing the 600m. AMIGO was inclined to lay in

passing the 100m having to be straightened.

A post-race veterinary examination of I'M VITAL which was not persevered with over the concluding stages and finished in a distant last placing revealed the gelding to be lame in the near hind leg with the connections advised a vet clearance would be required prior to returning to the races.
