After consideration the Committee found that while no dual engagement existed for FLEMINGTON one did exist for COATOFMANYCOLOURS and accordingly ordered a riding fee be paid to M Tanaka.

RACE COMMENTS:

Race 1 GARRY AND SUSAN BARLOW WEDDING ANNIVERSARY STAYERS

COLOMBIAN PRAISE ducked out abruptly shortly after the start making heavy contact with RICH PICKINGS resulting in M Tanaka being dislodged and RICH PICKINGS being severely hampered losing considerable ground. M Tanaka was uninjured. Trainer N Mortimer was advised that COLOMBIAN PRAISE must trial to the satisfaction of Stewards before next racing.

GYMDANDY was slow and then hung out rounding the first turn and raced wide throughout CALIFORNIA raced keenly in the early and middle stages and passing the winning post on the first occasion had to be steadied off the heels of D'TOP.

VRONSKII was obliged to make it's run, wide rounding the home turn.

Race 2 MCI & ASSOCIATES SPRINT

RIGHT ROYAL ROSE was crowded shortly after leaving the barriers when runners either side shifted ground and as a result settled back.

RIGHT ROYAL ROSE raced keenly for a short distance when being steadied passing the 1100.

SHINING PEARL was obliged to race wide without cover throughout.

MILO MISS (R Hannam) hung inwards in the run down the final straight and near the 300m shifted in and bumped RIGHT ROYAL ROSE. A short distance further, RIGHT ROYAL ROSE (K Smith) then commenced an outward movement in an attempt to improve and in doing so hampered MILO MISS (R Hannam). After questioning riders R Hannam confirmed that his mount contributed to the interference due to its tendency to hang, however, K Smith was advised to exercise care when in similar circumstances.

E Lloyd the rider of SOONGNILLANA was spoken to with regard to the use of her whip when out of contention.

Following the event THE LOOKER returned to the enclosure lame in the near foreleg. Following a vet inspection trainer J Bridgman was advised that a clearance is required before the gelding next races.

CARMARTHEN BAY returned to the enclosure displaying mild soreness in the off hind leg.

Race 3 CROWLEY FORGE MASTER FARRIERS LIMITED DASH

REUBEN THORN and SNAGGLEPUSS were slow away. VERA DE BOSSET was hampered at the start when crowded between REUBEN THORN and SNAGGLEPUSS which both shifted ground and as a result got back.

RIO NUGGET was inclined to over-race throughout.

MCLAREN was held up rounding the home turn and early part of the home straight before gaining clear running near the 200 metres.

RIO NUGGET was held up rounding the top bend until near the 100 when it was angled out in order to continue to improve.

VERA DE BOSSET was held up rounding the turn when awkwardly placed and was unable to obtain clear running throughout the final straight.

Race 4 BAMBRY'S WATER TREADMILL JUVENILE

TALK THE TORQUE was crowded shortly after leaving the barriers and lost ground.

VOLKSOI LADY bounded at the start.

HAZEL raced greenly in the early stages,

Shortly after the start WOLF KING when being steadied, shifted in and bumped PLATINUM MARSEILLE.

VOLKSOI LADY was inclined to lay out rounding the first turn and when being steadied dropped back onto TALK THE TORQUE which had to steady off heels. TALK THE TORQUE then commenced to over-race.

Race 5 MORRIS & BAILEY SPRINT

HEAD OF GOLD jumped outwards at the start simultaneously as MILANION shifted in resulting in FALCOURT and PHOENIX TYCOON being tightened.

CAPTAIN FRANCIS blundered on jumping away.

SIVOCCI was held up rounding the turn gaining clear running passing the 200.

BANDON dropped out over the concluding stages finishing last. Rider J Parkes advised Stewards the gelding pulled up in a normal post-race condition and he could offer no excuse for the poor run. Trainer S Dougan advised the gelding is finished as a racing proposition.

Race 6 GOLDEN BAY CEMENT STAYERS

VALDERAMA began awkwardly and got back.

MY O'REILLY jumped outwards at the start and bumped with HODDIGGIDY.

CALGACUS was slow away.

MONACHEE raced wide throughout.

Race 7 LINCOLN LODGE 3 & 4 Y O SPRINT

BETWEEN THE BEATS was buffeted for several strides shortly after leaving the barriers and lost ground as a result.

GOLDYSOX raced wide over the early stages.

OPEN AND SHUT was held up for a short distance rounding the turn before gaining clear running near the 250 metres.

Race 8 PRENTERS READY MIX CONCRETE WOODVILLE-PAHIATUA CUP

PRIMED AND READY was slow to begin.

SURREAL STORM was inclined to get its head up when being steadied passing the 1400.

SURREAL STORM then over-raced for some distance through the back straight.

GOLDSCHATZ raced wide without cover throughout.

M Hills the rider SLAH was reminded of his obligations to ride his mount out fully to the finish when circumstances permit.

Race 9 WOODVILLE WAIRARAPA HORSEFLOATS METRIC MILE

THE DEBATER was slow to begin.

GUNSMOKE raced four wide rounding the first turn so was allowed to stride forward to a share of the lead.

CASTLE QUEEN raced wide throughout.

BUBBSY'S CHOICE gave ground quickly passing the 600 and went back onto BOB VALDEZ which lost ground as a result. Jockey P Taylor said he was of the opinion that something was amiss with the gelding. A post-race veterinary examination of BUBBSY'S CHOICE revealed the gelding to be displaying a poor post recovery. Trainer J Scott was advised that a veterinary clearance is required prior to BUBBSY'S CHOICE next racing.

JAKOB GAMBINO had difficulty finding clear running in the final straight when racing in restricted room.
