Trainer P. Campbell advised the Stewards that STARGURU had undergone chiropractic treatment since its last start and in his opinion was now more fluent in its action. The hearing of a charge under Rule 638 (1) (d) filed against L Innes in relation to Race 3 was adjourned due to L Innes becoming unwell following Race 4 and having to leave the course.

RACE COMMENTS:

Race 1	RED BADGE SECURITY MAIDEN STAYERS
<p>The start of this race was initially delayed by the late arrival of the ambulance on course and again delayed after TINDALL reared and became cast on the back of its gate. TINDALL was declared a late scratching after sustaining abdominal bruising. ADIDAZLER in the adjacent stall became fractious as a consequence of TINDALL becoming cast and was also declared a late scratching after incurring a wound to its stifle.</p> <p>The connections of TINDALL were advised the gelding must trial to the satisfaction of the Stewards prior to racing again.</p> <p>The race was further delayed 3min at the request of the TAB and finally started 15min after the advertised time.</p>	

CROSS CREEK raced fiercely in the early stages and lost ground when being restrained. IL CAPO made the final turn awkwardly and ran wide. When questioned into the run of CHIPPY which failed to run on as expected, rider J Parkes could offer no excuse.	
Race 2	MANAWATU SOUND SERVICE STAYERS
The start of this race was deferred 8 minutes as a consequence of the delays in Race one. FLOWER OF FASHION underwent a veterinary examination at the barrier and was cleared to start after rearing and landing on its hind quarters. GOLDEN CROWNS and LUMINATION were slow to begin. GOLDEN CROWNS raced wide without cover throughout. Passing the 800m MARCIANO when awkwardly placed between ANNIHILATOR and GOLDEN CROWNS had to be steadied for several strides. Near the 50m FASTENET ROCKETTE faulted and was immediately restrained. A subsequent veterinary examination revealed damage to the near fore tendon. Trainer K Gray advised that FASTENET ROCKETTE is retired.	
Race 3	LIME COUNTRY THOROUGHBREDS 3YO
RUBY LADY and MONNIE were slow away. REALLY EXPLOSIVE was tightened at the start and got back, then made the first turn awkwardly. Passing the 800m TAAXMAN was checked when inside the heels of SANDRASCAL which was racing tight to the inside of SPLITSECOND (L Innes). L Innes denied a breach of Rule 638 (1) (d) in that he permitted his mount to shift in dictating SPLITSECOND inwards in to the line of TAAXMAN. The matter was adjourned to a date to be advised.	
Race 4	RUSH MUNRO MAIDEN 1600
LA VIENNE and MINNALEO came together and bumped at the start resulting in LA VIENNE shifting out and hampering APHELION, TE NAMU and BARTY BOY. Passing the 1300m CENTREOFATTENTION, when over racing, had to steady off the heels of THE KNIGHT and came back onto MINNALEO which lost ground. LA VIENNE was held up for several strides near the 400m. APHELION was held up for a short distance passing the 300m before being taken inwards to improve. When questioned regarding the run of EL DORADO rider L Allpress could offer no excuse. A post-race veterinary inspection of EL DORADO failed to reveal any abnormality. GROOVER raced wide without cover throughout. Following the event L. Innes, who was feeling unwell, was examined by medical personal and was stood down from his remaining engagements.	
Race 5	HB RACEHORSE OWNERS ASSOCIATION 1600
K. Myers replaced L Innes on SNIPPINS. REGAL RULER was inclined to lay in under pressure in the final straight. INFORMANT raced keenly in the lead throughout. When questioned into the run of INFORMANT rider B Lammis stated that while his intention was to lead, the gelding over-raced more than he anticipated after being challenged near the 1400m. When questioned regarding the run of TOPOSHFORU rider R Myers could offer no excuse. A post-race veterinary inspection TOPOSHFORU failed to reveal any abnormality.	
Race 6	TC'S FUN 4 KIDS / TC'S FRESH CANDY FLOSS SPRINT
B R. Jones replaced L Innes on CLAN O'CEIRIN. ROCKWEILER dislodged rider J Riddell on route to the barrier and returned to the stable enclosure where after a veterinary examination it was declared unfit to start. J Riddell was uninjured. WASABI began awkwardly and lost ground. MINICHIELO shifted in shortly after the start crowding WHO ARE YOU and CHAPELSTAD which lost ground. CHAPELSTAD then over-raced in the early stages and had to be steadied off heels passing the 1000m. D Nolan the rider of HACKENSACK admitted a breach of Rule 638 (1) (d) in that he allowed his mount to shift in near the end of the back straight dictating DASHING DOTTIE inwards onto	

FALZANO which in turn was taken in on to CLAN O'CEIRIN which was checked. After consideration the Judicial Committee suspended D Nolan's licence to ride in races from the conclusion of racing on Saturday 21st January up to and including racing on Sunday 29th January 2012. (5 days) Also affected in this incident were PEIT ROX, JILTED and WORKINGCLASS which all had to steady. CHAPELSTAD had to be steadied over the final metres when in restricted room.

Race 7	KARAKA 2012 30 JAN – 5 FEB 1400

MACADAMIA was a late scratching 2.21pm after sustaining a wound to the hoof region due to losing a plate when being transported to the meeting.

MISS LINCOLN became fractious in the barrier and dislodged its barrier blanket. When the barriers was released MISS LINCOLN was slow to begin. Connections were advised a warning had been placed on the mares barrier manners. GUSTO got its head up when being steadied passing the 1200m. GUSTO then raced fiercely for some distance. THE STING over-raced in the run through the back straight and had to be continually steadied. TEN BELLES raced keenly in the early stages. When questioned regarding the run of O'CEIRINS MAGIC rider B Lammas could offer no excuses with a post-race veterinary inspection failing to reveal any abnormality.

Race 8	McDONALDS HASTINGS MAIDEN 1400

R Hutchings replaced L Innes on SUNDAY'S NEWS due to no other rider being available. PAPARAZZI dipped and blundered on jumping away. CHEIMON and CORNELIUS O'CEIRIN were tightened at the start and got back. DIRTY HARRY and DEEP POCKETS raced fiercely in the early stages. CASUAL FLING hung inward throughout and passing the 300m shifted in crowding KILLARNEY LASS, GARDEZ LA FOI and DEEP POCKETS for some distance. SUNDAY'S NEWS had to shift ground passing the 200m in order to improve. MASIH CHIANTIK raced four wide without cover throughout. Rider D Bradley reported that CHEIMON had been unsuited to the Good 3 track.
