RACE COMMENTS:

Race 1	Lion Red Rating 75 1000
	<p>SCATTERCAT (C Grylls) began awkwardly, losing ground. HIGH PRIEST (M McNab) and FIELDOFDREAMS (S Spratt) came together jumping away. When pulling up MY MOJITO dislodged Rider A Collett and then ran into a fence. MY MOJITO underwent a veterinary examination which found the mare to have superficial abrasions to both hind legs. A Collett was attended to by the Paramedics and cleared fit to continue riding. When questioned into the performance of the favourite FIELDOFDREAMS Rider S Spratt stated that the horse had not raced since November and would benefit from the run but could offer no other reason for the gelding's performance. A post-race veterinary examination revealed no abnormalities.</p>

	<p>TRISTACAT (L Innes) knuckled when leaving the barriers. EVER SO SHARP (A Collett) was slow to begin. DREAMLINER (D Johnson) began awkwardly, shifting out making contact with OKCORAL (C Lammass). RONNIE BIGGS (C Grylls) began awkwardly, losing ground. Approaching the 1400 metres PHEROZARDO (R Hutchings) raced ungenerously when being steadied MAKERS MARK (G Cooksley) hung out rounding the bend into the final straight dictating OKCORAL over extra ground. DREAMLINER (D Johnson) lay inwards when placed under pressure in the final straight.</p>

Race 3	Adams Trimmer Nauman Insurance Rating 65 1200
<p>BROKASH (M Vance) began awkwardly, shifting out making contact with MYTSHARP (C Parish).</p> <p>MONARCH (M Cameron) was crowded briefly shortly after leaving the barriers.</p> <p>RELEASE ME (L Innes) over-raced in the early and middle stages.</p> <p>BEAD OF COURAGE (A Collett) had to steady when becoming awkwardly placed on the heels of ADHIRA (N Collett) which shifted in. BEAD OF COURAGE then over-raced through the middle stages.</p> <p>MONARCH had to steady off the heels of RELEASE ME which shifted out under pressure passing the 200 metres.</p>	
Race 4	Little River Transport Rating 65 1800
<p>CECIL (C Grylls) and CARNIVA BOY (G Cooksley) were both slow to begin.</p> <p>When leaving the barriers MANHATTAN MAM (D Nolan) shifted out and hampered ZAH GIRL (M Cameron).</p> <p>CARNIVA BOY raced wide in the early stages.</p> <p>When questioned into the performance of ZAH GIRL Rider M Cameron stated that as it was the horse's first run over ground and also having the blinkers removed may have contributed to the horse's performance.</p>	
Race 5	First National Roper & Jones Mdn 1200
<p>QUIN BAY (L Innes) was slow to begin.</p> <p>LA PINNICLE (R Hutchings) raced ungenerously when being steadied approaching the 800 metres and made the bend awkwardly forcing CARTELL (A Collett) wider on the track.</p> <p>CARTELL made the bend near the 800 metres awkwardly and then was obliged to race wide without cover.</p> <p>LA PINNICLE continued to race ungenerously through the middle stages.</p> <p>QUIN BAY was not persevered with over the final 200 metres. Rider L Innes advised the Stewards that the horse was feeling the effects of the firmer nature of the track but could offer no other reason for the filly's performance. QUIN BAY underwent a post race veterinary examination which showed signs of mild lameness in the near fore leg.</p>	
Race 6	Empire Liquor Centre Mdn 1800
<p>OCEAN BOUND (A Collett) was slow to begin.</p> <p>KING DAN (C Grylls) began awkwardly.</p> <p>GINGER GEM (N Collett) began awkwardly making contact with GOOGLE ME (M Cameron) with both runners losing ground.</p> <p>GINGER GEM ran wide when making the bend passing the 1600 metres.</p> <p>OCEAN BOUND raced wide and hung outwards throughout.</p> <p>GOOGLE ME (M Cameron) lay in when placed under pressure in the final straight and was not persevered with over the final 200 metres.</p> <p>Approaching the 200 metres SAVANA FROM HAVANA (R Hutchings) was denied clear running between DELICIANO (L Innes) and KING DAN (C Grylls), having to be steadied. The connections of SAVANA FROM HAVANA wished to view the video footage alleging interference by the winner DELICIANO which shifted in under pressure but elected not to proceed.</p> <p>Passing the 200 metres CAT AND THE MOON (C Lammass) had to be steadied when crowded due to WINDSWEPT (G Cooksley) shifting out when racing greenly.</p>	

Race 7**Cams Auto & Funky Fish Café Mdn 1400**

TWO CAMELS (N Collett) and PRINCESS LEIA (C Grylls) came together when leaving the barriers.

LITTLEMISSCHATABOX (R Hutchings) over-raced when awkwardly placed on the heels of POETRY IN MOTION (C Parish) near the 1000 metres.

TWO CAMELS raced wide without cover.

THE PROPHECY (S Spratt) was held up passing the 300 metres when looking to obtain clear running.

Trainer S Ritchie was informed that TWO CAMELS was difficult to load and would have a barrier warning placed against the mare.
