GENERAL:

MANAWATU - Saturday 11th February 2012 Race 9: Commercial Tavern Ashhurst 1400m

Trainer Mrs K Zimmerman reported that ISHIAROSE had pulled up well and had pleased in her work over subsequent days since disappointing at Manawatu. Mrs Zimmerman also stated that no abnormalities had been detected following a veterinary examination of the filly.

RACE COMMENTS:

Race 1 ELDERS LIMITED STAYERS

M Cameron replaced D Nolan on MOIVARO due to D Nolan not being able to ride at the carded weight. D Nolan's explanation was accepted by the Stewards on this occasion.

MOIVARO (M Cameron) gave ground quickly passing the 500m, being distanced at the finish. When questioned, rider M Cameron stated that the gelding was unsuited to the heavy going. A post-race veterinary inspection failed to reveal any abnormality.

NO COMMISION returned to the enclosure with blood present in the nasal region. A subsequent veterinary examination revealed the injury to be a minor laceration.

Race 2 VISTA MOTOR LODGE / SILVER FERN FARMS FLYERS

WATER NYMPH began awkwardly. Apprentice C Dell advised that TIMO'SHANTER had failed to handle the Heavy 11 track. The winner (CAPTAIN BRO) shortened stride over the final stages when appearing to shy approaching the winning post.

Race 3 SUNSET POINT SPORTS BAR AND BISTRO DASH

CIVICS ROCK was slow to begin. CIVICS ROCK then made the first bend awkwardly and shifted out hampering NAVIGATOR. COWBOY raced wide throughout and tailed off over

the latter stages. Rider M Cameron stated that the gelding was never comfortable in the heavy going. SHARP DECISION hung outwards near the 300m forcing REYNARDS VIXEN wider. CIVICS ROCK stumbled passing the 200m. Apprentice R Myers reported that SHARP DECISION was never comfortable in Heavy 11 conditions.

M Cameron reported his mount COWBOY failed in the Heavy 11 conditions

Race 4 WAIKARE HOTEL 3 YEAR OLD

MISS CONSTRUE shifted out on jumping crowding PEIT ROX which got back. When questioned regarding the run of ZA BRUTE rider D Walker advised that the gelding travelled reasonably comfortably in the track conditions, but in his opinion would improve with the run

Apprentice M Cropp reported his mount Question which finished well back, failed in the Heavy 11 track.

Race 5 PGG WRIGHTSON SPRINT

Trainer T Autridge admitted a breach of Rule 537a after failing to declare a rider for SATEKA by the required time.

AUNT DAISY got back at the start after bumping with PILLAR TO POST. LE BON FIN was slow away. LE BON FIN was held up rounding the turn so was angled inwards to improve entering the home straight. Apprentice R Myers reported that PILLAR TO POST had been unsuited to the Heavy 11 track.

Race 6 WAIROA STUD BREEDERS STAYERS

WILLY DUGGAN (K Scallan) was slow to begin, and then raced very keenly in the early and middle stages and passing the 1200m was angled out into clear running when proving difficult to restrain. HOWBADAMI commenced to over-race passing the winning post on the first occasion and had to be steadied off heels for some distance. WILLY DUGGAN lay out rounding the turn losing ground. R Myers (SLOSHED) and M Cameron (SECRETS ABOUND) reported that their mounts had failed to handle the Heavy 11 track. HOWBADAMI underwent veterinary treatment after being galloped on during the running. C Dell (DEE DEE SMASH) reported that his mount had got its tongue over the bit during the race. Trainer P Campbell advised that he would apply a Norton Bit prior to its next start

Race 7 JUKEN NEW ZEALAND LIMITED CUP PRELUDE

CROCODILE CANYON was slow to begin. QUINN TAIT was inclined to lay in throughout the final straight when in bad going. NOBLE WARRIOR displaced a front plate during the running. S Collett (SONOZA) reported that her mount had failed to handle the Heavy 11 track.

Race 8 KENILWORTH PLUMBING SPRINT

CAMEO LASS was tightened at the start and lost ground. BLACK ATTACK was inclined to lay in over the final 200m. K Myers the rider of BLACK ATTACK was reminded of her obligation to ride her mount out fully when circumstances permit.
