## **SUPPLEMENTARY REPORT:**

Racing Te Aroha, Wednesday 18 April 2012

Race 7, Ecolab Ltd 1400

The Stewards today concluded an investigation into a fall in race seven. After considering the evidence from L Innes rider of **VALLEY DIAMOND**, A Collett rider of **BEAM ME UP** and A Calder rider of **SORA DAWNING** into the reason why **SORA DAWNING** fell near the 800 metres, and viewing the relevant videos which were inconclusive, the Stewards were satisfied that not one rider could be held accountable for causing interference resulting in **SORA DAWNING** falling. The Stewards ascertained that passing the 800 metres **SORA DAWNING** which shifted out on the point of the turn was crowded between **VALLEY DIAMOND** and **BEAM ME UP**.

#### RACE COMMENTS:

## Race 1 CAMBRIDGE EQUINE HOSPITAL PREMIER

LION MAN (M Coleman) was slow to begin.

MATO GROSSO (L Innes) stumbled leaving the barrier.

**DEO VOLENTE** (C Dell) began awkwardly shifting out inconveniencing **WESTBROOK** (S Collett).

**DECORAH** (J Collett) and **WOLF KING** (R Hutchings) began awkwardly.

100 metres after the start **DEO VOLENTE** shifted out and hampered **WESTBROOK** which became briefly unbalanced.

Passing the 900 metres **DEO VOLENTE** shifted in crowding **MATO GROSSO** which shifted in and crowded **JULINSKY PRINCE** (K Myers) which was checked. C Dell (**DEO VOLENTE**) admitted a breach of careless riding [Rule 638(1)(d)]. After considering the evidence the JCA suspended C Dell's licence to ride in races from 3 – 8 May inclusive (4 days).

**DEO VOLENTE** raced ungenerously when making the first bend.

KALEVALA (A Collett) got its head up when awkwardly placed on heels near the 700 metres.

WATCH KING (C Grylls) was held up for clear running in the early stages of the straight.

**JULINSKY PRINCE** raced greenly under pressure.

#### Race 2 MANELINE CAMBRIDGE PREMIER

ART BEAT (A Forbes) began awkwardly losing ground.

KAPTAIN KIRKUP (L Allpress) raced ungenerously when being steadied passing the 900 metres.

Making the bend passing the 800 metres **THE MINER** (J Collett) had to steady when crowded for room to the inside of **ASPINAL** (L Innes) which was taken in by **SHAHBAB** (H Kasim). H Kasim was advised to exercise care. **THE MINER** then raced keenly when awkwardly placed on heels for a short distance.

**SINGAPORE SLING** (S Spratt) raced in restricted room over the final 150 metres having to steady.

When questioned regarding the performance of **THE MINER**, J Collett stated in his opinion his mount was unsuited to the track conditions and furthermore that **THE MINER** is better suited racing right-handed.

MI PAYDAY (N Collett) lost the off hind plate during the running.

#### Race 3 RAFFLES FARM PREMIER

KOOL KID (T Thornton), TWO UP (M Cameron) and ELECTRONIC SOCKS (S Collett) were slow to begin.

LA MUCHACHA (L Innes) raced wide until improving forward passing the 900 metres to sit outside the leader.

**MARCHING ON** (S Spratt) made contact with **FLY SILCA FLY** (C Grylls) near the 400 metres when shifting out to obtain clear running.

**TART 'N' TARTAN** (S Shirahama) returned to the weigh-in enclosure with blood present in both nostrils. After undergoing a veterinary examination **TART 'N' TARTAN** was deemed to be a bleeder and as such is subject to the mandatory three month stand down from racing.

M Cameron reported that **TWO UP** had felt indifferent in its action throughout. A post-race veterinary examination of **TWO UP** failed to find any obvious abnormality. Trainer S Hale undertook to report the progress of **TWO UP** in days subsequent.

A post-race veterinary examination found AL ASKAN (L Woods) to be mildly lame in the near hind leg.

### Race 4 WILLIAM INGLIS & SON PREMIER

TANGO TERRIFIC (D Johnson) and LUCY IN DISGUISE (C Grylls) came together leaving the barrier.

QUEEN OF ROCK (R Norvall) began awkwardly.

SEQUIN (M Coleman) shifted out leaving the barrier crowding DE'COLLETAGE (A Forbes) and COOL CRUISING (L Allpress).

**CAP EDEN ROC** (J Collett) began awkwardly and then was hampered when **KINGS COURT** (M Cameron) shifted in abruptly.

**CAP EDEN ROC** was then further hampered when **TANGO TERRIFIC** shifted in.

QUEEN OF ROCK raced ungenerously when being steadied approaching the 1200 metres.

**LUCY IN DISGUISE** raced wide without cover.

**A KEEPA** (L Innes) had to change ground approaching the 250 metres to obtain clear running and then became awkwardly placed inside the heels of **ORINDA** (S Spratt) which lay in under pressure for the remainder of the race.

Over the concluding stages KINGS COURT lay in under pressure and hampered PRINCE OF WALES (J Waddell).

## Race 5 WINDSOR PARK STUD BREEDERS STAKES

PRESTIGIOUS MISS (L Innes) and READY STEADY (S Spratt) were both slow to begin.

TALE TO TELL (L Allpress) began awkwardly shifting out.

CAIPIRINHA (D Johnson) was crowded leaving the barriers when CASTING STONES (J Waddell) shifted in.

**GOLDEN GLOBE** (S Collett) raced wide without cover.

**WHOSYOURMASTER** (H Tinsley) was briefly held up entering the final straight.

## Race 6 PRESLAND TOCKER INSURANCE PREMIER

M Baker was fined \$50 for presenting HURRICANE MICKEY (A Forbes) to race in gear that had not been notified (blinkers).

**STAR OF SHOW** (R Hutchings) stumbled leaving the barriers losing ground.

**FLASH HAPI** (M Cameron) shifted out abruptly leaving the barriers crowding **JOHN GRAY** (T Thornton), **RIOTOUS** (N Collett) and **INDIKATOR** (B R Jones) which lost ground.

**ALEGRIO** (A Collett) knuckled leaving the barrier.

SUM UP (M Hills) was slow to begin.

**LEADERSHIP** (L Allpress) raced ungenerously when being steadied approaching the 1200 metres.

CAPONE (D Bradley) and ALEGRIO raced keenly in the middle stages.

**RIOTOUS** made the bend awkwardly passing the 900 metres

Making the bend near the 900 metres KEEPEREEL (D Johnson) shifted in and became briefly unbalanced when making

contact with **DANCING CHIEF** (P Taylor) which shifted in and crowded **WORTHING** (J Collett). D Johnson was advised to exercise care.

**RIOTOUS** was held up in the early part of the final straight.

**SUM UP** lay in under pressure in the straight.

WORTHING shifted out off heels passing the 200 metres to obtain clear running inconveniencing DANCING CHIEF.

**STAR OF SHOW** lost the near front plate during the running.

## Race 7 NZ BLOODSTOCK INSURANCE PREMIER

RYAN JOHN (J Collett) began awkwardly losing ground.

**POST D'FRANCE** (C Grylls) began awkwardly and shifted in making contact with **EH WANDA** (N Collett) which became briefly unbalanced.

QUEST (D Bradley) shifted out leaving the barrier making contact with RED SHIFT (M Coleman).

TIBERIUS (K Myers) began awkwardly.

**DOWAGER QUEEN** (R Hutchings) over-raced in the early and middle stages.

**POST D'FRANCE** raced wide without cover for the majority of the race.

**DOWAGER QUEEN** had some difficulty obtaining clear running in the early part of the straight.

Passing the 400 metres RYAN JOHN shifted out to obtain clear running inconveniencing QUEST.

Following this race Jason Collett was stood down by the Club's doctor as he was unwell. J Collett is required to be cleared by a medical practitioner before he rides next.

## Race 8 TRAVIS STAKES

**DOLMABACHE** (D Bradley) was slow to begin.

MISS SHARAPOVA (S Spratt) and FLORIA (L Innes) both began awkwardly.

JOY'S CHOICE (M Coleman) was crowded for room on jumping by ANNA MARIA (J Jago).

MISS SHARAPOVA over-raced in the middle stages.

Rounding the home turn **O'FILLE** (N Harris) was crowded for room and taken wider by **POSTMANS DAUGHTER** (C Dell) which hung out. In this incident **FLORIA** (L Innes), **MINI PEARL** (M Hills) and **PLATINUM PRINCESS** (K Myers) were inconvenienced.

The Stipendiary Stewards lodged a protest on behalf of the third placed horse **O'FILLE** against the second placed horse **POSTMANS DAUGHTER** alleging interference over the concluding stages. After considering the evidence the JCA upheld the objection and amended the placings accordingly. The Stewards considered the evidence and were satisfied that **POSTMANS DAUGHTER** despite the efforts of its rider shifted out and caused this interference and no action was taken.

**POSTMANS DAUGHTER** lost the off hind plate during the running.

Trainer S McKee will be interviewed regarding the immediate racing future of **FLORIA** which raced disappointingly.

## Race 9 MITAVITE PREMIER

PACIFIC ROSE (M Hills) was slow to begin.

YOUREIN (C Dell) began awkwardly.

GOLD CAPE (M Coleman) raced wide throughout.

**ADIDAZLER** (K Myers) over-raced when being steadied off heels approaching the winning post on the first occasion and continued to over-race through the middle stages.

BOB VALDEZ (M Cameron) was steadied when awkwardly placed on heels near the 500 metres.

**STINGRAY** (L Innes) was briefly crowded for room approaching the 400 metres.

Rounding the home turn **PACIFIC ROSE** was steadied to avoid the heels of **ADIDAZLER**. K Myers was advised to exercise care.

**BOB VALDEZ** had difficulty obtaining clear running until the 300 metres.
