RACE COMMENTS:

Race 1	KIWI TRANSPORT STAYERS
NO COMMISSION jumped out at the start tightening MOIVARO and CROSS CREEK. MOIVARO raced keenly over the early stages and passing the 1800m had to be steadied off heels. NO COMMISSION was inclined to over race in the early stages. FAST TEMPO had to take evasive action passing the 800m to avoid the heels of the rapidly tiring CROSS CREEK and shifted out bumping CALM THE STORM outwards onto GIONA which became unbalanced.	
Race 2	HAVELOCK NORTH NEW WORLD OPEN
STUPENDOUS (K Scallan) shifted out abruptly passing the 150m into the line of JUST CALL ME BOND which was forced wider on the track and lost momentum. A protest was lodged by the connections of the third placed JUST CALL ME BOND against the second placed STUPENDOUS alleging interference passing the 150m. After consideration by the JCA, the protest was upheld and the placing's amended to read 3,4,1,2,5 Apprentice K Scallan was advised that when in similar circumstances she would be expected to take corrective action sooner than she did on this occasion.	
Race 3	ADAMS ENGINEERING 3 YEAR OLD
ROMAN RASCAL raced greenly rounding the turn. PAPAZZI raced wide throughout. LATIN SORM was inclined to lay in throughout the final straight.	

Race 4	ANGUS GEMMELL SPRINT
<p>PINOCCHIO BOY jumped inwards abruptly at the start hampering BUNNYTHORPERULZ and TRULY WISHFUL which lost ground. BUNNYTHORPERULZ raced wide throughout. MISS EVERGREEN was held up passing the 250m. PEIT ROCKS was held up in the early part of the home straight and near the 250m, when attempting a marginal run to the inside of MISS EVERGREEN, was denied clear running when that runner shifted in marginally so was then taken wider to improve.</p>	
Race 5	WAIROA CLUB DASH
<p>EXCEEDINGLY RICH (L Allpress) began awkwardly, and then over-raced in the early stages. EXCEEDINGLY RICH then hung outwards rounding the turn and was not persevered with over the final stages. When questioned rider L Allpress stated that despite over racing, the mare failed to respond when pressured and was disappointing. A subsequent veterinary inspection failed to reveal any abnormality. Trainer Co-trainer K Fursden was advised that a warning had been placed on EXCEEDINGLY RICH with respect to its racing performance. Mrs Fursden stated she would trial EXCEEDINGLY RICH prior to it racing again.</p>	
Race 6	VETENT DASH
<p>DAUFINO began awkwardly and a short distance after the start, shifted in abruptly into the line of REYNARD'S VIXEN which had to steady. DAUFINO hung out rounding the turn. QUEEN OF ROCK raced keenly throughout. When questioned regarding the performance of DAUFINO rider L Allpress stated that the gelding had travelled only fairly in the ground and added that, in her opinion, it had not backed up from the first day.</p>	
Race 7	WAIROA STAR STAYERS
<p>DUCATI raced keenly early. PAUHATU was inclined to lay outwards throughout</p>	
Race 8	WAIROA BUSINESS SUPPORTERS WAIROA CUP
<p>PEACE LILLY and SONOZA WERE slow away. NOBLE WARRIOR raced keenly over the early stages. PETERGABRIEL hung out throughout and could not be fully tested over the concluding stages. Rider R Hutchings advised that in his view, PETERGABRIEL may be better suited to racing right handed. R Myers (QUINN TAIT) lost her whip passing the 600m.</p>	
Race 9	WAIROA EXPATS SPRINT
<p>LE BON FIN began awkwardly and lost ground. SATEKA was held up for some distance rounding the turn when on the heels of the tiring MY SPIRITED STAR, gaining clear running near the 250m. THE KNIGHT was obliged to race wide without cover throughout I CHIANTI gave ground rapidly passing the 600m and was eased down in the home straight. A Subsequent veterinary examination of I CHIANTI revealed the gelding to be displaying cardiac arrhythmia. Trainer R Manning was advised that he must provide a veterinary clearance for I CHIANTI, including the results of an ECG and, furthermore, that gelding would be required to trial to the satisfaction of Stewards prior to racing again. When questioned regarding the improved performance of the winner GIJIMA, connections advised that the gelding was better suited to the improved track conditions.</p>
