RACE COMMENTS:

Race 1	R D 1 MAIDEN
ORISSA was slow away. MR IDEAL raced keenly over the early and middle stages. Passing the 1200m ORISSA had to be steadied off heels and then taken wider when racing keenly, this resulted in FRED FLINSTONE being dictated over extra ground for a short distance.	
Race 2	PGG WRIGHTSON MAIDEN 3YO
FLYING DAISY was slow away. BEAU ZED shifted out under pressure in the final straight. POROTENE RIO was denied a narrow run between ROYAL HAZE and ST RANSOM near the 100m had to change ground outwards to improve. A short distance further on ROYAL HAZE and ST RANSOM came together and bumped when both runners shifted ground under pressure. When questioned regarding the run of BEGUILING rider H Tinsley stated that in his view the filly may be better suited to a longer distance at this stage of its preparation. Following further rain the track conditions were downgraded to Heavy 10.	
Race 3	FARMLANDS MAIDEN
SLUMDOG MILLIONAIRE lay in over the final 400m and had to be continually straightened.	
Race 4	SUPER LIQUOR 1200
BARSTORM reared and lost several lengths at the start. ALKEMPO commenced to over race when wide in the back straight. DI'S BOY lost the near front plate during the race.	

Race 5	CLASS HARVEST CENTRE MAIDEN
<p>BELLE ZED was slow away.</p> <p>ELUSIVE LAW jumped inwards abruptly at the start and bumped heavily with LEATHER N' LACE.</p> <p>BETTER KEEPER began awkwardly.</p> <p>PRECIOUS POPPIE and POACH THE CASH bumped at the start.</p> <p>The saddle on BELLE ZED shifted back approaching the first turn placing the rider at a disadvantage.</p> <p>DICK DASTARDLY was inclined to shift out under pressure in the final straight.</p> <p>BETTER KEEPER was inclined to race greenly early in the final straight.</p> <p>When questioned regarding the run of POACH THE CASH apprentice jockey A Collett could offer no excuses other than the gelding may have been unsuited to racing left handed.</p> <p>When questioned regarding the run of ELUSIVE LAW rider H Tinsley stated that the gelding was unsuited to today's heavy 10 track conditions.</p>	
Race 6	WINDSOR PARK STALLIONS 1400
<p>Apprentice D Turner was fined \$100 pursuant to Rule 330(3)(c) in that he was unable to claim his full allowance for MANDY KAY. As there were no other suitable claiming apprentice, apprentice Turner was permitted to fulfil his engagement on this occasion</p> <p>SILVER VEIL raced wide in the back straight in search of better footing.</p>	
Race 7	TARANAKI DISTRICT TURF CLUB
<p>SOU'EAST was slow over the early stages.</p> <p>Apprentice D Turner (QUICK MARCH) admitted a breach of Rule 636(1)(c) in that he relaxed his ride over the concluding stages when in at least 2nd equal placing. After deliberations the JCA suspended apprentice jockey Turner's licence to ride in races from the conclusion of races today up to and including racing on 14 July 2012.</p> <p>JENNY'S OKAY raced greenly over the concluding stages.</p> <p>When questioned regarding the improved performance of RANGATIRA the connections advised the gelding had benefited from a bout of schooling.</p>
