RACE COMMENTS:

Race 1	FIBER FRESH MAIDEN SPRINT
<p>QUALITY STREET and MIBACHELORBOY were both crowded shortly after jumping away, losing ground. QUALITY STREET clipped a heel during this incident</p> <p>SHARE THE BLAME began awkwardly.</p> <p>When questioned into the run of MONTEREY which finished last, rider M Dravitski was of the opinion that the gelding would be better suited to a more rain affected track.</p> <p>MIBACHELORBOY had difficulty obtaining clear running over the final stages.</p> <p>When questioned into the run of QUALITY STREET, L Allpress was of the opinion her chances of finishing in a higher placing were affected after receiving a check at the start and that the filly was unable to recover sufficiently over the 1000 metres.</p>	
Race 2	CORNER CAFÉ/SCOTTY'S MEATS MAIDEN
<p>CHAIR UP began awkwardly and shifted in crowding MY OPINION on to FINAL WARNING, which was checked and lost ground. Shortly after, RUBY LADY shifted away from CHINA ROYALE, forcing DAL ARCA across the heels of MY OPINION which clipped a heel, blundered and lost ground.</p> <p>DAL ARCA raced greenly throughout and shifted out on the home bend forcing SINGSTAR over extra ground. DAL ARCA shied on pulling up, dislodging rider S Collett, who was uninjured. Trainer K Lawrence was advised that a warning has been placed on DAL ARCA with regard to its racing manners.</p> <p>When questioned into the run of FINAL WARNING, rider L Allpress said that despite receiving tightening at the start, had no real excuse for the filly's poor effort, after tailing off. A post-race veterinary inspection failed to reveal any abnormality.</p>	
Race 3	CRIGHTON ITM BUILDING CENTRE 1300
<p>HULA GRACE began awkwardly.</p> <p>SHANGHAI LIL jumped out abruptly leaving the barriers, crowding CEVICHE, PRINCE FEDERICO, BEAU AGEN and CITADELLE.</p> <p>TURKISH GOLD compounded near the turn after leading throughout and finished last. Trainer G Searle advised that the gelding would be spelled.</p> <p>When questioned into the run of PRIVATE LINCOLN, rider K Myers had no excuse.</p>	

R Hannam the rider of EXCEEDING A DREAM was advised to exercise care after he allowed his mount to shift out in the home straight hampering BEAU AGEN near the 150 metres.	
Race 4	HOLMES CONSTRUCTION 2000
SHOW THE BEEL and SOUTH ROAD began awkwardly. PENNON shifted out leaving the barriers and inconvenienced OUR DESTINY. SOU'EAST was slow to begin. SOUTH ROAD raced ungenerously leaving the straight. SOU'EAST had to shift inside the heels of AINTREE near the 300 metres when awkwardly placed.	
Race 5	MAC DEVELOPMENTS MAIDEN 2200
MAC AN ATHAIR, LUCKY LOL and SHORT OF CENTS all began awkwardly. SEA EAGLE and PAY DIRT came together leaving the barrier, with SEA EAGLE losing ground. HIKURANGI BILL over raced in the early stages. When questioned regarding the performance of EVASIVE TRACY, which finished well back, rider D Walker could offer no excuse. A post-race veterinary examination of EVASIVE TRACY could find no obvious abnormality. HIKURANG BILL underwent a post-race veterinary examination, which revealed the gelding to have a minor respiratory complaint and to have suffered cardiac arrhythmia. Trainer M Oulaghan was advised that he must provide the clear results of an ECG and trial HIKURANGI BILL before being permitted to race again.	
Race 6	RAT RAT 2200
R Hutchings was unable to make the required weight for HULA SISTER and was fined \$100 under Rule 330(3)(c). He was replaced by A Morgan. I'M NOT TICKLISH began awkwardly, shifting out. SOUTHERN SAM, HEAVENLY PRINCESS, JABEZ and TINKER BELLE were all crowded between KEEP AHEAD and REGAL RETURN, which both began awkwardly, shifting ground, with TINKER BELLE losing ground as a result. FOOTLOOSE shifted out leaving the barrier, crowding SLACK THE DIVER and BARBARA ANN. HULA SISTER shifted out leaving the barriers crowding SMART MOLLY and HOOVER BOY JEZARAY was slow to begin. HULA SISTER raced keenly in the early and middle stages.	
Race 7	A1 HOMES FILLIES & MARES 1600
NEGOTIATE, DIANA and CONSERVES LA FOI were slow to begin. ANAGRAM shifted in abruptly leaving the barriers, crowding SKIRMISH, which made contact with WANNABE QUEEN, which became briefly unbalanced. KARLA BRUNI over-raced in the middle stages. KARLA BRUNI was held up for a short distance passing the 400 metres.	
Race 8	ACTIVE MARKETING MAIDEN 1600
ZODIAC was slow to begin. ZENA PRINCESS began awkwardly. LA BELLA SANDS shifted out leaving the barrier crowding PERFECT SYMBOL and LADY LUNCHALOT out on to SHOT OF IRISH which was hampered, losing ground. STORMY RIVER over-raced in the early stages. LADY LUNCHALOT failed to finish the race off as expected, with rider L Allpress offering no excuse.
