RACE COMMENTS:

Race 1 Cowley's Hire Centre Ltd 1600

LIPPY (C Dell) jumped in at the start making contact with BO ON THE GO (P Taylor) which lost ground.

RECKLESSLY (C Lammas) was slow to begin.

LIPPY raced wide throughout.

Approaching the 1400 metres BO ON THE GO was crowded losing ground due to outward movement from STORM IN (J McDonald) and inward movement from LIPPY.

FULLOVIT (M Cameron) was unable to obtain clear running between the 200 metres and 100 metres.

LIPPY had to be steadied near the 100 metres when crowded to the inside of MEDIADOR (M Sweeney) which lay in under pressure. Also contributing was outward movement from RIO TONTO (S Spratt).

GUNNA returned to the enclosure with blood present in both nostrils. After undergoing a veterinary examination GUNNA was deemed a bleeder and is now subject to the mandatory 3 month stand down.

Trainer K Rae was fined \$50 under Rule 616 for presenting CALIBURN to race without notified gear (blinkers).

Race 2 Lion Red 1400

REACHFORTHESTARS (M Cameron) jumped in at the start crowding ST RHYTHM (M Sweeney) and NAZEER (J Collett) which both lost ground.

THE PALM KING (P Taylor) jumped away awkwardly.

GOOGLE ME (S Spratt) got its head up when over-racing in the middle stages.

ROSE TATTOO (C Parish) was inclined to lay out making the bend awkwardly near the 800 metres then continued to lay out rounding the bend.

REACHFORTHESTARS had to steady off the heels of THE PALM KING on two occasions between the 500 metres and 400

metres and then had difficulty obtaining clear running until the final 150 metres.

THE PALM KING was held up until passing the 200 metres.

NAZEER (J Collett) was held up near the 150 metres.

L Innes was questioned into the performance of PEGASUS MOUTON and stated that the horse raced greenly and was reluctant to improve into a marginal run in the final straight.

Following the running of Race 2 the siren was sounded as to LARGE AS LIFE being denied a fair start due to the starting gate being slow to open. An information was filed to the Judicial Committee to determine if the horse LARGE AS LIFE was denied a fair start. After viewing the video and also questioning Rider M Hills the horse was declared a non runner and all investments were refunded.

Race 3 The Northern Advocate 1400

GOOD WILL (J McDonald) began awkwardly losing ground and was then further hampered due to LION RED (M Cameron) shifting out.

ABUNDANTIA (J Castano) began awkwardly losing ground.

RIX'S BENEFIT (M Sweeney) shifted in forcing ANDREAS (T Thornton) inwards.

Approaching the 1300 metres ANNIE BELLOTA (C Parish) had to be steadied losing ground when racing to the inside of SPICEY AS (M Hills) and MANDY O'REILLY (J Collett) which was racing greenly when dictated in by ELUDE (C Dell) C Dell was issued with a warning. Also having to steady as a result was SCHNAPPA ROCK (P Taylor).

LION RED (M Cameron) ran wide passing the 800 metres and continued to race wide into the final straight and was not persevered with finishing wide out on the track. LION RED underwent a post race veterinary examination which revealed no abnormalities. A warning on was placed on the geldings racing manners.

RIVELATORE (J Oliver) was held up for clear running between the 400 metres and 200 metres.

Near the 200 metres SPICEY AS had to steady when crowded between ANDREAS and MANDY O'REILLY with both those runners shifting ground.

Race 4 Industrial Security Specialists 1600

AL ASKAN (J McDonald) was checked by the Veterinarian at the start after galloping some distance before being pulled up by its rider during the preliminaries and was cleared fit to start.

PAY PACKET (J Oliver) and JUSTACROSS (A Collett) both jumped away awkwardly.

PAY PACKET commenced to over-race passing the 1400 metres and then near the 1000 metres. Rider J Oliver was in difficulty as his saddle had slipped forward placing the rider at a disadvantage for the remainder of the race.

BELLE DE JEU (S Spratt) was briefly held up passing the 200 metres having to shift ground to the inside of CONG'ER (M Cameron) to obtain clear running.

When questioned into the performance of GRAND ADMIRAL Rider L Innes was unable to offer any explanation apart from the gelding being unsuited by the tempo of the race.

Race 5 Art N Tartan Wearable Arts 1600

MANNY PACUIAO (M Cameron) shifted in abruptly on jumping away and hampered FREE SERVE (J Collett) and BROTHER MICKEY (J Whiteside).

CHAINEDINALKATRAZ (R Hutchings) was very slow away.

THORNY CHICK (J McDonald) was slow away.

BROTHER MICKEY had to shift out near the 1400 metres when inside the line of the running rail and in doing so dictated CLASSIC KANGA (P Taylor) outwards.

GOVIND (C Dell) raced wide without cover throughout.

FREE SERVE was held up for clear running early in the final straight.

Passing the 400 metres ARTEMIS (M Hills) when laying out had to be steadied when becoming awkwardly placed on the heels of GOVIND and then when shifting in made contact with the hind quarters of GOVIND which became briefly unbalanced.

GOVIND had to be steadied off the heels of WHISTLING STRAIGHTS (S Spratt) which shifted in under pressure near the 300metres,S Spratt was told to exercise care.

Near the 300 metres CANDIDLY when held up had to shift out when becoming awkwardly placed on the heels of BROTHER MICKEY and MAWAH VELLOUS (T Thornton).

Near the 150 metres CANDIDLY (M Cropp) when being restrained got its head in the air and shifted in abruptly. FREE SERVE (J Collett) then had to be steadied off that runner's heels and shifted out dictating WHISTLING STRAITS (S Spratt) over extra ground.

Race 6 91.6 More FM 1200

DREAMCATCHER (A Collett) began awkwardly shifting in making contact with GOLD HUNTER (T Thornton) which lost ground.

FARAWAY EYES (J Collett) was slow to begin.

Approaching the 800 metres READY STEADY (M Cameron) had to be steadied when crowded by ERNESTO (M Hills).

Passing the 800 metres CACHUCHA made the bend awkwardly shifting out dictating KOOL KID (C Dell) on to ORDINDA (\$ Spratt) which shifted in slightly. CACHUCHA then continued to over-race for a short distance. ORINDA then made the bend awkwardly.

GOLD HUNTER raced in restricted room between the 250 metres and 150 metres.

BILLY BINGO (C Lammas) had to steady when SPIN DOCTOR (BR Jones) shifted in passing the 150 metres.

Northland Copier Services 2100 Open

LOVISTE (M Cameron) jumped away awkwardly losing ground.

MAGNA CARTA (R Hutchings) was slow to begin.

Passing the 1700 metres JUNGLE JUICE (S Spratt) when being restrained threw its head in the air and went back on to MATOST (M Wenn) which had to be firmly restrained.

DESERT LAD (T Thornton) was obliged to race wide until being allowed to stride forward and sit outside the leader passing the 1400 metres.

THE STRUTTER (M Hills) hung outwards from the 600 metres.

NOBLE WARRIOR (L Innes) shifted out under pressure passing the 150 metres into the line of DANCING EMBERS (C Dell) which had to be steadied off that runner's heels.

Fell Engineering Ltd 1400 Race 8

PRETTY TO WATCH (C Dell) which was kicked behind the barriers underwent a veterinary examination and cleared fit to start.

SHANSPUR (M Cropp) was crowded at the start losing ground when GEM LOVER (K Kalychurun) shifted in and SPLITFIRE (R Hutchings) shifted out.

LILY BEE (M Wenn) shifted out on jumping away making contact with EMERALD DANCER (T Thornton). Also contributing was inward movement from CHARLI JAY (M Hills).

GEM LOVER shifted out passing the 1000 metres and continued to race wide throughout.

HEART OF DARKNESS (M Cameron) raced ungenerously in the early stages and then when passing the 800 metres ran off and was not persevered with for the remainder of the race. The connections were advised the filly must barrier trial to the satisfaction of the Stewards before racing again. The filly underwent a post race veterinary examination which revealed no abnormalities.

J McDonald, the rider of ISHIMINE, reported to the Stewards that the horse felt indifferent in its action in the final straight. ISHIMINE underwent a post race veterinary examination which revealed no abnormalities.

SHANSPUR after being crowded at the start settled at the rear of the field and failed to respond to the rider's urgings in the final straight. When questioned M Cropp could offer no reason. SHANSPUR underwent a post race veterinary examination which revealed no abnormalities. Stable Representative E Chippendale informed the Stewards that the horse had under gone an endescopic examination and also had blood taken which returned clear results. The Stable Representative undertook to inform the Stewards of any issues that may show up in the ensuing days.

Northland Vet Group 1400

MR SHANGHAI (J Oliver) jumped away awkwardly and shifted out losing ground.

KRASH (J Whiteside) jumped away very awkwardly losing several lengths.

CHEEKY RED (S Spratt) shifted in on jumping away making contact with PRINCE OF WALES (BR Jones) which was forced inwards making contact with MR SHANGHAI who became unbalanced.

MR SHANGHAI raced wide in the middle stages.

Passing the 800 metres SARSARUN (A Collett) was crowded to the inside of THE RACONTEUR (M Sweeney) which was
