| <p>NO REDEMPTION (K Kalychurun) began awkwardly losing several lengths.</p> <p>FOXY BELLE (A Collett) and COAT DU ROAN (M Du Plessis) were both slow away.</p> <p>FLICKA OF GOLD (N Collett) shifted out after jumping away taking CHARLIE FARLEY (C Dell) out on to the hind quarters of OUR CAPTAIN JACK (R Norvall) which in turn made contact with BELLA SWAN (C Parish).</p> <p>OUR CAPTAIN JACK over-raced in the middle stages and hung out when making the final turn. OUR CAPTAIN JACK then lay in in the final straight.</p> <p>IRISH KING (M McNab) lay in and had some difficulty obtaining clear running near the 100 metres.</p> <p>TWILIGHT DRAGON underwent a post-race veterinary examination which failed to find any obvious abnormalities.</p> <p>D Nolan admitted a breach of Rule 636(1)(c) in that he failed to ride TWILIGHT DRAGON out to the end of the race when there was a reasonable chance of the horse finishing in fifth position. The JCA fined D Nolan \$200.</p> |                                  |

| <b>Race 2</b>  | <b>Macsway Scaffolding 1000</b>          |
| <p>NINE PIN (L Innes) was slow to begin.</p> <p>D'CASH MAN (C Parish) shifted out from the 200 metres when placed under pressure.</p> <p>The connections of the third placed horse MUMS APPARITION viewed the footage in the final straight, electing not to proceed with an objection.</p> <p>C Parish admitted a breach of careless riding in that he permitted D'CASH MAN to shift outwards near the 50 metres when not sufficiently clear of MUMS APPARITION which was checked, hampering DIAMONDS IN TIME. The JCA suspended Jockey C Parish's licence to ride in races, 26 August - 1 September, inclusive. 4 riding days.</p>   |  |
| <b>Race 3</b>  | <b>Lawson Cartage Ruakaka 1400</b>       |
| <p>ISHETICKLISH (E Leighton) proved difficult to load. Trainer S Ralph was informed that a barrier warning would be placed against the mare.</p> <p>RAJAH BROOK (A Collett) was a shade slow to begin.</p> <p>LADY PRIVATEER (A Taylor) raced wide without cover throughout.</p> <p>HAMACHO (M McNab) raced ungenerously when being steadied passing the 1200 metres.</p> <p>LADY PRIVATEER ducked in near the 300 metres having to be straightened by its rider and inconveniencing GET ON IT (M Cheung). LADY PRIVATEER continued to race greenly for the remainder of the race.</p> <p>SMEDLEY (J Oliver) raced greenly in the final straight and shifted out passing the 200 metres hampering ISHETICKLISH.</p> <p>When questioned regarding the performance of RAJAH BROOK Apprentice Jockey A Collett could offer no tangible explanation.</p> <p>RAJAH BROOK returned to the enclosure with blood present in the right nostril. RAJAH BROOK underwent a veterinary examination which found the blood to be consistent with a laceration to the nostril.</p>   |  |
| <b>Race 4</b>  | <b>Rudolphins Abrasive Blasting 1600</b> |
| <p>KLONDYKE ROAD gave ground passing the 500 metres finishing a distant last. Trainer K Coulter was advised that a warning would be placed against KLONDYKE ROAD and the mare would be expected to be more competitive at its next race day start.</p>   |  |
| <b>Race 5</b>  | <b>Doidges Tyres 2100</b>                |
| <p>AIR CADET (M Hills) began awkwardly.</p> <p>AMANPULO (R Hutchings) was slow away.</p> <p>N Collett defended a charge of careless riding in that she permitted her mount PAUHATU to shift inwards near the winning post on the first occasion when not sufficiently clear forcing THE PALM KING (V Colgan) into the line of COUNT ON (T Thornton) which was checked. After hearing all relevant evidence and submissions the Judicial Committee found the charge to be proven and suspended Miss Collett's license to ride in races from the conclusion of racing today until the conclusion of racing on Thursday 30 August 2012, 4 riding days.</p> <p>Passing the 1600 metres THE PALM KING (V Colgan), IRENE ALICE (P Turner), COUNT ON (T Thornton) and OVERTHROW (R Norvall) all over-raced when the pace slackened.</p> <p>COUNT ON continued to over-race throughout and was not persevered with in the final straight with the rider dismounting when pulling up. COUNT ON underwent a veterinary examination and was found to have bled and as such is subject to the mandatory three month stand down from racing. Co-trainer Mr P Mirabelli indicated that COUNT ON is now likely to be retired.</p> <p>When making the final turn OVERTHROW made contact with the hind quarters of CLASSIC KANGA (C Parish) with that runner becoming briefly unbalanced.</p> |  |

| <p>REVES EN ROUGES (S Collett) was very slow to begin. Trainer R Lawrence was advised that the mare must barrier trial to the satisfaction of the Stewards before being permitted to race again.</p> <p>DANDYLIGN (V Colgan) shifted out abruptly when leaving the barriers hampering AIMEES BABE (M Sweeney) and RIP CITY (R Norvall).</p> <p>SOLAR ECLIPSE (R Hutchings) began awkwardly.</p> <p>DANDYLIGN over-raced in the early and middle stages.</p> <p>AIMEES BABE returned to the enclosure with blood present in the nasal area. After undergoing a veterinary examination AIMEES BABE was found to have a laceration to the nose.</p>   |  |

| <p>KRASH (D Johnson) began awkwardly.</p> <p>HIDDEN ASSET (M Cheung) began awkwardly shifting in crowding SWIPER THE FOX (K Kalychurun).</p> <p>LUCKY BREAK (P Taylor) over-raced in the early stages.</p> <p>BONUS BOND (A Forbes) lay in over the concluding stages.</p> <p>The connections of the second placed horse LUCKY BREAK viewed the footage in the final straight, electing not to proceed with an objection.</p> <p>SWIPER THE FOX underwent a post-race veterinary examination which failed to find any obvious abnormalities.</p>  |  |
| <b>Race 8</b>   | <b>Ruakaka Economic Development Group 1600</b> |
| <p>E Tomes was unable to claim down to his riding weight aboard STEEL and was replaced by J Oliver at the request of Trainer G Rogerson. E Tomes was fined \$100 under Rule 330(3)(c).</p> <p>PORSHABEEL (K Kalychurun) and DRAGON EYE (M Coleman) came together when leaving the barriers.</p> <p>DRAGON EYE shifted out passing the 1400 metres when racing fiercely making contact with PRINCESS LEIA (C Parish) which shifted out forcing KING DAN (M Cheung) into the hind quarters of SHANSPUR (L Innes) which became unbalanced. KING DAN then shifted in abruptly crowding PRINCESS LEIA and DRAGON EYE which shifted in abruptly forcing JUNGLE KNIGHT (S Spratt) inwards. JUNGLE KNIGHT shifted out when being corrected by its rider, with STEEL which was over-racing became awkwardly placed, clipping a heel and blundering almost dislodging Rider J Oliver.</p> <p>STEEL underwent a post-race veterinary examination which failed to find any obvious abnormality.</p> <p>KING DAN over-raced through the middle stages.</p> <p>JUNGLE KNIGHT and SHANSPUR both shifted in under pressure over the concluding stages.</p> <p>JUNGLE KNIGHT returned to the enclosure with a laceration to the near hind leg and underwent veterinary attention.</p> <p>PORSHABEEL underwent a post-race veterinary examination which failed to find any obvious abnormality.</p> |  |
