#### RACE COMMENTS:

### Race 1 'FIRST GIRL HOME' MAIDEN (1200m)

The start of this race was delayed due to **SAN GURU** proving difficult to get to the barriers, and further delayed when **TANTIVY** reared and became cast in the barriers and was declared a late scratching on veterinary advice at 12.37 pm. **AUSSIE BOY** which was in the next barrier also underwent a pre race veterinary examination and was cleared fit to race. The connections of **TANTIVY** were advised that the mare must barrier trial to the satisfaction of the Stewards prior to racing again.

**SKY JAZZ** began awkwardly and got back as a result.

**SAN GURU** and **AUSSIE BOY** came together as the start was effected, with the rider of **SAN GURU** being unbalanced momentarily.

Shortly after the start **AUSSIE BOY** had to be steadied when **ROBERT BROOK** shifted inwards when not clear. Apprentice rider D Prastiyou was shown the films in the presence of his employer and issued with a warning.

Approaching the bend near the 1000 metres **HALO MAY** got its head up when racing keenly and shifted inwards and in doing so hampered **PARADISE CITY**. The trailing **ROBERT BROOK** contacted a heel of **HALO MAY** in this incident and blundered. Also inconvenienced was **PERFECTLY COURT** which had raced up onto the heels of **ROBERT BROOK**.

Passing the 800 metres AUSSIE BOY was steadied off heels for some distance.

Passing the 300 metres **PARADISE CITY** and **SANDYS GIRL** came together and made firm contact on two occasions.

AUSSIE BOY raced in restricted room passing the 300 metres and lay out under pressure in the final 200 metres.

# Race 2 PHAR LAP MAIDEN (1200m)

LANGTON KATIE and OUR SANTANA were slow to begin.

**RUBY RED** was obliged to race four wide without cover throughout.

Passing the 800 metres **SUPERTED** commenced to lay out. **SUPERTED** continued to race greenly and passing the 400 metres despite its rider's urgings failed to make the bend and in doing so hampered both **JACKSANFIVES** and **RUBY RED**, forcing those runners over extra ground.

Passing the 200 metres **OUR SANTANA** shifted in to obtain clear running. When spoken to regarding the improved performance of **KOSTALOT**, trainer N Coulbeck reported that the gelding had taken natural improvement from its debut run on unsuitable track conditions where it had been hampered early. He added that beginning well from the inside barrier draw coupled with the stronger rider also contributed to the performance.

When questioned regarding the performance of **PENNYS FROM HEAVEN** which tailed the field from the 700 metres and finished a distant last, rider R Hannan stated the filly was reluctant to stride out in today's track conditions. The connections of **PENNYS FROM HEAVEN** were advised that the filly must trial to the satisfaction of the Stewards prior to racing again. A post race veterinary examination of **PENNYS FROM HEAVEN** did not reveal any obvious abnormalities. A post race veterinary examination of **SUPERTED** revealed the gelding to have struck itself behind. The connections were advised that **SUPERTED** must trial to the satisfaction of the Stewards prior to racing again.

# Race 3 D'CASH DASH RATING 65 (1200m)

TORO was slow to begin.

**GOOD EXCUSE** raced keenly for a short distance passing the 1000 metres and shifted inwards when being restrained and made firm contact with **GEM LOVER** which became unbalanced.

WANNABEAWALLABETOO made the bend passing the 1000 metres awkwardly, shifting wider on the track.

**LEZANI** lay outwards rounding the home bend.

Passing the 200 metres **WANNABEAWALLABETOO** lay in under pressure.

# Race 4 SPEIGHT'S SPRINT RATING 85 (1200m)

**ZIVA** blundered on jumping, almost dislodging its rider.

**ROYAL GOVERNESS** and **SEMPER PLUS** made firm contact as the start was made.

Passing the 1100 metres **ZIVA** got its head up when being restrained and shifted out abruptly hampering **SEMPER PLUS**. **SATISFACTION** raced wide rounding the home turn.

**MILO** was held up passing the 350 metres and had difficulty obtaining clear running until the 200 metres when the gelding had to be steadied and shifted outwards to improve making contact with **ROYAL GOVERNESS**.

Rider K Williams reported to the Stewards that after getting back further than anticipated due to the interference, **SEMPER PLUS** never travelled well throughout and only ran home fairly despite her urgings. She added that the mare should benefit from today's race.

# Race 5 EQUINE VETERINARY SERVICES RATING 85 HANDICAP (1600m)

**DINO** was slow to begin.

KING PRAWN was tightened between runners as the start was made and as a result got back.

Passing the 1400 metres **THE DEBT COLLECTOR** commenced to lay outwards proving difficult to ride. **THE DEBT COLLECTOR** continued to lay outwards for the remainder of the race.

Passing the 150 metres **HYDROGEN** which was laying in under pressure made firm contact with **THE DEBT COLLECTOR** which was laying out.

A post race veterinary examination of **THE DEBT COLLECTOR** revealed no obvious abnormalities.

#### Race 6 WASHDYKE WONDERS RATING 65 1600 (1600m)

YAZOOM was slow to begin.

**CORAZANA** shifted away from **ROWDY** as the start was effected and further hampered **YAZOOM**.

**KEMDALE** raced wide throughout.

Passing the 1000 metres **EL BEE DEE** got its head up when being restrained off heels.

**CORAZANA** raced ungenerously through the middle stages.

Passing the 350 metres **EL BEE DEE** which was racing in tight quarters was held up until inside the final 100 metres.

Passing the 300 metres **BRAEHILL** which was attempting a marginal run on the inside of **SIR LUIS** was denied clear racing room until the 100 metres when having to shift outwards across heels to obtain clear running.

Passing the 250 metres CORAZANA and YAZOOM came together with YAZOOM becoming unbalanced.

Approaching the 200 metres **YAZOOM** (D Prastiyou) shifted out when not clear, making contact with **CORAZANA** on three occasions with both runners becoming unbalanced. Apprentice rider D Prastiyou admitted a charge of careless riding under Rule 638(1)(d) with the Judicial Committee suspending his licence to ride at race meetings for 2 days effective 8 to 14 November 2012 inclusive.

CORAZANA which returned to the birdcage with blood present in both nostrils underwent a veterinary examination and

was declared a bleeder and stood down for the mandatory three months.

### Race 7 PORT FM MAIDEN MILE (1600m)

TANDALA was hampered between runners as the start was effected and got back as a result.

Passing the 1500 metres **DENISES TOY BOY** got its head up and lost momentum when being restrained off the heels of **VOUSSOIR**.

**GIOCCHINO** raced wide through the early and middle stages.

Passing the 350 metres **GIOCCHINO** (J Chong) which was laying out shifted out and in doing so hampered **RUFSHOT** which had to steady. Rider J Chong was cautioned in regard to shifting ground when not clear.

### Race 8 NZ THOROUGHBRED BREEDERS ASSN CANTY/WESTLAND MDN (2100m)

**OUR ZULU GIRL** was slow to begin.

**OURMANSTAN** pulled hard over the early stages.

MISTER SPIDERMAN and WHATS NEW made the first bend awkwardly forcing MY SYDNEY BOY over extra ground.

WHATS NEW and OURMANSTAN continued to over race through the middle stages.

WHATS NEW raced wide without cover from the 1000 metres.

Passing the 500 metres MISTER SPIDERMAN raced ungenerously when in tight quarters.

Passing the 350 metres ITS HAPPENEN had to steady momentarily when in tight racing quarters.

Passing the 200 metres MISTER SPIDERMAN was held up for a short distance.

When questioned regarding the performance of favoured runner **WHATS NEW**, rider R Hannam stated that after over racing early, the stop start nature of the race did not suit the mare and when asked to improve passing the 1000 metres the mare had challenged for the lead rounding the home turn but had faded in the run home despite his urgings. A post race veterinary examination of **WHATS NEW** did not reveal any obvious abnormalities.

When questioned regarding the performance of **OURMANSTAN**, rider C Johnson reported that after over racing through the early and middle stages, the gelding had travelled into the race well approaching the turn but had failed to run on despite his urgings in the home straight and in his opinion may not have seen out the distance of today's race. A post race veterinary examination of **OURMANSTAN** did not reveal any obvious abnormalities.

# Race 9 CENTRAL SI OWNERS & TRAINERS RATING 75 2100 (2100m)

NO ROSETTES began awkwardly and MISSCEO was slow to begin.

WHAT A FIND raced fiercely through the early stages.

**TRISTANS CHOICE** got its head up passing the 1800 metres when being restrained and raced fiercely proving a difficult ride and forcing **KOKIID** and **EKSTRA SPECIAL** over extra ground. **TRISTANS CHOICE** continued to over race for some distance. When questioned regarding the performance, rider T Moseley stated that after being extremely difficult to control rounding the first bend the gelding over raced and when placed under full pressure failed to respond. A post race veterinary examination of **TRISTANS CHOICE** did not reveal any obvious abnormalities.

WHAT A FIND raced wide without cover from the 1100 metres.

**NO ROSETTES** raced wide from the 900 metres.

**WHAT A FIND** lay in throughout the home straight having to be straightened.
