## RACE COMMENTS:

Race 1 Rotary Club of Auckland East Stayers

**TE KINGI** (A Taylor) and **HAWICK PARK** (J Jago) came together on jumping away.

**KIDNAPPED** (C Grylls) began awkwardly.

LE BON FIN (S Shirahama) had to be steadied when racing in restricted room near the 1600 metres.

IRENE ALICE (M Du Plessis) raced three wide without cover throughout.

**MONTETRA** (R Hutchings) raced wide through the middle stages.

THE MISSING LINK (M Cheung) had to be steadied passing the 1200 metres when crowded for room to the inside of

**MONTETRA**. R Hutchings was advised to exercise more care.

ELECTRONIC SOCKS (S Collett) was crowded approaching the 500 metres when HIGH COUNTRY (S Spratt) lay in.

**THE STRUTTER** (M Cameron) was held up until passing the 300 metres.

BRUCE ALMIGHTY (A Forbes) was unable to obtain clear running until near the 100 metres.

**HIGH COUNTRY** had difficulty obtaining clear running in the final straight.

**TE KINGI** was unable to obtain clear running over the final 250 metres.

A post-race veterinary examination of **ABSTAIN** (N Harris) did not reveal any abnormalities.

### Race 2 Leila MacDonald 1200

Apprentice E Leighton was unable to make the required weight for **RUSTY DEVIL** being replaced by Apprentice A Taylor. E Leighton was fined \$200.

GINJA NINJA (M Du Plessis) and RUSTY DEVIL (A Taylor) were slow away.

**TE TORO LASS** (M Sweeney) was crowded shortly after the start between **TIME LEGEND** (S Shirahama) which was laying out and **SHUKA** (D Johnson).

**RUSTY DEVIL** raced wide without cover throughout.

**GINJA NINJA, HAPPYTO KEEPA** (R Norvall) and **TRAPICHE** (O Bosson) were all badly crowded passing the 150 metres with **HAPPYTO KEEPA** and **GINJA NINJA** both having to be severely checked. C Dell admitted a charge of careless riding in that he permitted his mount **DEMOPHON** to shift outwards passing the 150 metres when not sufficiently clear crowding **GINJA NINJA** and **HAPPYTO KEEPA**. C Dell was suspended by the Judicial Committee from the conclusion of racing on Wednesday 3 October 2012 until the conclusion of racing on Thursday 11 October 2012, 6 riding days.

S Shirahama was suspended from the conclusion of racing on Friday 5 October 2012 until the conclusion of racing on Thursday 11 October 2012, 4 riding days, after admitting a charge of careless riding in that he permitted his mount **TIME LEGEND** to shift inwards approaching the 100 metres when not sufficiently clear crowding **TRAPICHE** on to **HAPPYTO KEEPA**. In assessing penalty the Judicial Committee took into account S Shirahama's excellent riding record. FARAWAY EYES (A Collett) shifted outwards to obtain clear running near the 100 metres and bumped with **SHUKA** which was shifting in .

D Johnson admitted a charge of careless riding in that she permitted her mount **SHUKA** to shift inwards over the concluding stages when not sufficiently clear crowding **FARAWAY EYES** (A Collett) on to **CIVICS ROCK** (L Innes) and **TIME LEGEND** which were all severely checked. D Johnson was suspended from the conclusion of racing on Saturday 6 October 2012 until the conclusion of racing on Thursday 18 October 2012, 6 riding days.

**DEMOPHON** lost the right hind plate during the running.

## Race 3 Ray White Real Estate 2100

ZER EBENY (A Taylor) was slow away.

YOU'LL KEEP (C Dell) began awkwardly.

**MAHARISHI** (L Isherwood) raced wide around the first turn before improving forward to lead near the 1100 metres. **BUCKLES** (N Harris) was held up behind the weakening **MAHARISHI** entering the final straight.

O Bosson was suspended from the conclusion of racing on Saturday 6 October 2012 until the conclusion of racing on Saturday 13 October 2012, 4 riding days, after admitting a charge of careless riding in that he permitted his mount **KING DAN** to shift outwards near the 200 metres forcing **BUCKLES** outwards crowding **TAATS** (R Hutchings) on to **COUNT ISTI** (T

Thornton) and STRENUA (L Innes) with COUNT ISTI being checked.

Race 4 Remuera Fisheries Mitchelson Cup

MAWAH VELLOUS (M Du Plessis) and PLAN EX (C Grylls) were both slow to begin.

ACE HIGH (K Kalychurun) jumped away awkwardly.

Going into the first turn near the 1800 metres **INDIKATOR** (C Dell) had to be steadied when crowded for room by **LITTLE ALFIE BROWN** which was taken in by **JOHN GRAY** (T Thornton). T Thornton was issued with a warning.

LITTLE ALFIE BROWN (L Satherley) raced three wide without cover throughout.

**INTRANSIGENT** (C Parish) had some difficulty obtaining clear running early in the final straight.

PLAN EX had difficulty obtaining clear running until near the 100 metres.

## Race 5 Macleans Soliloquy Stakes

TWILIGHT GRANITA (J Waddell) was slow to begin.

**HOLLYWOOD ANGEL** (M Du Plessis) and **PERFECT START** (S Shirahama) both began awkwardly and came together with **HOLLYWOOD ANGEL** losing ground.

**DECORAH** (S Spratt) had to be steadied to avoid the heels of **ELYSIUM** (M Coleman) which shifted in going into the bend near the 1100 metres. When being steadied **DECORAH** shifted in crowding **TWILIGHT GRANITA**. M Coleman was issued with a warning.

Passing the 1000 metres **KISSES** (T Thornton) which was racing keenly got its head up when awkwardly placed inside the heels of **KELLY O'REILLY** (V Colgan) and shifted in slightly crowding **MARMI** (M Cameron). **KISSES** continued to over-race through the middle stages.

**ELYSIUM** and **TWILIGHT GRANITA** over-raced through the middle stages with both runners having to be restrained off heels on several occasions.

RAY'S GIRL (D Walker) shifted out under pressure over the final 100 metres.

Race 6

CAPTAIN CAT (O Bosson) began awkwardly.

HARLEQUIN (A Collett) was slow to begin.

**HAVE NO MERCY** (S Shirahama) knuckled when jumping away.

GEORGEY AEROPLANE (L Innes) bumped with RANSOMS GOLD (C Grylls) when leaving the barriers.

**TAKEOVER** (N Collett) raced three wide without cover throughout.

**CAPTAIN CAT** over-raced in the middle stages when the pace steadied.

STELLAS GOLD (D Johnson) was held up over the final 100 metres.

Race 7

**Manuka Doctor Bonecrusher Stakes** 

KING ZEUS (O Bosson) lost its footing at the start and was slow away.

MACKA'S BACK began awkwardly with Rider V Colgan losing the use of his right stirrup iron for a short distance.

**REMINISCING** (M Coleman) had to be steadied shortly after the start due to movement from runners to either side.

**NEO** (A Calder) raced three wide without cover.

MACKA'S BACK over-raced in the lead through the middle stages.

**WARHORSE** (M Cameron) shifted out near the 300 metres inconveniencing **ZINKO** (A Collett). M Cameron was advised to exercise more care. **ZINKO** then made contact with **KING ZEUS** on several occasions unbalancing both runners. A Collett was issued with a warning.

L Innes defended a charge of careless riding in that he permitted his mount **SWIPER THE FOX** to shift inwards when not sufficiently clear of **MACKA'S BACK** which was checked near the 100 metres. After considering all evidence the Judicial Committee found the charge to be proven with L Innes being suspended from the conclusion of racing on Saturday 6 October until the conclusion of racing on Monday 15 October, 6 riding days.

Race 8 Life Education Ambassador Terenzo Bozzone 1200

TRENDY (A Calder) began awkwardly.

FIELDOFDREAMS (S Spratt) shifted out at the start hampering MASTER ZENNO (N Harris).

HE'S ROCK'N'ROLL (M Du Plessis) made contact with CAIPIRINHA (D Johnson) leaving the barriers.

**EIGHTLIVES** (O Bosson) began awkwardly and lay out crowding **LEONUCASAM** (M Cheung) on to **OHOPE PRINCE** (M Sweeney).

WINE'NSODA (N Collett) began awkwardly.

MOSSE (J Waddell) and CAIPIRINHA were both crowded shortly after the start.

MOSSE, OHOPE PRINCE and CAIPIRINHA all raced ungenerously going into the first turn near the 1000 metres.

KAHALA (C Grylls) raced three wide without cover.

**NOTHING** (L Innes) was unable to obtain clear running in the final straight.

**EIGHTLIVES** had difficulty obtaining clear running in the straight when laying out.

**WINE'NSODA** was not persevered with in the straight finishing a distant last. A post-race veterinary examination found the mare to be mildly lame behind.

**NEW MOON** (J Jago) raced wide without cover throughout.

**FREE SERVE** (K Kalychurun) ran wide around the final turn. K Kalychurun was advised that he must show better judgement in future.
