#### RACE COMMENTS:

Race 1 Race Images 1200

RED LAMAR (M Cheung) lost its footing when jumping away unbalancing its rider and losing several lengths.

**CAPISTRANO MAGIC** (M Cameron) made the bend near the 900 metres awkwardly, getting its head up when being steadied and losing ground.

GARDEN OF EDEN (K Joyce) raced three wide without cover from the 800 metres.

**WATCH KING** (B Hutton) over-raced in the lead through the middle stages when racing well away from the running rail. Apprentice Hutton was shown a video footage in the presence of his employer and advised that he must show better judgment in future.

J Waddell admitted a charge of careless riding in that he angled his mount **SPITTING IMAGE** outwards near the 300 metres when insufficiently clear of **ROMAN CAVALRY** (L Innes) which was checked. After hearing submissions the Judicial Committee suspended J Waddell's license to ride in races from the conclusion of racing on Saturday 17 November 2012 until the conclusion of racing on Friday 23 November 2012, 4 riding days.

#### Race 2 West Brook Winery 1200

BEL AMI (S Collett) jumped away awkwardly losing ground.

**BEL AMI** was inclined to race greenly when wide without cover throughout.

**CRUSH THE CASTLE** (L Innes) jumped a dark strip of grass near the 1000 metres.

LEANA ME (M Sweeney) ducked outwards abruptly when struck with the whip near the 250 metres.

SMART ODDS (J Whiteside) was unable to obtain clear running over the final 200 metres.

**LEANA ME** lost the left front plate during the running.

Race 3 Morgan Furniture 1200

A Forbes replaced R Hutchings on **RIVER MOY** due to a miscommunication.

MISS ZETA (M Wenn) was a shade slow to begin.

K Myers was suspended from the conclusion of racing on Thursday 22 November 2012 until the conclusion of racing on Monday 26 November 2012, 4 riding days, after admitting a charge of careless riding in that she allowed her mount **CASUAL FLING** to shift in near the 1100 metres when not sufficiently clear of **THXALOT** (C Dell) which struck a heel and blundered.

**VELOCITY** (S Spratt) raced three wide without cover throughout.

**GIRLS DAY OUT** (S Collett) had to be steadied near the 1000 metres when crowded for room by **FANTASTIC TIMES** (P Taylor) which was taken in slightly by **DANDYLIGN** (M Cameron) which lay in away from **VELOCITY**. **VELOCITY** then jumped a dark strip of grass on the track.

Near the 900 metres **GIRLS DAY OUT** got its head up when being steadied dropping back on to **THXALOT** which was hampered.

**VELOCITY** lay out rounding the final turn and was hampered when weakening near the 350 metres by **POSY** (L Innes) which was taken out by **BRAHMA QUEEN** (D Johnson) which shifted out off the heels of **HARDTALUVA** (V Colgan) when racing greenly. Also hampered having to steady and shift out off the heels of **VELOCITY** was **DEFIANT ROSE** (M Tanaka).

## Race 4 Brighter Carpets 1400

Trainer R Collett was fined \$50 for the late declaration of rider for LUCY BEE.

ALSUKARI (D Johnson) was slow away.

**PENTAROSE** (A Calder) began awkwardly.

**DANNY THE IMP** (M McNab) had to be steadied off the heels of **CORNELIUS** (D Nolan) near the 1200 metres when that runner shifted in. D Nolan was advised to exercise more care. **NORDIC KNIGHT** (S Spratt) then shifted in away from **CORNELIUS** crowding **CATALAN KING** (M Cameron) which was taken into the line of **KIDWELLY** (J Waddell) which had to be steadied losing ground. **NORDIC KNIGHT** continued to shift away from **CORNELIUS** further crowding **CATALAN KING** which made contact with **WESTBROOK** (V Colgan).

**RISING FORCE** (L Innes) had to be steadied off the heels of **DOMINEER** (M Coleman) which shifted in near the 1000 metres. **ALSUKARI** got its head up when over-racing going into the bend near the 900 metres.

**RISING FORCE** was inclined to lay out under pressure in the final straight.

#### Race 5 Waitakere United Supporters 2200

STEEL (J Oliver) over-raced in the lead in the early to middle stages.

**WEST END** (M Sweeney) shifted in under pressure crowding **SEAMS LIKE MAGIC** (R Hutchings) on to **SIR REIMS** (D Johnson) passing the 200 metres.

#### Race 6 Charlie Farley's Restaurant Waiheke 1200

**DRAGONKEEPER** was a late scratching on veterinary advice at 9.30am.

MANGAROA MINI (M Cameron) blundered on jumping losing several lengths.

MARANELLO (D Johnson) was slow away.

**BLUE STREAK** (K Myers) shifted in when being steadled near the 1000 metres crowding **COPS 'N' COYOTE** (K Leung) on to **ERNESTO** (L Innes).

Passing the 1000 metres when being steadied the saddle shifted forward on **LOVETOHAVEIT** disadvantaging Apprentice J Castano for the remainder of the race. **CHARLIE FARLEY** over-raced in the middle stages getting its head up when being steadied approaching the 800 metres and shifting out across the heels of **CAPTAIN SCOTT** hampering **COPS 'N' COYOTE** and **MARANELLO** which were both forced wider on the track.

PACHENKO (M Wenn) raced three wide without cover throughout.

**CHARLIE FARLEY** (C Dell) and **COPS 'N' COYOTE** raced wide around the bend with **CHARLIE FARLEY** being crowded between runners near the 500 metres when **BLUE STREAK** was taken out slightly by **CAPTAIN SCOTT** (V Colgan) making contact with the hind quarters of **COPS 'N' COYOTE** which was unbalanced.

**PINZAARA** (S Spratt) lay out around the turn and continued to lay out under pressure in the final straight inconveniencing **KHISDAR** (A Calder) near the 250 metres.

### Race 7 Boyle Mathieson 1400

**DAKARAI** (J Whiteside) which had been fractious in the barriers began awkwardly losing several lengths.

PICO ALTO (A Calder) lost its footing on jumping and was slow away.

**OKCORAL** (L Innes) raced wide without cover throughout.

**DIAMONDS IN TIME** (A Forbes) commenced to over-race near the 1000 metres when the pace eased with **DIAMONDS IN TIME** shifting out to avoid the heels of **SAFFRON** (S Spratt). **HABIBI** (M Cameron) then became awkwardly placed on the heels of **DIAMONDS IN TIME** striking a heel of that runner near the 950 metres. Also over-racing at that point were **PICO ALTO, SKAI GLOW** (S Shirahama), **DAKARAI** and **BON GENIE** (V Colgan). J Waddell and S Spratt, the respective riders of **CALYPSO** and **SAFFRON** which were sharing the lead at that stage of the race were both advised that in future they must not ease the pace to a degree which puts other riders in difficulty.

**REGALIA** (R Hutchings) was held up early in the final straight making contact with **DIAMONDS IN TIME** when improving into a tight run near the 300 metres.

**CALYPSO** lay out under pressure over the final 250 metres.

R Hutchings (REGALIA) dropped his whip near the 150 metres.
