RACE COMMENTS:

Race 1	LASER ELECTRICAL TIMARU MAIDEN 1600m
<p>FALENA jumped awkwardly, shifted inwards and bumped HYDRAULIC which became unbalanced and shifted in abruptly. HYDRAULIC then tailed the field throughout and was restrained in the straight finishing a distant last. Jockey K Williams</p>	

stated the horse felt awkward throughout and never stretched out. A post-race veterinary examination revealed no abnormalities.

LILITH FAIR raced wide rounding the first turn near the 1300 metres.

HALO MAY hung out rounding the first turn.

ARE YOU MINE hung outwards throughout and raced wide from the 800 metres. A post-race veterinary examination revealed no abnormalities. Trainer S Hewitt was advised a warning would be placed against the mare's racing manners. L Callaway (**JIMMY THE ONE**) reported he was concerned with his mount's action throughout the race. A post-race veterinary examination revealed no abnormalities.

DUNROAMIN hung outwards in the straight proving difficult to ride and shifted outwards near the 350 metres carrying **FALENA** out onto **HALO MAY**.

Rounding the home turn **ATAAHUA DREAMIN** was held up for clear racing room. When questioned in regard to his ride in the early stages of the straight jockey C Johnson (**ATAAHUA DREAMIN**) explained that his horse was reluctant to race amongst horses in the early stages and shortly after straightening when a run appeared before him, the gelding proved hesitant to take the opening. Jockey Johnson was advised he would be expected to make a greater effort to encourage his mounts in similar circumstances.

GERVASIO which made the home turn wide shifted inwards when placed under pressure in the straight.

In the straight **SERAPHIM FALLS** hung inwards and proved difficult to ride.

Race 2 OPIHI VINEYARD & PORT FM MAIDEN 1200m

AKEISHA QUEEN and **REALLY RUSTY** jumped awkwardly.

FINTORRO jumped inwards at the start and made heavy contact with **MOUSE POINT** which shifted inwards onto **AKEISHA QUEEN**. As a result **MISS GOLDY NORRISS** which was racing to the inside of **AKEISHA QUEEN** was crowded for room and lost ground. **MISS GOLDY NORRISS** then shifted outwards and carried **MOUSE POINT** out onto the heels of **FINTORRO** resulting in **MOUSE POINT** clipping the heels of **FINTORRO**, blunder and lose ground.

AKEISHA QUEEN raced wide rounding the bend.

OWE THE RANSOM had difficulty obtaining a clear run for the majority of the home straight and went to the line not fully tested.

SINGAPORE GIRL raced wide rounding the home turn.

A Request for a Ruling was lodged with the JCA under Rule 647(1) to disqualify **TRUTH**, which placed 4th, after it was alleged it's jockey R Hannam failed to weigh in. After hearing the evidence, the JCA were satisfied that R Hannam failed to weigh in and disqualified **TRUTH** from 4th placing. The placings were amended as follows; **FINTORRO** 1st, **MEDIADOR** 2nd, **PENNY FROM HEAVEN** 3rd and **OWE THE RANSOM** 4th.

At a subsequent enquiry Jockey R Hannam admitted an associated charge under Rule 647(1) and the JCA imposed a fine of \$500 and ordered his riding fee be forfeited under Rule 331(2) to the owners of **TRUTH**.

Race 3 CENTRAL SI OWNERS & TRAINERS MAIDEN 1200m

PRINCE EDEN and **INDIVIDUAL** bumped on jumping as did **TE NAMU** and **BALTIC**.

Passing the 1100 metres **SEVEN ON BROADWAY** was steadied to avoid the heels of **SPARKS FLY** which shifted inwards when not quite clear. Jockey K Williams was shown the film and advised to exercise more care in future.

Approaching the 1000 metres **INDIVIDUAL** which was racing in restricted room shifted outwards slightly and bumped **SEVEN ON BROADWAY** which became awkwardly placed close to the heels of **WINCHESTER**.

ALFIE RIVER and **THE GOVERNATOR** raced wide throughout.

INDIVIDUAL and **TE NAMU** had difficulty obtaining complete clear running for the majority of the home straight.

Near the 100 metres **ALFIE RIVER** and **TE NAMU** were crowded for room between **SEVEN ON BROADWAY** (L Callaway) which shifted inwards and **INDIVIDUAL** (C Barnes) which shifted outwards. As a result **TE NAMU** was severely checked and lost ground. Jockey Callaway and apprentice Barnes were both issued with a warning and advised they must make a greater effort in future.

Approaching the 50 metres **PERSIA** was steadied when awkwardly placed close to the heels of **ADDITUP** which shifted in slightly.

Race 4 ANNE GLENDINING & CRT REAL ESTATE RATING 75 DASH 1200m

NATKINGCOLE jumped awkwardly, bumped heavily with the side of the barriers resulting in its rider apprentice T Direen becoming unbalanced and being dislodged shortly after.

Shortly after the start **BACIO FRANCESE** which was being steadied got its head up.

Approaching the first turn near the 1000 metres **KATIE JAY** and **NEVER DIE** were both crowded for room to the inside of the rider-less **NATKINGCOLE** which shifted inwards abruptly.

Miss Direen was attended to by the Club's medical officers and passed fit to fulfill her remaining riding engagements.

After the race rider L Allpress reported that **BACIO FRANCESE** suffered a laceration to the off hind leg. The mare was examined by the Club's Vet who reported treatment was required. Trainer J Parsons was advised a veterinary clearance

would be required before **BACIO FRANCESE** races again.

Race 5 | **COUPLAND'S BAKERIES TIMARU CUP (LISTED) 1600m**

On jumping **ZIVA** was buffeted between **EL CHICO** and **GO GO DINGO**.

ESSENTIAL which was restrained shortly after the start, obtained a position at the tail of the field and then raced keenly in the early and middle stages

ZIVA and **EL CHICO** raced wide rounding the first bend near the 1300 metres.

Passing the 1100 metres **KEEP THE CONFLICT** raced in restricted room to the inside of **EL CHICO** and came into contact with that horse on a couple of occasions.

CHAPARELLA raced wide without cover for the majority of the race.

CAPTAIN TODD and **FLASH HAPI** raced wide rounding the home turn.

FAXED race wide rounding the home turn and in the straight.

Near the 300 metres **EL CHICO** had to be checked when its rider, L Allpress attempted to improve into a narrow run which briefly presented itself between the weakening **ZIVA** and **KEEP THE CONFLICT**, both of which shifted slightly.

Approaching the 250 metres **ZIVA** which was weakening quickly was crowded for room and had to be checked.

Shortly after the 200 metres **KEEP THE CONFLICT** and **EL CHICO** bumped.

When questioned in regard to the performance of **ZIVA** jockey R Hannam explained that the horse raced forward as instructed however commenced to weaken quickly shortly after straightening and proved disappointing. He added that he had some concerns with the mare's breathing after the race and advised the trainer accordingly. A post-race veterinary examination of **ZIVA** revealed no abnormalities and the mare was sent to be swabbed.

Race 6 | **LJ HOOKER GROUP SUE & NOEL WALKER RATING 75 MILE 1600m**

PEARL DANCER and **OXBOROUGH MAGIC** bumped on jumping.

Rounding the turn near the 1300 metres **SLICK NICKEL** which was racing keenly got its head up when being restrained.

ALUMINIUM BIKERACK and **UMSHINI WAMI** raced wide rounding the home turn.

In the straight **ASK MY WIFE** hung in.

In the straight **STANICA STAR** hung inwards and proved difficult to ride.

PEARL DANCER had difficulty obtaining clear running for the majority of the home straight and went to the line without being fully tested.

Race 7 | **D'CASH RATING 65 1600m**

Trainer C Spittles was fined \$100 under Rule 616(3) for presenting **BARBARA JENNIE** to race in gear which had not been notified.

When the start was effected the front barrier gate of **KETCHME** was slow to release however the mare was not affected and jumped with the field.

SEASPRITE was slow to begin.

Shortly after the start **SOVEREIGN ROSE** and **KETCHME** were buffeted between **BARBARA JENNIE** and **SHE'S ASSERTIVE** which jumped awkwardly and shifted in. As a result **KETCHME** bumped **BARBARA JENNIE**, which became unbalanced and lost ground.

MISS KATE and **FLY MY PRETTY** raced keenly in the early stages.

Passing the 50 metres **SOVEREIGN ROSE** had to be checked when crowded between **MISS KATE** and **KETCHME** (A Mundy) which shifted inwards when placed under pressure. Miss Mundy was shown a replay and issued with a warning.

Approaching the winning post **MISS KATE** had to be steadied to avoid the heels of **SHE'S ASSERTIVE** (A Frye) which shifted outwards under pressure. Apprentice A Frye in the presence of her employer D Frye was spoken to and advised to show more care in future.

Race 8 | **MARTIN WAKEFIELD RATING 65 SPRINT 1200m**

GOD SEND underwent a pre-race veterinary examination after dislodging jockey J Bullard in the preliminary and was cleared to start. J Bullard was unharmed in this incident. **GOD SEND** required the attention of the farrier which caused a significant delay to the start.

ALTHELEAVESRBROWNE was slow to begin.

GOLD TERROR jumped awkwardly.

On jumping **GOD SEND** shifted out and bumped **BEE JEAN**.

MARIA PREDADI and **PLEASE RELEASE ME** bumped at the start.

Rounding the first turn near the 950 metres **FULLAVINO** hung out and had to be steadied when awkwardly placed close to the heels of **GOD SEND**.

When questioned regarding the performance of **ROYAL HU** apprentice R Doherty explained that he was instructed to ride the gelding just behind the leaders however his mount failed to travel throughout and when placed under pressure in the straight proved disappointing. Mr Doherty said the only excuse he could offer for the disappointing performance of **ROYAL**

HU was that it may not have handled the weight allotted to the gelding.

Jockey J Bullard the rider of **GOD SEND** reported that his mount hung out throughout and in his opinion was distressed. A post-race veterinary examination of the gelding revealed no abnormalities.

Race 9

TRADEZONE ENGINEERING SUPPLIES RATING 85 STAYERS 2100m

The start of this event was put back five minutes by the TAB due to the previous race running late.

Shortly after passing the winning post on the first occasion **ELEANOR COUP** had to be checked when crowded by **CRYSTAL DUKE** (A Frye) which shifted inwards momentarily. Apprentice A Frye was shown a replay of the incident and issued with a warning.

CONFUSED raced wide without cover for the majority of the race.
