An inquiry adjourned from Racing Rotorua, Monday 7 January, was resumed today with L Cribbin the rider of **GORDYFROMGREATBARR** admitting a breach of Rule 636(1)(b) in that he failed to take all reasonable and permissible measures to maintain contact with the remainder of the field from leaving the barriers until near the 900 metres. After consideration the Judicial Committee suspended L Cribbin from the conclusion of racing today, Friday 11 January, until the conclusion of racing on Monday 11 February 2013, one month.

RACE COMMENTS:

Race 1 AZTECH SIGNS TAURANGA '1300'

The track was upgraded to Good(3) at 11.50 am prior to the 1st race.

MERCUTIO (C Grylls) and ANAHEIM (S Spratt) both jumped away awkwardly.

BAGSAGOLD (M McNab) was slow to begin and then was further hampered when **OUR FOXY LADY** (M Cameron) shifted in on jumping away.

BAGSAGOLD commenced to over-race shortly after the start and got its head up making the turn near the 900 metres awkwardly running wide. **BAGSAGOLD** continued to race ungenerously through the middle stages. Trainer J Pender was advised that a warning would be placed against the gelding for its racing manners with Mr Pender indicating he would give consideration to making gear changes for its next start.

OUR FOXY LADY lay in under pressure in the final straight.

Race 2	TAURANGA RIDING FOR THE DISABLED '1400'

LUCKY SPIRIT (C Grylls) jumped away awkwardly.

STIRLING BRIDGE (P Turner) was slow to begin.

STIRLING BRIDGE raced ungenerously through the middle stages.

Going into the bend near the 900 metres **CLARA JANE** (A Calder) raced ungenerously when being steadied getting its head up and shifting out across the heels of **STIRLING BRIDGE** losing ground. A Calder advised that the filly had been inclined to race a little greenly in its race day debut.

LUCKY SPIRIT made the 900 metre turn awkwardly when racing keenly getting its head up.

STIRLING BRIDGE was held up for a short distance rounding the turn near the 500 metres.

SUPER THUNDER (S Collett) raced wide without cover throughout.

STIRLING BRIDGE was held up near the 250 metres having to shift out across the heels of **LARGE AS LIFE** (K Myers) to obtain clear running passing the 200 metres.

CLARA JANE lost the right front plate during the running.

Race 3 118TH TAURANGA A&P SHOW – SAT 19 JAN '2100'

NATASSJA KINSKI (S Shirahama) and LUV TO SEA (M Wenn) were both slow away.

LA COLINETTA (S Spratt) over-raced in the early stages.

NATASSJA KINSKI commenced to over-race when the pace eased near the 1600 metres, and continued to do so for a distance.

LINE UP LIONEL (O Bosson) hung outwards around the final bend inconveniencing SON OF CIVICS (J Jago) near the 700 metres.

NATASSJA KINSKI was held up rounding the final turn.

When questioned regarding the performance of **BEVERLEY BECK** rider C Grylls advised that the gelding had been quickly beaten once placed under pressure near the 600 metres and could offer no excuses. A post-race veterinary examination did not reveal any abnormalities.

Race 4 THE NEW RADIO HAURAKI WITH MARTIN DEVLIN FOR BREAKFAST '1600'

KAAP'S PRINCESS (S Collett) was very slow to begin losing several lengths. Trainer K McQuade was advised that the barrier warning on the filly would be maintained, with Mrs McQuade advising that they would be removing the blinkers from **KAAP'S PRINCESS** in an attempt to rectify the problem.

WINE'NSODA (S Spratt) over-raced in the early and middle stages.

DIVINE SPICE (M Cameron) raced wide without cover from the 900 metres.

PAY ATTENTION (R Hutchings) blundered near the 200 metres making solid contact with the running rail and losing all chance being eased down by its rider.

OLIVIA ANN (D Johnson) was crowded between **SATEKA** (S Shirahama) and **DIVINE SPICE** when both those runners shifted ground passing the 150 metres.

When questioned regarding the performance of **MANAIA ROSE** rider O Bosson advised that the mare had felt to have jarred up on the firm footing. Trainer J Pender advised he would now be sending **MANAIA ROSE** for a spell.

Race 5 GEAR WELDING SERVICES TAURANGA '1600'

ISTILANE (D Johnson), WAINUI PRINCE (K Myers) and KEEP ROCKING (C Lammas) were all slow to begin.

THE MIG (R Norvall) and **WAINUI PRINCE** commenced to over-race near the 1200 metres with **THE MIG** getting its head up and racing ungenerously when being restrained for a distance.

OHOPE PRINCE (O Bosson) raced three wide without cover throughout.

Race 6 LASER PLUMBING TE PUKE '1300'

RE DEEL (B Hutton) was slow away.

RE DEEL lay in making contact with the running rail near the 1100 metres.

APACHE SKY (S Collett) over-raced when being restrained going into the bend near the 900 metres.

ROMAN TOIA (B R Jones) was held up early in the final straight, and when shifting out into a tight run between **JUNGLE JOY** (M Wenn) and **ALVESTA** (M Coleman), made contact with **ALVESTA** approaching the 200 metres.

Race 7 CROCKFORD REAL ESTATE '1300'

KODEMA (O Bosson) shifted inwards jumping away crowding SNIPPECHEE (L Satherley) which lost ground.

KODEMA raced wide without cover throughout.

LADY MARILYN (M Dravitzki) over-raced in the middle stages, and was held up rounding the final turn.

AURORA LIGHTS (J Waddell) shifted out passing the 400 metres inconveniencing SNIPPECHEE.

MATIMBA (D Johnson) lay out under pressure in the final straight shifting into the line of **KAPSBOY** (J Jago) near the 250 metres with as a result **KODEMA** shifting out off the heels of **KAPSBOY** making contact with **AURORA LIGHTS** which shifted out hampering **SNIPPECHEE**.

SPRINGLOADED (S Collett) lay in under pressure in the final straight.

Race 8 SPEIGHT'S '1600'

J Waddell was unable to make the weight for **REVOLUTIONARY** being replaced by A Calder. J Waddell was fined \$225 by the Judicial Committee.

PINDALU (S Shirahama) stumbled on jumping away shifting out and inconveniencing SAN ALESSANDRO (M Coleman).

CARDON BOY (R Norvall) and **REVOLUTIONARY** (A Calder) came together on jumping away, with **CARDON BOY** then having to be steadied shortly after the start when crowded between runners.

JOHNNY BRAVO (D Johnson) which was slow away was further hampered shortly after by **MIDNITE RENDEZVOUS** (C Lammas) which shifted in when being steadied to avoid the heels of **SKYFALL** (R Hutchings) which shifted in when not fully clear. R Hutchings was advised to exercise more care.

CARDON BOY commenced to over-race passing the 1200 metres, and continued to do so through the middle stages having to be firmly restrained off heels for a considerable distance.

SERPENT (O Bosson) was held up entering the final straight near the 350 metres.

MIDNITE RENDEZVOUS was held up until near the 200 metres.

RESUME (B R Jones) raced wide without cover throughout.
