RACE COMMENTS:

Race 1 AMCOR KIWI PACKAGING SPRINT

LIGHTNING LUCY jumped in the air at the start and was further hampered when crowded between runners.

TAOIST MASTER got its head up when being restrained when passing the 1000 metres and continued to over race through the middle stages.

Race 2 TOTAL WORLDFRESH 1200

Several runners anticipated the start prior to the gates opening with **TANSAVA**, **SERGEANT LINCOLN** and **PRETTY PLEASE** being slow away.

'ER INDOORS raced three wide throughout.

ALICIA made the bend near the 900 metres awkwardly.

XIBIT had some difficulty obtaining clear running early in the final straight when inclined to lay in.

Race 3 AWESUM ORGANICS 2200

TARTAN RED was slow away.

KEY TO DANCE began awkwardly making contact with LADY LINCOLN.

HIGH PRAISE was held up behind the weakening **COLJOY** passing the 800 metres and was again held up behind **MY MAGICIAN** passing the 600 metres.

When questioned into the run of LADY LINCOLN, rider K Myers advised that after getting well back in the early and middle stages, she opted to improve her mount wide rounding the final turn but the mare had little left over the final stages. When questioned into run of TARTAN RED which finished well back, rider R Myers had no excuse for the mare's poor run. When questioned into the run of **COLIOY**, which gave ground rapidly passing the 800 metres, rider L Allpress considered something amiss and eased the gelding down in the home straight failing to finish. A subsequent veterinary inspection revealed the gelding to be suffering from cardiac arrhythmia. Connections were advised that **COLIOY** will be required to trial and pass a veterinary examination, including the results of an ECG prior to its next start.

Race 4 JM BOSTOCK LTD 2000

HERMOSA NOVIA began awkwardly.

VIA VENETO raced keenly throughout, when in front.

Race 5 WAIMEA NURSERIES 1400

PADDY JO was kicked en route to the start. After undergoing a veterinary examination the gelding was cleared to start. **MENDOZA** was slow away.

GRENADE and **ARMANI CODE** began awkwardly.

BAT PAD over raced in the middle stages.

PADDY JO raced three wide without cover.

GRENADE was held up and unable to improve early in the home straight and could not be ridden out fully over the final stages when in restricted room.

M Dee, the rider of **BAT PAD**, was advised to exercise care when riding with vigour after he allowed his mount to shift in over the final stages, hampering **ARMANI CODE** near the finish.

Race 6 KOLLA 1600

PESCATORE was very slow to begin. Following the race a request for a ruling was filed with the judicial committee under the provisions of Rule 632 as to whether **PESCATORE** had been denied a fair start due to a barrier attendant having hold of the horse when the gates opened. After viewing video footage and hearing submissions the judicial committee determined that **PESCATORE** be declared a non-starter with all bets on that horse to be refunded.

SAINT KITT shifted out under pressure over the final stages.

When questioned into the run of SANIANI, which finished last, rider R Myers considered the mare to have jarred up.

SANIANI underwent a post-race veterinary inspection, which failed to reveal any abnormality.

Race 7 DMP METRIC MILE

J Riddell defended a charge of careless riding in that he permitted his mount **SAINT MARTINS** to shift inwards when not sufficiently clear of **THE TOOTHFAIRY** (M Wenn), which was checked near the 1400 metres. After hearing submissions the judicial committee found the charge to be proven and J Riddell was suspended from the conclusion of racing of Wednesday, 6 February 2013 until the conclusion of racing on Wednesday, 13 February 2013 (5 days).

SAINT MARTINS was held up early in the final straight

When questioned into the run of **FLORAL SCENT**, rider L Allpress said that the mare was feeling the effects of the firm ground.

Race 8 PROFRUIT NZ FILLIES & MARES 1400

PICCADILLY was slow away.

OUR JESSE JANE began awkwardly, hampering **TULLUMAYO**. **OUR JESSE JANE** then raced ungenerously in the early stages and attempted to buck. Connections of **OUR JESSE JANE** were advised that a warning will be placed against the filly with regard to its racing manners.

MACKENZIE raced wide early.

Near the 1200 metres **TULLUMAYO** hung inwards and away from **HOOFSAIN BOLT** and in doing so hampered **PICCADILLY** and **ALLEZ ROSE.**

Rider L Allpress reported that **HOOFSAIN BOLT**, would appreciate any easing in the ground.
