RACE COMMENTS:

Race 1	ELDERS LIMITED/WAIROA CLUB STAYERS
NO CHANGE (B Lammas) began awkwardly then shifted into the line of ROME (M Dee) which got back at the start. HANAMICHI(D Bradley) was slow away. HANAMACHI was eased near the winning post on the first occasion. NO CHANGE(B Lammas) raced wide in the early stages prior to gaining cover upon entering the back straight. NO CHANGE	

<p>was then obliged to make its run three wide rounding the home turn. GOOGLE ME(D Walsh) raced three-wide without cover throughout. Connections of the 3rd placed GREY GURU(T Russell) viewed video coverage of the final stages but elected not to proceed with an objection after the second placed HANAMICHI(D Bradley) shifted into the line of GREY GURU, which resulted in GREY GURU shifting ground outwards to improve. D Bradley was advised to exercise care when shifting ground.</p>	
Race 2	VISTA MOTOR LODGE/SILVER FERN FARMS DASH
<p>M McNab was unable to attend the meeting due to injury. INTERCITY GIRL was led by the Clerk of the Course from the enclosure to the 1200m start rider-less which is not permitted. After being returned to the birdcage by order of the Stewards, the filly was mounted but would not proceed to the start then dislodged Apprentice jockey D Turner who was injured. INTERCITY GIRL was subsequently declared a late scratching. Connections were advised that INTERCITY GIRL must trial prior to its next start. WILLING SPIRIT (B Grylls) was kicked prior to the start and as a result was a late scratching on Veterinary Advice. AMBITIOUS PRINCE(C Lammas) and COTERIE(D Walsh) were kicked prior to the start and after undergoing a Veterinary inspection were both cleared to start. AMBITIOUS PRINCE was slow to begin. LA SOMMELIRE(R Myers) raced keenly in the early stages when wide. AMBITIOUS PRINCE made the first bend awkwardly near the 800 metres. PARVATI(R Hutchings) raced ungenerously rounding the turn and got its head in the air for some distance.</p>	
Race 3	WAIKARE HOTEL DASH
<p>L Callaway was unable to attend the meeting due to injury. AGENT EIGHTY SIX(C Dell) shifted out abruptly on leaving the barriers hampering BROADWALK(H Tinsley) which lost ground. AGENT EIGHTY SIX raced keenly in the early stages. Rider C Dell reported that his mount AGENT EIGHTY SIX raced greenly throughout. When questioned into the performance of FRANKIE VAN HATT, rider M Hills was of the opinion the gelding was feeling the effects of the firm track surface.</p>	
Race 4	WAIROA BUSINESS SUPPORTERS SPRINT
<p>CHERYL MOANA MARIE reared in the barrier and dislodged rider C Lammas who sustained a suspected leg fracture and was transported to Hospital. CHERYL MOANA MARIE was declared a late scratching and connections were advised the mare has to trial prior to its next start. BIJOUX(J Oliver) and GIJIMA(D Miller) were slow away. PEIT ROX(H Tinsley) raced three wide until near the 800 metres. POST ONLINE(T Thornton) and GIJIMA bumped near the 800m after POST ONLINE hung inward. Also affected was KING PICCOLO which had to steady. ON THE HILL(T Russell) had to steady off the heels of POST ONLINE near the 700 metres. CHEVREMONT(S Collett) was held up early in the home straight. D Walsh (TIMETODANCE) was questioned regarding his lack of vigour over the final stages. D Walsh advised that he considered positions were becoming tight after OUR DELIGHT(V Johnson) commenced to shift inward near the finish so he elected to ease his mount. D Walsh added that his mount raced greenly and was inclined to shift away from other runners. The explanation of D Walsh was noted.</p>	
Race 5	WAIROA STUD BREEDERS FLYERS
<p>MISS SING(D Bradley) was slow away. Apprentice rider M Dee(BELLA ARTOIS) admitted a charge of careless riding after he allowed his mount to shift in near the 700 metres into the line of ARCHETTO(J Oliver) which was checked. After deliberations, the JCA suspended Apprentice rider Dee's license to ride from the conclusion of racing on Sunday 17th February until 23rd February (3 days) THE RIGHT CHOICE(B Grylls) raced in restricted room over the final 100 metres.</p>	
Race 6	KENILWORTH PLUMBING DISTANCE
<p>SAINT KITT(T Thornton) and FIREKEEPER(D Bradley) were slow to begin DASHING THUNDER(L Allpress) raced three-wide throughout. SAINT KITT was held up early in the home straight prior to being angled wider in order to improve. SHORT OF CENTS(B Grylls) finished a distance last. A post-race Veterinary inspection revealed the mare to have suffered a rupture flexor-tendon to the left foreleg. Connections were advised that a Veterinary clearance will be required prior to SHORT OF CENTS racing next.</p>	
Race 7	JUKEN NEW ZEALAND LIMITED CUP TRIAL
<p>CROCODILE CANYON(M Dee), CALGACUS(M Hills) and HERMOSA NOVIA(D Walker) were all slow to begin. SECOND HOPE(T Thornton) shifted in abruptly on leaving the barriers hampering GALSHAAN(R Hannam) which got back.</p>	

ASHWORTHY (D Walsh) which finished a distance last underwent a Post-race Veterinary inspection failed to reveal any abnormality.

BROKERWEB RISK SERVICES/BLACK & WHITE ACCOUNTING DASH

VEDEX(R Hutchings) underwent a veterinary inspection behind the barriers and was passed fit to start.

PARTY HORSE(B Lammas) was slow away.

VEDEX was tightened at the start and got back.

KINGS ROYAL(L Ailpress) was forced over extra ground rounding the home turn when **O'MIGHTY THOR(D Bradley)** shifted out in search of a run. D Bradley was advised to exercise care when shifting ground.
