Race 2 SPEEDY SIGNS-EMBROIDEME 1950

MONTOPOLI (R Norvall) was slow to begin.

Near the 1300 metres **GORDYFROMGREATBARR** (T Thornton) and **MONTOPOLI** were inclined to over-race with **GORDYFROMGREATBARR** then racing three wide without cover.

Race 3 ILES CASEY CHARTERED ACCOUNTANTS 1200

WAI ITI (J Oliver) jumped away awkwardly.

IDAHO'S HALO (S Collett) which was slow to begin was then obliged to race three wide without cover throughout.

**WAI ITI** was steadied passing the 400 metres.

**BAY DANCER** (J Riddell) lay out in the final straight.

## Race 4 MARKS EWEN & ASSOCIATES 3YO

MANACOR (S Spratt), CAROLINA ISLAND (M Du Plessis) and LEGLESS (M Coleman) were all slow to begin.

**KISSES** (T Thornton) was inclined to over-race in the early and middle stages.

S Spratt (MANACOR) advised that her mount had failed to handle today's track conditions.

**SUBRIDEO** (B R Jones) required veterinary attention post-race for a laceration to the right hind leg consistent with having struck itself during the running.

### Race 5 WAIKATO BRANCH NZ FARRIERS ASSOCIATION 1560

**CALLMELOU** (T Thornton) jumped away awkwardly and then was further hampered when **HIGH SOCIETY** (B Hutton) shifted in.

ANYX (A Collett) was slow to begin.

**HIGH SOCIETY** was steadied and shifted out across the heels of **CORSICANA** (S Spratt) passing the 1200 metres. **HIGH SOCIETY** then improved forward to sit outside the leader near the 900 metres.

**CALLMELOU** over-raced in the middle stages.

M Coleman (ALICIA) advised that the mare had failed to handle today's track conditions.

Race 6 ON LOCATION SERVICES 1560

**IS DA CHIEF** (L Satherley) which had become fractious in the barriers was removed and underwent a veterinary inspection being cleared fit to start.

PUTUSHKI (A Morgan) jumped away awkwardly.

SATEKA (T Thornton) was slow to begin.

JUST CALL ME BOND (M Coleman) over-raced in the early and middle stages.

Passing the 600 metres **SATEKA** had to be steadied when crowded for room between **MRS NEAT** (B R Jones) which was laying out and **VIRGINIA WADE** (M Du Plessis) which was taken in by **SURVIVED** (M Tanaka) when **JUST CALL ME BOND** which was improving forward to its outside lay in.

L Satherley (IS DA CHIEF) advised that the gelding had not felt comfortable in today's track conditions once placed under pressure.

Race 7 DAWSON INSURANCE BROKERS 1400

WAINUI PRINCE (T Thornton) over-raced in the middle stages.

**ORAKA PRINCE** (S Collett) raced three wide without cover throughout.

**ORAKA PRINCE** was treated post-race by the veterinarian for a mild case of colic.

Race 8 TOWNLEY TRENCHING & ELECTRICAL 1400

WHATWASTHAT (M Coleman) was slow to begin.

**CATALAN KING** (M Du Plessis) raced three wide without cover throughout.

**SOPHIE CLAIRE** (S Spratt) was inclined to lay out in the final straight.

A post-race veterinary examination of MISTAROX found the gelding to have a haematoma on the left shoulder.
