RACE COMMENTS:

Race 1	MILLS REEF HANDICAP
MUSOKO KING and SIR COSWORTH were both slow to begin. SIR COSWORTH was held up rounding the turn and early part of the home straight. MISS CENTREFOLD raced keenly in the early stages.	
Race 2	PGG WRIGHTSON 3YO MAIDEN
VETTRIANO was crowded leaving the barriers when runners either side shifted ground. ETERNITY was angled out in the straight in order to obtain better footing. L Allpress reported that ETERNITY failed to handle the heavy track conditions.	
Race 3	ASCEND SALES TROPHIES HANDICAP
Trainer G Freeman admitted a breach of Rule 616 (3) and was fined \$50 after presenting AINTREE to race without notified gear (blinkers). AINTREE and REGAL SECRET came together leaving the barriers. SAN PEDRO shifted in leaving the barriers making contact with THATZ DAVID . THATZ DAVID slipped and blundered shortly after passing the finish line.	
Race 4	DESIGN BUILDERS MANAWATU MAIDEN

This race started 5 minutes behind schedule due to the field arriving late at the barrier and being several runners proving slow to load.

A warning was placed against the barrier manners of **LIGHT UP THE NIGHT** after the mare was fractious in its gate.

OH SO NAUTI was slow away.

JUST A CHARLIE and **ELATED** were both tightened leaving the barriers when runners either side shifted ground.

A post-race veterinary examination of **LIGHT UP THE NIGHT** which finished a distant last failed to find any obvious abnormality.

MISS LINCOLN was a late scratching at 2.45pm due to a material change in track conditions following constant rain throughout the early part of the meeting.

NO EXCUSES underwent a veterinary examination behind the barriers and was cleared to start after contacting the gate when leaving the enclosure.

PAY THE FOX bounded at the start.

J Shackleton reported that **PAY THE FOX** had failed to handle the Heavy 11 track conditions.

Permission was given for **ORMOND ROAD** to race without pacifiers due to the track conditions.

COATOFMANYCOLOURS shifted out shortly after leaving the barriers making contact with **JUST ISHI** and became unbalanced.

MUNGO JERRY was slow away.

TWILIGHT GRANITA slipped and lost its footing near the 900 metres.

R Hannam (DUBAI BELLE) was issued with a warning after he allowed his mount to shift in passing the 200 hundred metres hampering **INTRANSIGENT**.

When questioned regarding the performance of **VILLIFYE**, **M Tanaka** advised that the mare was never travelling comfortably at any stage in the going.

When questioned regarding the performance of **ZENNISTA**, **J Riddell** said the mare travelled a little keenly and may be improved by the run.

Following the event all riders participating in race eight were questioned regarding the state of the track and agreed that the track was suitable for them to continue riding.

DRIFT hung inwards near the end of the back straight and in doing so forced **NENA GREENA** across the heels of **POLLY FLINDERS** resulting in **NENA GREENA** having to be checked.

A post-race veterinary examination of **BIG ROCKET** failed to reveal any abnormalities.

When questioned regarding the performance of **FLINT**, **J Riddell** said the gelding was unsuited by the track conditions.

When questioned regarding the performance of **LIBERATOR**, **J Parkes** said that carrying the topweight of 59 kgs in the Heavy 11 told on the gelding over the final stages.
