As there was no other suitable rider available Stewards granted permission for jockey R Bishop to replace apprentice K Walters as the rider for **SEE YOU AT DIVAS** in Race 3 due to apprentice K Walters being unable to make the carded weight. Apprentice C Barnes replaced apprentice K Walters as the rider for **EMMA SAVANNA** in Race 4. K Walters admitted a breach of Rule 330(3)(c) with the JCA imposing a fine of \$100.

RACE COMMENTS:

Race 1 HAZLETT CONTRACTING HURDLES(2600M)

AIR CADET jumped the first hurdle awkwardly resulting in rider G Walsh losing his left stirrup iron for a short distance. Rounding the home **DECEPTIVE** had to be steadied and lost ground when held up for clear running.

UNCLE JIM landed awkwardly after jumping the third last hurdle near the 300 metres.

KEEP IT TIGHT and **AIR CADET** jumped the last hurdle awkwardly.

Race 2 THE ROADING COMPANY STEEPLECHASE (3400M)

DAY CENTRE made a faulty leap at the tenth fence near the 1800 metres dislodging rider A Browne. A Browne was examined by the St John Ambulance paramedics and found to be uninjured in this incident. A Browne reported **DAY CENTRE** was not comfortable with the prevailing track conditions and made several jumps awkwardly prior to his being dislodged. **DAY CENTRE** which completed the course riderless underwent a post race veterinary examination which revealed the gelding to have suffered a slight laceration to the right front leg.

DANA PASCALLE raced wide without cover throughout.

SUSPEND US jumped awkwardly outwards and bumped **YAMISSION**.

KING TAP lay out throughout the run home proving difficult to ride.

Correct weight was slightly delayed while T Moseley rider of **FOUR GEES** viewed replays of the final stages to consider whether to lodge a Protest against the first placed horse **KING TAP**. After viewing the films Mr Moseley decided not to lodge a Protest and correct weight was declared.

When questioned R Doherty the rider of **KING TAP** reported the gelding hung badly and lay out throughout the home straight and proved very difficult to ride. Trainer K King advised it was her intention to now spell **KING TAP**. K King was advised the gelding must trial to the satisfaction of the Stewards prior to racing next.

Race 4 SPG RIVERTON AND MARQUEE & PARTY HIRE MAIDEN (1200M)

NORTHERN TAP was slow to begin.

GUNNA FLY raced wide throughout.

INDIANA JONES raced wide from the 700 metres.

Passing the 250 metres **HALO DOLLY** shifted in and had to be steadied away from the heels of **NORTHERN TAP** which shifted out slightly.

C Johnson (LEGAL AID) was reminded of his obligations to ride his mount out fully to the finish of the race.

When questioned regarding his ride and the performance of **RICCIOLI** rider R Bishop reported that as the gelding was having its first start in seven months he was instructed to ride **RICCIOLI** wherever it was comfortable. He said the gelding was not completely comfortable in todays track conditions and initially did not respond when placed under pressure rounding the home turn. R Bishop added that he again placed the gelding under pressure passing the 300 metres at which stage **RICCIOLI** responded and went to the line fairly.

Co-trainer Miss J Gordon concurred with the instructions given and added after **RICCIOLI'S** poor performance prior to going for a spell they were unable to find anything amiss with the gelding. Miss Gordon further stated that **RICCIOLI**, which may have come into this race slightly underdone, will benefit from todays outing and will be better suited over more ground.

Race 5 TONY ROY BUILDING AND APARIMA PLUMBING HANDICAP (1200M)

WINDSWEPT was slow to begin.

GANNICUS commenced to race keenly nearing the first turn and got its head up when being steadied.

In the straight **NAVIGATOR** hung in.

Race 6 HAPPY BIRTHDAY HAZEL HILLIS FILLIES & MARES MAIDEN (1400M)

DOWN HERE UP THERE raced keenly in the early and middle stages.

Passing the 500 metres LANGHAM LADY and STRUCTURE brushed.

SWEET BUT NEAT drifted out slightly when placed under pressure in the home straight.

Race 7 MAINLAND MEATS AND TUATAPERE FREIGHT HANDICAP (1400M)

On jumping LUV DA BLING was crowded between BELLE D'OR and ASTRALIGHT both of which shifted ground.

RUSHINELLA jumped awkwardly bumping heavily with the outside gate.

GOLDEN TOWER was slow over the early stages.

Passing the 300 metres **LUV DA BLING** and **BETHUNE BILLY** were crowded between **HEZA KOOL KAT** (R Black) and **RUSHINELLA** both of which shifted ground. Apprentice Miss R Black was issued with a warning pursuant to Rule 638(1)(d) and reminded of her obligations when shifting ground.

RUSHINELLA (T Moseley) continued to have difficulty in obtaining clear running and passing the 250 metres shifted ground outwards bumping **BETHUNE BILLY** on several occasions. T Moseley was issued with a warning pursuant to Rule 638(1)(d) and reminded of his obligations when shifting ground.

Race 8 WRENS AND J R MILNE & SON LTD HANDICAP (1600M)

AMBITIOUS FOLLY and BUFFYS BOY bumped on jumping away.

YOUNG BACHELOR jumped awkwardly shifted in and bumped DOUBLE TAP.

HONORA FLYNN jumped awkwardly as the start was made.

POWDER CREEK raced wide rounding the first bend.

CHOCOLATE CAKE raced wide throughout.

D Bothamley defended a charge of Careless Riding pursuant to Rule 638(1)(d) in that near the 1200 metres he allowed his mount **AMIGO** to shift ground inwards when not clear of **PHIL WENNECK** (R Doherty) causing that horse to clip a heel and check. After viewing the replays and hearing evidence and submissions from D Bothamley, and the Stewards the JCA upheld the breach and suspended Mr Bothamley's licence to ride from 6th May 2013 to 14th May 2013, inclusive (3 days)
