Race 1 HI-TECH MERCHANTS LTD SPRINT 1000M

ELUSIVE ROSIE was slow to begin and was then outpaced in the early stages.

ANNIESSTAR and **SMARTAZ** were slow to begin.

MOUAD shifted out and bumped with RIODORO when the start was made.

MOUAD hung out rounding the turn.

DECADENT had to steady momentarily when held up near the 200 metres.

ANNIESSTAR was held up rounding the turn and only obtained clear running passing the 150 metres.

Race 2 THE MARQUIS HOTEL CARTERTON SPRINT 1000M

DESERT SABOTEUR, VEININSKY and **DAUFINO** were all slow to begin.

EVASIVE TRACY improved onto heels and had to be steadied near the 400 metres.

TURQUOISE was held up for a short distance rounding the home turn.

Race 3 WCM LEGAL MAIDEN 2200M

Due to a misunderstanding apprentice A Taylor was inadvertently engaged to ride **BANTENEIGHTY** the correct rider being **D Bradley**.

AREUFORREEL began awkwardly.

ANUTHA HULA was slow away.

SEFERINO shifted out on jumping crowding **READY EDDIE**.

READY EDDIE raced wide without cover throughout.

When questioned regarding the performance of ARIA PRINCE, L Allpress could offer no excuse.

M Tanaka admitted a charge of careless riding under Rule 638 (i) (d) in that he allowed **SEREFINO** to shift in shortly after the start when not clear of **BLACK DRAGON** which was taken inwards with consequential interference to **ARIA PRINCE** which was checked. After deliberations the JCA suspended his licence to ride in races from the close of racing on Wednesday 5 June 2013 until the close of racing on Wednesday 12 June 2013. (4 days)

Race 4 G V ELECTRICAL MAIDEN 1300M

MAKE BIG jumped in when the start was made crowding PRIVATE LINCOLN which settled back as a result.

PAINTED CITY was slow to begin.

CEVICHE raced three wide without cover throughout.

J Riddell admitted a charge of careless riding under Rule 638 (i) (d) in that he allowed his mount **FIST** to shift out resulting in crowding to **PARTY ICE** which clipped a heel and blundered at the winning post. The JCA after hearing all submissions and relevant evidence imposed a suspension from the close of racing on 9 June 2013 until the close of racing on 15 June 2013 (5 days).

Race 5 THE HIRE SHOP – GREYTOWN MAIDEN 3YO 1400M

QUEST FOR GOLD and SHADOW PLAYER were slow away.

JOE BONANNO began awkwardly and lost ground.

WIND IN HIS SAILS raced wide without cover throughout.

BAZINGER was held up rounding the turn until near the 200 metres.

Race 6 GRAYS CONTRACTING 1400M

I'M BACK JACK was a late scratching at 7.50am on veterinary advice. Connections were advised that a veterinary clearance would be required before the horse next races.

K Myers was fined \$50 under Rule 614 (2) for presenting SHOTGUN in the enclosure with the incorrect saddlecloth.

ELUSIVE RED began awkwardly and lost ground.

RAMPANTEXCUSE reared on jumping losing several lengths.

PLATINUM DANCER began awkwardly and shifted in making contact with WHOOPI GEE.

MISS CLAWDY raced three-wide without cover throughout.

RAMPANTEXCUSE had difficulty obtaining clear running near the 100 metres.

Race 7 COOPER FARM SERVICES 1600M

CIRON and **LIEUTENTANT LINCOLN** were slow away.

DAL DANTIX commenced to over-race shortly after leaving the barriers and had to be steadied for some distance.

CANSO raced three-wide without cover throughout.

HOLY SMOKE raced four-wide throughout.

DAL DANTRIX was held up rounding the turn and near the 250 metres was denied a marginal run having to be steadied and angled wider to obtain clear running near the 150 metres.

PILLAR TO POST was held up rounding the turn prior to be angled inwards approaching the 200 metres to continue to improve.

SPIKE MILLIGAN became awkwardly placed on heels over the final stages and had to be steadied.

QUIN BAY hung outwards throughout the final straight and could not be ridden to advantage

Race 8 SMITH SPREADING MAIDEN MILE 1600M

XIBIT reared on jumping away and lost ground.

BEAUTIFUL MAN began awkwardly.

I'M YOUR MAN began awkwardly, shifting in and bumping with ATTIVAREE.

I'M YOUR MAN raced wide throughout.

LA BELLA SANDS and KAYZED came together passing the 200 metres.

XIBIT had difficulty obtaining clear running passing the 100 metres.

ALL GINGA was inconvenienced near the 250 metres when awkwardly placed on heels.
