RACE COMMENTS:

Race 1 G & M HENNESSY JUMPERS FLAT HANDICAP 2600m

MUZZA got its head up and raced keenly in the early stages.

PAKITIN PETE was held up on the final bend by the tiring **KIDUNOT**.

When spoken to regarding the performance of **IRISH WIT** rider C Johnson advised that he was momentarily held up passing the 600 metres but he had only battled over the concluding stages and had disappointed.

Race 2 STEVE BLAIR-EDIE R65 HANDICAP 1800m

There was a slight delay to this race being started due to a power issue with the gates.

HIDDEN IDENTITY was slow to begin.

THE BIRD OF PREY began awkwardly shifting in and hampering AQUALINE who lost ground.

BOKKIE BOKKIE also began awkwardly losing ground.

LORD YARBOROUGH raced wide through the early stages.

LORD YARBOROUGH (R Black) shifted out in the concluding stages placing **THE BIRD OF PREY** (C Johnson) in restricted room. The connections of **THE BIRD OF PREY** viewed replays of this incident before deciding not to proceed with a protest. Apprentice R Black was advised to exercise care.

PAMINA (J Wong) was inclined to shift outwards under pressure in the run home and in the shadows of the post carried **LORD YARBOROUGH** further out onto **THE BIRD OF PREY**. Apprentice J Wong was shown replays and advised to exercise care.

When spoken to regarding the disappointing performance of GOLDEN TOWER rider R Doherty reported that the gelding

had never travelled well at any time throughout the event and had been very disappointing. Stewards ordered a post-race veterinary inspection of **GOLDEN TOWER** which revealed no abnormalities.

Stewards also ordered a post-race veterinary examination of **HIDDEN IDENTITY** when it was observed to have blood in its mouth on return to scale. On inspection the mare was found to have knocked a tooth on the starting gate.

Race 3 M MEYER R65 HANDICAP 1200m

CHEEKY TART shifted out abruptly at the start crowding **HALO BUSTER** and **TRICATCHME** with the rider of **CHEEKY TART** momentarily losing the use of his off side iron.

ON YER FEET raced wide throughout.

On return to scale favourite **TACTICALL** was observed to have blood in one nostril. After examination by the Club's Veterinarian **TACTICALL** was found to have a laceration to the inside of the nostril and was not a bleeder.

When spoken to regarding the performance of **TACTICALL** rider R Hannam advised that the mare had been fractious in the gates but had travelled well until placed under pressure at the 400 metres and had disappointed however he believed the mare would benefit from today's outing after resuming following a lengthy spell.

Race 4 WAIMATE VETERINARY CENTRE & CRT FARMLANDS MAIDEN 1200m

MADAM was slow to begin.

PAZERAE began awkwardly.

ALFIE'S BELLE (D Prastiyou) shifted out just after the start was made hampering FIGOLAN.

Passing the 1100 metres **BEST FELLA** and **FULLOVTRIX** were crowded and had to steady when **ALFIE'S BELLE** shifted in when not clear. Apprentice D Prastiyou in the presence of his employer Mr P Richards admitted a breach of Rule 638(1)(d) careless riding. After considering submissions on penalty the JCA imposed a suspension from after the conclusion of racing at Ashburton on 5 July 2013 up to and including 12 July 2013 (2 Days).

D'JAKE and GARTARTAN LAD both raced keenly through the early stages.

Passing the 900 metres **FULLOVTRIX** who was racing keenly shifted out off the heels of **SWEET BUT NEAT** dictating **GARTARTAN LAD** wider on the track. **GARTARTAN LAD** raced wide thereafter.

Race 5 MINSTREL COURT WILLOW GLEN R65 HANDICAP 1800m

SIR REIMS and AVID RULER began awkwardly and made firm contact with both runners losing ground.

CHINA BO BO raced very wide into the first bend and wide throughout.

Passing the 1200 metres GANADOR threw its head in the air when being steadied off heels.

Passing the 1100 metres WAGONWHEEL shifted in contacting ADDITUP who was buffeted and unbalanced momentarily.

Passing the 250 metres **CHINA BO BO** had to steady momentarily when **GANADOR** (J Bullard) shifted in on the point of the turn. Rider J Bullard was advised to exercise care.

WAGONWHEEL lay in throughout the run home with the rider having to swap whip hands.

Race 6 R & D GOODEVE WAIMATE CUP R85 1800m

DICKENS shifted in abruptly at the start hampering **GOOD ONE GLADY** who lost ground. **DICKENS** despite the efforts of its rider continued its inward movement making firm contact with **STORMY RAIN**.

When spoken to regarding the performance of favoured runner **ALL ABOUT ALF** rider J Bullard advised the gelding had been disappointing but added that **ALL ABOUT ALF** was probably suited to tracks with more moisture in them.

Race 7 LIFETIME GROUP R85 HANDICAP 1200m

BOWLING BOY shifted out at the start crowding **AUTHENTIC PADDY**, **CANGOWEST** and **CREDIT CRUNCH**.

REDFERN raced keenly through the early stages when being restrained.

When questioned regarding the performance of **AUTHENTIC PADDY** rider R Hannam explained the gelding's good form had generally been on slow to heavy going.

When questioned regarding the performance of **BOWLING BOY** rider T Direen explained she thought the gelding may have been holding its breath and that it had made some abnormal respiratory noise following the race. A post-race veterinary examination revealed no abnormalities.

Race 8 WAIMATE TOWN & COUNTRY CLUB & WALLFIELD FARM MAIDEN 1800m

Both IT'S HAPPEN'EN and PENNY KATE were inspected by the Club Veterinarian prior to racing after both sustaining small lacerations to their legs with both runners cleared to race.

LONE WOLF began awkwardly with the rider becoming badly unbalanced for a short distance.

SMARTYMARTY and **SOMETHING ZED** both over-raced in the straight on the first occasion.

When spoken to regarding the disappointing performance of favourite **D'CHAPARRAL** rider R Hannam advised that from his 1 barrier draw he had been trapped down near the rail which was the worst part of the track and had only battled away over the concluding stages.

When spoken to regarding the disappointing performance of **FORGOTTEN HERO** rider C Johnson could offer no tangible excuses.

When spoken to regarding the improved performance of **GIOCCHINO** trainer M Hamilton advised the Stewards that he had changed the gelding's training regime since its previous start with **GIOCCHINO** having only been given light work during the week and a better showing was not unexpected.

Rider G Coetzee (**PFORPERFECT**) was issued a warning under Rule 649(1)(b) for making contact with another person prior to weigh in.

Race 9

R WILLIAMSON & H RUDDENKLAU MEMORIAL R75 1200m

PATRICE and REMIND ME brushed on jumping away

KATIE JAY was buffeted between runners as the start was made losing ground.

SUMMER'S BOY began awkwardly and was slow to begin.

GOLDEN GLOBE got its head up when being restrained through the early stages.

Passing the 600 metres GOLDEN GLOBE again skied its head when being steadied off the heels of the runner in front.

When spoken to regarding the performance of **PATRICE** rider C Johnson advised the Stewards the gelding had never travelled well throughout the running and had been very disappointing. Stewards ordered a post-race veterinary examination which revealed no abnormalities.

When spoken to regarding the performance of **REMIND ME** rider T Direen advised that in her opinion the mare had not handled the holding nature of today's Dead 6 track.

Stewards ordered a post-race veterinary examination of **KATIE JAY** which finished in a distant last placing after failing to maintain contact with the field throughout the running. This examination also revealed no abnormalities. Trainer M Daly advised he would be deciding on the mare's race future in coming days.

Race 10 WAIMATE HOTEL MAIDEN 1200m

BLUSHING shifted out abruptly at the start resulting in **BELLALEAH** being severely hampered with the rider becoming badly unbalanced for several strides. Also hampered in this were **NANCHO LASS** and **MOONOFKLAIRESSA** who were shifted wider on the track and lost ground.

As a result of this incident NANCHO LASS when being shifted wider and making firm contact with KINGSLEY ROSE resulting in MISSCATTLECREEK, SENTENCE, GEE TEE EM and RAVISHING all being crowded with all these runners becoming unbalanced and losing momentum. Also contributing to this crowding was DO UNO WHOIAM shifting in marginally.

DO UNO WHOIAM and RAVISHING both raced keenly early.

Passing the 75 metres **THORN MAJIC** and **BLUSHING** made contact.
