RACE COMMENTS:

Cowley's Hire Centre 1200

PUSSY WILLOW (S Spratt) began awkwardly losing ground.

SUMOTORI (A Forbes) and FIELDOFDREAMS (M Wenn) both began awkwardly and came together.

PUSSY WILLOW raced ungenerously when being restrained in the early stages.

O'RIGHT ZEN (M Hills) made the bend awkwardly passing the 900 metres.

Approaching the 350 metres SAVANNAH AL JAMAL (P Taylor) had to shift to the inside of O'RIGHT ZEN (M Hills) to obtain clear running.

DARCI'S GOLD (M Cameron) and FIELDOFDREAMS came together passing the 300 metres when both runners shifted

ground.

Over the concluding stages **PUSSY WILLOW** became awkwardly placed on the heels of **D'CASH MAN** (B Hutton) which shifted out slightly. As a result **PUSSY WILLOW** shifted out making contact with **FIELDOFDREAMS**.

When questioned into the performance of the favourite **DARCI'S GOLD** Rider M Cameron could offer no tangible reason for the mare's performance.

Race 2 The Northern Advocate 1400

CEEBEEL (B Hutton), BRAHMA QUEEN (P Turner) and VICTORY GOLD (M Hills) all began awkwardly.

Approaching the 1200 metres **SUDDEN EXPLOSION** (K Myers) shifted away from **FULL ON JACKS** (T Thornton) placing **MAIDEN WARRIOR** (M Sweeney) in restricted room having to be steadied **MAIDEN WARRIOR** then shifted out with **GOLD VAULT** (L Robertson) shifting away from that runner forcing **OUR KISMET** (R Hutchings) wider on the track. **OUR KISMET** then steadied and shifted back in closer to the running rail.

Passing the 900 metres **JOYFUL SPIRIT** (S Collett) and **SUDDEN EXPLOSION** both made the bend awkwardly with **I DREAM OF JEANNIE** (M Wenn) becoming awkwardly placed on the heels of **SUDDEN EXPLOSION** having to steady losing ground. **OUR KISMET** was held up early in the final straight.

Over the concluding stages **DANCING ON TABLES** (A Forbes) raced in restricted room to the inside of **HENNESSY BLACK** (S Spratt) which shifted in.

Race 3 92.4FM Live Sport Northland 1400

SPLITFIRE (M Wenn) began awkwardly losing ground.

Shortly after the start **ASGOODASITGETS** (T Thornton) shifted out when struck with the whip making contact with **GENDARME** (B Hutton) which became unbalanced.

Approaching the 300 metres **ANOTHER INVADER** (M Cameron) shifted in under pressure crowding **JUST GOT HOME** (R Smyth). **ANOTHER INVADER** shifted out when corrected by its rider then shortly after **ANOTHER INVADER** continued to shift in to obtain a tight run to the inside of **ASGOODASITGETS** when not sufficiently clear of **JUST GOT HOME** (R Smyth) which had to be checked losing ground. Rider M Cameron was charged under Rule 638(1)(d) to which he elected to plead guilty and was suspended from the conclusion of racing on 6 July 2013 up to and including 12 July 2013.

Race 4 Industrial Security Specialists 1400

WYATT EARP (P Taylor) and RED STORM (R Hutchings) both began awkwardly losing ground.

ANOTHER EDITION (T Thornton) shifted in when leaving the barriers making contact with **LUCKY ORPHAN** (J Jago) which then shifted in hampering **GOIN TO THE CHAPEL** (M Sweeney) which had begun awkwardly.

Passing the 1300 metres **ANOTHER EDITION** had to steady when becoming awkwardly placed inside the heels of **ZEST PRINCESS** (M Wenn) which shifted in.

SAINT PIRAN (K Myers) raced fiercely in the early stages.

LUCKY ORPHAN over-raced in the early and middle stages and was inclined to lay out.

PIAZZETTA (S Collett) and STRADA LASS (P Turner) raced ungenerously through the middle stages.

Passing the 900 metres **WYATT EARP** ran off when making the bend losing considerable ground. Trainer A Scott was advised that a warning would be placed against the gelding for its racing manners.

MAILLY (B R Jones) and **ANOTHER EDITION** raced wide without cover for the majority of the race.

GOIN TO THE CHAPEL had difficulty obtaining clear running for the majority of the final straight.

PIAZZETTA shifted in under pressure approaching the 200 metres.

SAINT PIRAN raced in restricted room over the final 100 metres.

Race 5 United Security Northland 1400

IPONI (A Forbes) began awkwardly losing ground.

AIRMAN (S Spratt) began awkwardly shifting out making contact with **NAZEER** (M Hills) and then shifted back in inconveniencing **CAST A SPELL** (M Wenn).

JUNGLE KNIGHT (K Myers) raced ungenerously in the early stages and then was obliged to race three wide without cover for the remainder of the race.

Passing the 300 metres **CAPO** (B Hutton) shifted out to obtain clear running making contact with **SHANSTAR** (R Hutchings) with both runners becoming briefly unbalanced. **CAPO** then continued to lay out under pressure further inconveniencing **SHANSTAR**.

PRINCE OF THRACE (M Sweeney) raced in restricted room over the concluding stages when **RIGHTEO** (M Cameron) shifted out under pressure.

Race 6 Fell Engineering 1400

Passing the 900 metres ROSE TATTOO (P Taylor) raced ungenerously when making the bend.

PERFECT KATCH (M Hills) was obliged to race wide without cover throughout.

When questioned regarding the performance of **AIMEES BABE** Rider M Sweeney advised that after drawing awkwardly he had to work harder in the early stages than he anticipated and this had been detrimental to **AIMEES BABE'S** chances when placed under pressure in the final straight.

When questioned regarding the performance of **THE RICH LISTER** Rider M Wenn could offer no tangible reason for the gelding's performance.

Race 7 Whangarei Bus Services Open 2100

KIDNAPPED (M Wenn) and SAVED BY THE BELL (K Myers) both began awkwardly.

HOT IN BLACK (P Taylor) and **SHOOTOFF** (R Hutchings) were both slow to begin.

SKAI GLEN (S Collett) and **PAYBACK** (A Forbes) were both obliged to race wide in the early stages before both being allowed to work forward.

SAVED BY THE BELL raced ungenerously when making the first bend passing the 1700 metres and then hung out through the middle stages.

M Cameron, the rider of **NATSINGA**, admitted a breach of Rule 638(3)(b) excessive use of the whip prior to the 200 metres and was fined the sum of \$150.

S Spratt, the rider of **MONTETRA**, admitted a breach of Rule 638(3)(b) excessive use of the whip prior to the 200 metres. After hearing submissions from S Spratt she was suspended from the conclusion of racing on 6 July 2013 up to and including 15 July 2013, 4 days.

J Jago, the rider of **NOBLE WARRIOR**, was issued with a warning under Rule 638(3)(b) excessive use of the whip prior to the 200 metres.

Race 8 100% Barrell's 1600

RULALINE underwent a veterinary inspection at the start after making contact with the fence in the Bird Cage and was declared a late scratching at 3.04pm.

PACO KIDD proved difficult to load with co-trainer D Logan being advised that a barrier warning would be placed against the gelding.

LOCHWOOD (P Turner) began awkwardly losing ground.

Approaching the 700 metres **ZEPHYROS** (B Hutton) became awkwardly placed on the heels of **SHADES OF GOLD** (R Hutchings) having to steady and as a result shifted back on to **LOCHWOOD** which was hampered.

FULLOVIT (A Forbes) was obliged to race wide without cover.

Approaching the 100 metres **ZABINELLA** (S Collett) ducked in under pressure before being corrected by its rider. As a result **PACO KID** (M Cameron) shifted away from that runner crowding **BEAUTY AHEAD** (BR Jones) which had to steady.

Race 9 Waipu In Tartan 1600

MEMORY (M Hills) began awkwardly losing ground.

Shortly after leaving the barriers **HARDTALUVA** (M Wenn) was crowded between **FREEDOM** (K Joyce) which lay out and **URBAN ANGEL** (M Cameron) losing ground as a result.

Approaching the 1300 metres **URBAN ANGEL** became awkwardly placed on the heels of **TOP CHOICE** (B Hutton) which shifted in with **URBAN ANGEL** then having to steady becoming briefly unbalanced.

BANDERAS (T Thornton) was obliged to race wide without cover.

Passing the 300 metres **TOP CHOICE** and **BANDERAS** raced in restricted room between **SMUCKERS** (K Myers) and **DENMARK** (S Spratt) which had shifted in and away from **MEMORY** which was laying in under pressure with **TOP CHOICE** then having to steady off the heels of **SMUCKERS**.

Race 10 A'Fare Caterers 1600

S Cameron was fined \$50 under Rule 616(3) for presenting **WERIO** without notified gear.

GOYESCAS (M Hills), **THE MIG** (S Collett), **SOPHIE'S GEM** (R Hutchings), **BOB VALDEZ** (V Gatu) and **SWIPER THE FOX** (B Hutton) were all slow to begin.

Passing the 1400 metres **SOPHIE'S GEM** became awkwardly placed on the heels of **REGALO REAAL** (S Spratt) which was steadying with **SOPHIE'S GEM** then shifting out abruptly hampering **SWIPER THE FOX**. **SOPHIE'S GEM** then raced ungenerously for a distance.

Passing the 1300 metres **WERIO** (P Turner) shifted in making contact with **PYCOK FLYER** (L Magorrian) for a distance. P Turner was reprimanded by Stewards and told that he would be expected to show better judgment in future.

THE MIG was held up rounding the final turn and early in the final straight until near the 200 metres.

Passing the 150 metres **BOB VALDEZ** shifted in abruptly when struck with the whip inconveniencing **SWIPER THE FOX**. **KING ZEUS** (M Cameron) shifted out over the final 50 metres when under pressure making contact with **BOB VALDEZ**. Following the race the connections of the second placed horse **BOB VALDEZ** wished to view footage inside the final 100 metres with a view to an objection electing not to proceed.

C Dell, the rider of **CAPTAIN SCOTT**, admitted a breach of Rule 638(3)(b), excessive use of the whip, prior to the 200 metres. After hearing submissions he was fined a sum of \$225.
