RACE COMMENTS:

Race 1	KIM TREWEEK FAREWELL MAIDEN HURDLES
<p>N Quinn (REYNARDS BRO) was issued with a warning after shifting inwards in the home straight on the first occasion when not clear of I'M ISAAC (I Lupton) which was momentarily hampered. ASWORTHY (T Ihaka) landed awkwardly after jumping the first fence. HOOVER BOY (G Walsh) hit the fence near the 1400 metres. ARMADIO ESTRADA (M Mitchell) blundered at the fence near the 1000 metres. REYNARDS BRO had to be eased after jumping the fence near the 600 metres when ARMADIO ESTRADA shifted in. R Cully (KINGS DEEP) was issued with a warning after he allowed his mount to shift out on the point of the turn crowding HOOVER BOY and CALGUCUS (S Houston). R Cully (KINGS DEEP) dropped his whip after jumping the last fence.</p>	
Race 2	MURRAY THOMPSON HB HUNT MAIDEN HURDLES
<p>SHOOGOLD (G Walsh) was slow away and jumped indifferently throughout at the rear and was retired from the race prior</p>	

to the second last fence.

BRER (C Thornton) ran its fences down throughout hampering **HEMINGWAY** (K Veenendaal) at the three fences in the back straight and near the fence near the 600 metres.

An inquiry was opened and adjourned into an incident near the winning post on the first round when **HEMINGWAY** appeared to clip the heels of **BRER** and blundered.

JAMAA (A Kuru) was inclined to hang throughout.

Race 3 **TE WHANGAI ROMNEY'S HAWKE'S BAY HURDLES**

HONEY (K Veenendaal) was slow away.

S Phelan (**GOOSEBUMPS**) was issued with a warning after he allowed his mount to shift in shortly after jumping the first fence tightening **NO GOVERNANCE** (I Lupton)

GOOSEBUMPS (S Phelan) was inclined to run its fences down throughout and after jumping the fence near the 600 metres shifted in and hampered **EVATHREESTEP** (C Thornton) which went back onto **HONEY**.

HO DOWN(R Cully) was retired from the race at the 400 metres when well back and out of contention.

GOOSEBUMPS was retired from the race prior to jumping the last race. Rider S Phelan advised that the gelding had jumped indifferently throughout and in his opinion had not been entirely comfortable in today's track conditions.

GOOSEBUMPS suffered an abrasion to the left stifle during the running requiring veterinary attention.

Race 4 **WAIPUKURAU NEW WORLD/COREY & AMIE'S ENGAGEMENT 2500**

Apprentice jockey Dylan Turner admitted a charge under [Rule 330 (3)(c)] in that he failed to make the weight for **THE PAINTER** (Race 4), **EKKO BEECHES** (Race 7), and **ISHIAROSE** (Race 10) and had his license to ride in races suspended from the conclusion of racing on the 6th July up to and including 13th July, 2013 (3 days).

SEA EAGLE (D Bradley) was slow away.

LASSWADE (B Lammas) raced wide throughout.

RIPDIDDLER (C Johnson) shifted out under pressure and bumped **STAGEHAND** (L Allpress) early in the home straight.

Race 5 **JUST A SWAGGER HB HUNT MAIDEN STEEPLECHASE**

PALEMO (J Rathbone) raced keenly early.

WAIANAKARUA (S Houston) jumped slowly throughout when well back.

PALEMO jumped the fence poorly near the 1000 metres unbalancing the rider.

MISTER DEEJAY landed awkwardly near the fence at the 1000 metres and dislodged rider H Curran. H Curran was uninjured.

Race 6 **ANIMAL HEALTH DIRECT HAWKE'S BAY STEEPLECHASE**

K Veenendaal (**LIZAC**) lost her left stirrup iron for a short distance when jumping the fence near the 1400 metres on the first occasion.

NO QUOTA (S Houston) lost its footing a short distance after jumping the fence near the 1400 metres dislodging rider S Houston who was uninjured.

BORRACK (I Lupton) was under pressure passing the 800 metres and commenced to give ground, not being preserved with from the 600 metres and was retired from the race.

A subsequent veterinary examination found the gelding to be lame in the left foreleg. Trainer Mr A Bull was advised that a veterinary certificate of fitness would be required prior to **BORRACK** racing next.

Race 7 **LOWRY/CULLEN RACING STABLES MAIDEN 1400**

CANYON (H Tinsley) began awkwardly.

LAVISH PRINCE (D Bradley) was bumped at the start and got back.

Near the 500 metres **PARTY ICE** (B Lammas) had to be steadied when crowded between **ADRIENNE** (L Allpress), which shifted out under pressure and was then taken out further by **LAVISH PRINCE** (D Bradley), and **HUNKY DORY** (S Doyle) which shifted in slightly. Also hampered as a result was **PREMEAUX** (C Johnson) which became awkwardly placed on the heels of **PARTY ICE**. D Bradley was advised to exercise more care.

RACE 8 **62 DAYS TO RUSH MUNRO SPRING RACING CARNIVAL**

ZINIKA (M Hudson) was slow away.

ITSAGEM (B Grylls) shifted ground inwards to improve near the 300 metres.

Race 9 **TARADALE CLUB OPEN SPRINT**

SANRIBA (C Johnson) and **TOMA VALEA** (V Johnstone) bumped shortly after the start resulting in **SANRIBA** becoming unbalanced.

When questioned into the disappointing run of **ATOZED** rider R Hannam was of the opinion the mare was feeling the effects of recent racing. Trainer G Searle confirmed **ATOZED** would be spelled.

H Mathews advised stewards at 8.45am that **GOSSIPING** had incurred a stone bruise so was subsequently late scratched.

Race 10 **WAIROA WANDERERS 1400**

MR DARCEE'S GOLD (B Grylls) was severely bumped and became unbalanced at the start when **BEAU AGEN** (J Shackleton) shifted out abruptly.

MIDNIGHT PADDLE (S Pashai) began awkwardly when appearing to be severely restrained by its rider for some distance after the start effectively losing all chance in the race.

S Pashai in the presence of her employer Mr G Lowry admitted a subsequent charge in that she rode her mount **MIDNIGHT**

PADDLE in an incompetent manner leaving the barriers. After hearing submissions the Judicial Committee suspended Miss Pashai from the conclusion of racing on Monday 2nd July until the conclusion of racing on Monday 12th August, 6 weeks. **PIONEER** (D Bradley) was held up for some distance near the 400 metres prior to gaining clear running over the final 200. Trainer M Loveday attributed the winner **MR DARCEE'S GOLD's** improved performance to being ridden more patiently on this occasion.
