RACE COMMENTS:

Race 1 THE CLUBHOUSE SPORTS BAR HURDLE

EL PATRON (C Perrett) jumped the first fence awkwardly.

JAMIE LEE (M Cropp) had to be steadied when laying in onto the heels of **IMA DANCER** (K Veenendaal) which shifted out slightly going into the first bend near the 2500 metres.

EL PATRON put in a poor jump at the third fence.

FLAVOUR FLAV (S Houston) over-raced when a clear leader in the early and middle stages.

JAMIE LEE hit the third last fence and blundered on landing effectively losing its chance in the race. After jumping the second last fence **JAMIE LEE** was retired from the race when a distant last.

A Kuru (COMTE DE JEU) dropped his rein in the approach to the second last fence.

FLAVOUR FLAV (S Houston) put in poor jumps at the last two fences when tiring. Rider S Houston advised that the gelding over-racing in the early to middle stages had been detrimental to its chances today.

T Harris the rider of **SUPERCHARGED** was reminded of his obligation to ride his mounts out fully to the finish after relaxing his ride inside the final 50 metres when narrowly holding third placing.

Race 2 ANDERSON ACCOUNTING HURDLE

Prior to the first race the Stipendiary Stewards were advised by the stable representative for **XALTED** that P Ormsby the declared rider for this runner had advised that he would not be attending the meeting as he was over-weight. With attempts by the Stipendiary Stewards to contact P Ormsby being unsuccessful a minor infringement notice alleging a breach of Rule 330(3)(c) (over-weight) was lodged with the Judicial Committee. Due to Mr Ormsby's non-attendance at the meeting the matter was adjourned until a date to be set.

APPLAUD (S Sanders) was slow away.

CASH KINGDOM (M Cropp) ran down the first fence hampering **TED'LL DO** (S Houston) and **VICTOR LUDORUM** (K Veenendaal).

BARTOTE (A Kuru) and GOLDEN CUP WINNER (C Leveque) both put in poor jumps at the first fence. GOLDEN CUP WINNER

continued to jump indifferently at the rear throughout.

TED'LL DO ran down the three fences in the home straight on the first occasion, and continued to run its fences down for the remainder of the race.

VICTOR LUDORUM, CHAINEDINALKATRAZ (G Walsh) and APPLAUD all put in poor jumps at the second fence.

VICTOR LUDORUM hit the third fence with rider K Veenendaal losing her right iron which she did not regain until near the 1600 metres. When attempting to regain the use of the iron **VICTOR LUDORUM** hampered **APPLAUD** near the 1900 metres.

VICTOR LUDORUM was retired from the race near the 1300 metres. A post-race veterinary examination found the gelding to have suffered a significant injury to the left foreleg with trainer A Browne indicating that **VICTOR LUDORUM** would now be retired from racing.

BARTOTE made contact with the hind quarters of CHAINEDINALKATRAZ going into the bend near the 800 metres.

CHAINEDINALKATRAZ made a poor jump at the second last fence and was retired from the race prior to the last fence as was **CASH KINGDOM** when both runners were well beaten.

ISDABICKY (S Phelan) jumped the last fence awkwardly.

Race 3 AZAMOUR CHAMPION RACEHORSE & PROVEN SIRE JUVENILE

Trainer R Gavin was spoken to regarding comments made in a Trackside TV interview regarding the chances of **READY TO RUMBLE** (J Whiteside).

DILLY (A Forbes) began awkwardly and shifted in badly hampering **HARP** (D Johnson) which lost ground.

DURHAM ROSE (L Allpress) began awkwardly and was further hampered when crowded shortly after.

READY TO RUMBLE made the 800 metre bend awkwardly shifting out into the line of **VITESSE ROSE** (C Grylls) which had to steady going back on to **MR SANCHEZ** (M Hills). **MR SANCHEZ** was then inclined to over-race having to be restrained off the heels of **BUCKWILD** (J Jago) near the 700 metres and continuing to over-race for a distance.

READY TO RUMBLE was inclined to race greenly under pressure in the final straight and passing the 150 metres shifted in away from **BUCKWILD** hampering **MR SANCHEZ**.

Approaching the 100 metres **ALADDIN** (O Bosson) shifted in under pressure crowding **BUCKWILD** which was taken inwards further hampering **READY TO RUMBLE** and **MR SANCHEZ**. O Bosson was issued with a warning.

A Forbes admitted a breach of Rule 638(3)(b) in that he used his whip in an excessive manner prior to the 200 metres on his mount **DILLY**. After giving the matter full consideration and taking into account that today's breach was viewed as low end of the scale along with A Forbes's poor record the Judicial Committee on this occasion imposed a fine of \$700.

Race 4 GOLDPINE JUVENILE

ROYAL DOMINANCE (C Grylls) was crowded shortly after leaving the barriers losing ground.

WAZUNGU (M Sweeney) stumbled shortly after jumping away.

Approaching the 1100 metres **CONGRESSMAN** (O Bosson) shifted out when racing greenly with **STELLA VEGA** (S Spratt) then shifting away from that runner inconveniencing **SILK SHOT** (A Forbes).

WAZUNGU made the bend near the 800 metres awkwardly inconveniencing **KING SAVINSKY** (M Cameron) which was forced wider on the track.

CAUTHEN (B Lammas) raced wide without cover throughout.

ESZENCIA (L Allpress) was inconvenienced passing the 400 metres by **EYE CONTACT** (M Hills) which shifted out when racing greenly.

When questioned regarding the performance of **STELLA VEGA** rider S Spratt was unable to offer any excuses advising that in her opinion the filly had found the 1200 metres of today's race too testing and may be better suited over a shorter distance.

Race 5 PORRITT SAND STEEPLECHASE

O'CONNOR (G Walsh) and MR ALIGN (M Mitchell) both began awkwardly.

AYATOLLAH (C Perrett) raced keenly in the early stages.

IMA HEROINE (A Kuru) badly misjudged the second fence in the middle and fell.

MYTHS AND LEGENDS (K Veenendaal) put in a poor jump at the third fence in the middle dislodging its rider.

O'CONNOR hit the fence passing the 1200 metres and landed awkwardly dislodging its rider.

AYATOLLAH knuckled after jumping the second last fence.

All riders which fell were examined by the course doctor and found to be uninjured.

Post-race veterinary examinations found **IMA HEROINE** and **O'CONNOR** to be uninjured. **MYTHS AND LEGENDS** suffered a significant tendon injury to the left foreleg with connections indicating that the gelding would now be retired from racing.

Race 6 CAMBRIDGE TRAINING CENTRE STEEPLECHASE

GENEROUS TYPE (G Walsh) badly misjudged the second fence and fell. **POTHEEN** (S Phelan) which was following also misjudged the fence and landed awkwardly and when evading the fallen runner dislodged its rider. Hampered by the fallen **GENEROUS TYPE** was **SINISTA** (R Cave).

SINISTA put in a poor jump at the third fence and fell.

BENEDETTO lost its footing after jumping the fence near the 2000 metres dislodging rider S Sanders. Hampered as a result was **RADINKA** (M Mitchell).

RADINKA was crowded between **IMA STAR** (I Lupton) and **ROBERTY BOB** (K Veenendaal) rounding the final turn near the 400 metres with those three runners then coming together and bumping.

RADINKA lay in approaching the last fence making contact with **IMA STAR** which was forced close to the inside wing of the fence

All fallen riders were cleared by the course doctor.

GENEROUS TYPE, BENEDETTO and **POTHEEN** were all uninjured. **SINISTA** required veterinary treatment for a bruised right shoulder where the gelding had collided with another rider-less runner prior to being recaptured. **IMA STAR** also required veterinary attention after having aggravated a previous tendon injury to the left foreleg.

Race 7 FAIRVIEW FORD CAMBRIDGE 1200

STRAWBERRY SWING (S Spratt) began awkwardly.

KONTIKI (T Wenn) shifted in abruptly leaving the barriers crowding **GIRLS DAY OUT** (D Johnson), **WAR STORY** (A Forbes) and **FINNYS GOLD** (L Allpress) which was forced across the heels of **RUSTY HEIGHTS** (J Whiteside) losing ground as a result.

CATCHAGRENADEFORU (M Cheung) began awkwardly losing ground.

GREAT DANCER (B Hutton) commenced to over-race passing the 1000 metres when being restrained off heels.

Passing the 500 metres AIM PHAR (M Hills) ducked in when becoming unbalanced for a short distance.

WAR STORY was held up passing the 200 metres having to be steadied off heels and shift out to obtain clear running approaching the 100 metres.

KONTIKI hung inwards throughout the race and was unable to be ridden out in the straight. **KONTIKI** lost the right hind plate during the running.

Following a period of showers the track was downgraded to a slow 9.

Race 8 FARRIER SUPPLIES 1200

SUBRIDEO (R Stam) and **RANSOMLASS** (R Norvall) both began awkwardly with **SUBRIDEO** shifting in abruptly and **RANSOMLASS** clipping a heel of that runner and blundering losing ground.

PRIDE AND PASSION (M Cameron) and SMILING CHOICE (B Hutton) both began awkwardly.

RIVER MOY (L Allpress) raced a little ungenerously when being restrained approaching the 1000 metres.

PRIDE AND PASSION and ANAHEIM (S Spratt) both shifted in under pressure over the final 150 metres.

Race 9 SHOCKING @ RICH HILL STUD 1400

EXOTIC (M McNab) and I'VE GOTLEGS (J Whiteside) were slow to begin.

SHEZASTUNNA (M Dravitzki) and **PINK DIAMOND** (L Allpress) came together leaving the barriers with **SHEZASTUNNA** then being further crowded by **RUSTANA** (M Sweeney) which shifted out.

Approaching the 1200 metres **AMARLIA** (R Smyth) which was inclined to lay in crowded **GETUSTOIT** (T Thornton) which was taken inwards causing crowding to **LADY PHOENIX** (R Hutchings), **CAGA DANCE** (A Forbes) and **LATIN RULE** (R Norvall). R Smyth was advised that she must make a greater attempt to correct her mount more quickly than she had on this occasion. Approaching the 1000 metres **LATIN RULE** became awkwardly placed on the heels of **CAGA DANCE** which shifted in slightly with **LATIN RULE** having to be steadied losing ground as a consequence. Hampered as a result was **SHEZASTUNNA** which was following **LATIN RULE**.

LATIN RULE hung out rounding the final turn.

SHEZASTUNNA had to be steadied when awkwardly placed on the heels of **RUSTANA** near the 350 metres.

GETUSTOIT lay in under pressure in the final straight being inconvenienced near the 250 metres when **CAGA DANCE** shifted out away from **RUSTANA**.

EXOTIC had difficulty obtaining clear running approaching the 200 metres.

Race 10 CAMBRIDGE – TE AWAMUTU HARNESS RACING CLUB 1600

CLARA JANE (L Magorrian) which had been reluctant to load was eventually led into its barrier stall with the assistance of a starting attendant. Whilst the starting attendant was still standing in the barrier stall with **CLARA JANE** the start was effected resulting in the starting attendant being knocked to the ground and **CLARA JANE** being severely impeded losing approx. 15-20 lengths. As **CLARA JANE** recovered to finish in third placing, in accordance with Rule 632, there was no provision for the filly to be declared as a non-starter. A full inquiry into the circumstances of this incident was commenced by the Stipendiary Stewards with the matter being adjourned pending further investigation and consideration. The starting attendant involved was uninjured.

I SUGGEST (B Hutton) was slow to begin.

HOLLYWOOD ANGEL (O Bosson) and FORBIDDEN (M Cameron) both began awkwardly.

I SUGGEST became awkwardly placed on heels when being restrained passing the 1400 metres.

Passing the 600 metres KAKAHU NELL (S Collett) was crowded between SEAMS LIKE MAGIC (R Hutchings) and CLARA JANE
