### **RACE COMMENTS:**

Race 1 104.2 MORE FM 3YO MAIDEN 1200M

**ITSALLBELT** began awkwardly and was slow away.

**VICE MARSHALL** hung inwards during the early stages.

**DON'T BLAME BUSTER** raced wide throughout.

**ANOTHER BACHELOR** raced three wide without cover from near the 800 metres.

**R Hannam (ANOTHER BACHELOR)** admitted a charge under Rule 638 (3) (b) of excessive use of his whip prior to the 200 metres. The JCA imposed a fine of \$350.

#### Race 2 LEVIN CRANE HIRE HANDICAP 1200M

GO DANNY was slow to begin.

FRITZY BOY shifted out under pressure inside the final 150 metres.

GO DANNY had to change ground inwards near the 100 metres in order to continue to improve.

**DON'TLIKEMONDAY** returned to the enclosure with blood in a nostril. A subsequent veterinary examination revealed the gelding had suffered a laceration.

#### Race 3

#### **B.S. YOUNG HANDICAP 1600M**

THE MUFFIN MAN raced three wide without cover throughout.

#### Race 4

#### **KAPITI NEWS MAIDEN 1400M**

**RIODORO** began awkwardly.

**RAPT IN GOLD** had some difficulty in obtaining clear running between the 350 metres and the 250 metres.

The connections of the third placed horse **GIPSY STAR** and the fourth placed horse **PREMEAUX** lodged protests against the 2<sup>nd</sup> placed horse **HUNTER STREET** alleging interference inside the final 100 metres. After hearing submissions the Judicial Committee dismissed the protests.

J Riddell (HUNTER STREET) admitted a charge of careless riding under Rule 638 (1) (d) in that he allowed his mount to shift out under pressure crowding PREMEAUX onto GIPSY STAR with all three runners jostling over the concluding stages. The JCA imposed a term of suspension from the close of racing on until the close of racing on 29 July 2013, up until and including 5 August 2013, five riding days.

#### Race 5

### **QUIN BUILDINGS DIRECT HANDICAP 2100M**

ALIGNADREAMS began awkwardly.

**REASONS UNKNOWN** was slow to begin.

**ANOTHERCHANCETAKEN** over raced in the early stages.

**CHEIMON** raced ungenerously when being restrained passing the winning post on the first occasion.

Passing the 400 metres **NGARIO** shifted out under pressure placing **ALIGNADREAM** awkwardly across heels and having to steady.

**SEA KING** hung out throughout the final straight and passing the 200 metres, shifted out and made contact with **JACK ROMANOV.** 

When questioned regarding the performance of **BIRCHINO**, **R Hannam** said the mare failed to handle today's track conditions which he described as holding. A post-race veterinary inspection failed to reveal any abnormalities.

#### Race 6

## **COURTESY FORD RYDER STAKES 1200M (LISTED)**

ATTICA and WEREGOINGTOGETCHA were slow to begin.

AAJA NACHLE and VITESSE ROSE came together leaving the barrier.

**FASCINATION STREET** and **DANCER'S TALE** came together.

**ZANOTTI** shifted in leaving the barrier crowding **TIME TO SPARC** which lost ground.

Shortly after the start SILVER SHADOW shifted out making contact with ZANOTTI which became unbalanced briefly.

**FASCINATION STREET** lay in over the final stages.

**WEREGOINGTOGETCHA** lay in under pressure over the final 200 metres.

When questioned into the run of **DUGAN** which finished at the rear of the field, **H Tinsley** said the gelding was unsuited by the track today. A post-race veterinary examination of **DUGAN** failed to reveal any abnormalities.

### Race 7

## **CHAINEY'S LEVIN HANDICAP 1200M**

**REGALIA** began awkwardly making contact with the hindquarter off **MASH**.

SIR COSWORTH was slow to begin.

OUR ENTOURAGE was slow to begin.

WHISPERING WATERS and SOU'EAST came together leaving the barriers with WHISPERING WATERS becoming unbalanced.

**SIR COSWORTH** raced keenly in the early and middle.

**BARSTORM** shifted out passing the 600 forcing **WHISPERING WATERS** wider on the track. **M Dravitzki (BARSTORM)** was advised to exercise greater care.

**SIR COSWORTH** raced in restricted room over the final stages.

When questioned regarding the performance of **SNOW LINE, A Forbes** reported that the filly failed to handle the heavy track conditions.

## Race 8

## **SUPER LIQUOR LEVIN HANDICAP 1600M**

THE DOLPHIN was slow to begin.

**OUR MOON SHADOW, KINDACOOL** and **LIEUTENANT LINCOLN** all began awkwardly, coming together.

R Hannam (ST RANSOM) admitted a charge under Rule 638 (3) (b) of excessive use of his whip prior to the 200 metres. The JCA imposed a term of suspension from the close of racing on 29 July 2013, up until and including, 2

August 2013, three riding days.

When questioned on the performance of **HAYABUSA**, K Myers advised the mare over-raced in the early stages and had little left when asked for an effort in the final straight.
