RACE COMMENTS:

Race 1	THE DOMINION POST HANDICAP
<p>KEVILDO began awkwardly, crowding DALTORAY. THE LONG RANGER was slow to begin. ROCKWEILER (D Walker) raced fiercely in the middle stages. J Riddell, the rider of BASILDON BOND, was advised to exercise more care when it was observed that near the 900 metre mark he allowed his mount to shift inwards when only marginally clear and this resulted in RACEY RED having to be steadied. THE LONG RANGER raced ungenerously when being steadied in the early and middle stages. MERINDA made the bend passing 400 metres awkwardly, running wide. BASILDON BOND shifted out passing the 400 metres to obtain clear running.</p>	
Race 2	CAVALLO AGISTMENTS 3YO MAIDEN
<p>PETONE PRINCE, LITTLE DRAGON GIRL and IF I CAN I CAN all began awkwardly. ANISETTE was slow to begin. Soon after the start TINKA TINKA was inclined to lay in despite the rider's efforts and as a result SHALLWETELLTHEM had to be steadied and lost its position. ABRAHAM LINCOLN and ANNIESSTAR were also affected in the incident. ANNIESSTAR then commenced to over race for some distance, when being steadied. Near the 900 metres TINKA TINKA got its head up when being steadied into a trailing position behind CRISPNCOOL.</p>	

ABRAHAM LINCOLN raced wide without cover throughout.

TINKA TINKA was held up entering the final straight.

Early in the home straight **SHALLWETELLTHEM** was held up for several strides but when angled out into clear running finished well to win.

Apprentice jockey B Grylls (**MISS PROFESSIONAL**) was issued with a warning under Rule 638(1)(d) after it was observed that she allowed her mount to shift inwards, when struck with the whip near the 200 metres, when insufficiently clear of **CRISPNCOO**L, which was weakening at the time but had to be steadied.

Race 3 THE SOUND OF KAPITI 94.3FM MAIDEN

COLD HEARTED shifted out abruptly leaving the barrier, crowding **POSING GEM** and **PADDY JO** on to **ROSA ROSSA**, which lost ground.

Shortly after **LAJUCA** then shifted in slightly with **OUR SONARE** having to be steadied when awkwardly placed on that runner's heels.

PADDY JO over raced when being restrained in the early and middle stages.

Passing the 1000 metres **COLD HEARTED** commenced to race fiercely when being restrained off the heels of **LAJUCA** which shifted in, with **COLD HEARTED** continuing to race fiercely through the middle stages.

PADDY JO raced wide without cover throughout.

Following the race, **OUR SONARE** was reported to have blood in the left nostril. However after undergoing a veterinary examination, **OUR SONARE** was found to have a small cut in the nostril. **OUR SONARE** is not classed as a bleeder.

DUCK FOR COVER underwent a veterinary examination following the race and was found to be suffering from cardiac arrhythmia and will require a clear ECG following a trial before the filly is permitted to race.

Race 4 HOROWHENUA SHELTER TRIMMERS MAIDEN

OURBLACKISLE, which became fractious in the parade ring, made contact with the outside fence, undergoing a veterinary examination behind the barriers and was cleared to start. The rider was checked by ambulance staff at the barrier and cleared.

ALOTARANZAU was slow away then shifted out abruptly becoming unbalanced.

OURBLACKISLE began awkwardly losing ground. **OURBLACKISLE** raced ungenerously in the early and middle stages when being restrained. **OURBLACKISLE** raced wide without cover for the majority of the race.

KINDACOOL raced wide without cover throughout.

MONNIE hung throughout the race and once into the home straight could not be ridden out to full advantage because of its hanging tendencies.

MAURRAL shifted out in the home straight when placed under pressure.

HOLY SMOKE (H Tinsley), dropped to the rear early in the race and despite the rider's urgings, raced three lengths behind the second last horse in the run down the back straight and around the bend. Once in the home straight and angled out into clear running **HOLY SMOKE** finished on well for third placing. It was observed that rider H Tinsley was unable to ride the horse to full advantage in the home straight due to the gelding's tendency to lug in. When questioned, Jockey Tinsley stated that **HOLY SMOKE** had lugged throughout the race.

Race 5 THE ROCK 91.9FM HANDICAP

STUERTZER began awkwardly and shifted in, crowding **CANSO**, which lost ground.

KING LEONIDAS began awkwardly.

FLOAISHA had to be steadied near the 2000 metres when awkwardly placed on the heels of **STUERTZER**, which shifted in.

MR KEENINSKY raced wide without cover for the majority of the race. When questioned regarding the performance of **MR KEENINSKY**, rider H Tinsley reported that the gelding had not been helped when required to race wide throughout but had failed to respond when placed under pressure in the final straight.

Race 6 MILLS REEF WINERY HANDICAP

I AM LEO began awkwardly shifting in crowding **THE MONEYZMINE** which had been slow to begin.

SIR COSWORTH shifted in leaving the barrier, crowding **BRIGHT GLO**, **HANAMI** and **ANAGRAM** with **ANAGRAM** and **HANAMI** losing ground as a result.

KINGS COURT and **SURREAL STORM** came together when leaving the barriers; then both runners raced ungenerously in the early stages when being restrained.

I AM LEO over raced in the early and middle stages and got its head up on several occasions when being restrained.

SURREAL STORM raced wide without cover throughout.

SECOND HOPE was held up early in the home straight until near the 200 metres.

BRIGHT GLO was held up early in the home straight and was unable to find clear running until the 100 metres.

Race 7**AUTOMOTIVEPRYDE LEVIN HANDICAP**

THE BACHELOR shifted out abruptly leaving the barrier, causing crowding to **MINT, DOWN TOWN, VICTOR ALBERTO, CHOCOLATE CAKE, JOKRAAR and GET THE MESSAGE**; contributing was slight inward movement from **JULINSKY PRINCE**. **HEIR SUPPLY** and **LADY SHANNON** came together leaving the barrier when both runners began awkwardly. **THE PRINCE OF POP** raced wide without cover throughout. **LADY SHANNON** lay in under pressure in the final straight. **MINT** was held up for several strides near the 200 metre mark until being angled inwards to clear running.
