RACE COMMENTS:

Race 1	Cowley's Hire Centre 2100
<p>MISTER TROY (R Norvall) and ZEPHYROS (B Hutton) both jumped away awkwardly.</p> <p>THE LAST STAR WAY (R Hutchings) was slow away.</p> <p>LUCY BEE (A Collett) shifted in when leaving the barriers making contact with DUEL OF HONOUR (S Spratt).</p> <p>TOMMY RIKI (T Thornton) over-raced in the middle stages.</p> <p>ZEPHYROS raced wide without cover throughout.</p> <p>Rider B Hutton (ZEPHYROS) reported that his mount had got its tongue over the bit during the running.</p> <p>TOMMY RIKI was held up rounding the final turn and continued to have some difficulty obtaining clear running in the final straight when inclined to lay in under pressure.</p> <p>RIVA BALLERINA (C Grylls) and THE LAST STAR WAY came together entering the final straight near the 400 metres with RIVA BALLERINA then racing greenly under pressure in the final straight.</p> <p>Rider S Spratt was unable to offer any excuses for the disappointing performance of DUEL OF HONOUR.</p>	
Race 2	The Northern Advocate 1600
<p>PIXIE (S Collett) shifted in on leaving the barriers inconveniencing AEROSPACE (C Grylls) which had begun awkwardly.</p> <p>BELFAST BOY (P Taylor) was slow to begin.</p> <p>TE ATATU PRINCESS (M Hills) commenced to hang outwards rounding the turn approaching the 600 metres and continued to hang badly for the remainder of the race. As a result TE ATATU PRINCESS could not be ridden out to any extent by its rider. Trainer S Broughton was advised that a warning would be placed on the mare's record for its racing manners.</p>	

Race 3	Lion Red 1200
<p>LADY MARILYN (M Du Plessis) was slow to begin.</p> <p>AIMEES GOLD (M Sweeney) shifted in on jumping away making contact with HE'S ROCK'N'ROLL (P Taylor) forcing that runner on to LA PINNICLE (R Smyth) which in turn shifted in on to FINTORRO (B Hutton) with that runner losing ground.</p> <p>LADY MARILYN which was slow to begin was then further hampered by HER CHOICE (M Hills) which shifted out when jumping away.</p> <p>HER CHOICE raced three wide without cover.</p> <p>CLUBS CHOICE (T Thornton) lay out rounding the final turn.</p> <p>LADY MARILYN which was reluctant to improve into a run between SAFFRON (C Grylls) and HER CHOICE shifted in across the heels of SAFFRON to obtain clear running approaching the 100 metres.</p> <p>M Hills, the rider of HER CHOICE, when questioned into the performance of the filly stated that after being trapped wide throughout the filly had failed to finish the race off in its first run back from a break but in his opinion would benefit from the outing.</p>	
Race 4	More FM Northland Saturday Sports Desk
<p>RUSTY LACE proved very unruly during its preliminary with Rider M Hills once bringing the filly under control advising that he had great concerns over its manners and ability to be steered. RUSTY LACE was then declared a late scratching at 2.35pm with Trainer K Knight advised that the filly must barrier trial to the satisfaction of a Stipendiary Steward prior to racing again.</p> <p>FAIRY STORY (S Spratt) was slow to begin then further hampered when BEL AMI (S Collett) shifted in abruptly.</p> <p>AFFOGATO (R Norvall) and EL PRIMO (C Grylls) made firm contact when leaving the barriers when both runners shifted ground. Both runners were further hampered when YEAH BRO (P Taylor) lay in after leaving the barriers. YEAH BRO continued to race erratically in the early stages.</p> <p>AFFOGATO made the bend near the 800 metres awkwardly shifting out forcing YEAH BRO, which was continuing to race ungenerously, wider on the track. YEAH BRO then hung outwards around the bend.</p> <p>AFFOGATO raced greenly in the final straight when well back.</p> <p>When weighing in after the race Apprentice T Wenn was found to be 1kg less than the proper weight required to be carried by her mount KEENTORULE. A request for a ruling was filed with the Judicial Committee who determined that KEENTORULE would be disqualified from 4th placing under the provisions of Rule 648(3).</p> <p>T Wenn subsequently admitted a breach of Rule 649(3) and was suspended from the conclusion of racing on 15 August 2013 until the conclusion of racing on 24 August 2013, 5 riding days, with the riding fee also to be forfeited.</p>	
Race 5	Fell Engineering 1400
<p>DEANE MARTIN (M Du Plessis) was slow away.</p> <p>DEANE MARTIN was steadied off the heels of BALDOVINO (R Hutchings) passing the 1000 metres.</p> <p>A post-race veterinary examination of CONG'ER which raced poorly found the mare to have suffered from cardiac arrhythmia. The Stable Representative was advised that the mare is required to trial with a veterinary certificate of fitness including ECG results to be provided prior to racing next.</p>	
Race 6	JLT Bloodstock 1600
<p>LE COUGUAR (T Thornton) over-raced in the early to middle stages.</p> <p>LE COUGUAR lay in under pressure in the final straight.</p> <p>When questioned regarding the disappointing performance of HONEYMOON Rider L Innes was of the opinion that the mare had failed to back up after racing the previous Saturday. HONEYMOON underwent a post-race veterinary examination which did not reveal any abnormalities.</p>	
Race 7	A'Fare Caterers 1400
<p>PIAZZETTA dislodged its rider during the preliminaries and took some time to be recaptured being declared a late scratching at 4.20pm. Rider L Innes was attended to by ambulance personnel for a minor knee injury.</p> <p>RANSOMLASS (R Norvall) was slow to begin.</p> <p>HENNESSY BLACK (S Spratt) shifted in leaving the barriers making contact with STACKED (M Hills).</p> <p>DRAGONSTONE (T Thornton) jumped away awkwardly.</p> <p>BURNT ORANGE made the bend near the 800 metres awkwardly when racing greenly. Rider M Du Plessis advised that the gelding had raced greenly throughout.</p> <p>DRAGONSTONE over-raced when being restrained in the middle stages.</p> <p>FOG ON THE TYNE (R Hutchings) raced greenly throughout.</p> <p>DRAGONSTONE raced greenly under pressure in the final straight.</p>
