Race 1	LIQUORLAND TE AWAMUTU 1150			
ALBERTA (B R Jones) was declared a late scratching at 12.44 pm after refusing to enter the barriers. Trainer M Lupton was				
advised that ALBERTA is required to trial to the satisfaction of a Stipendiary Steward prior to racing next.				
I'MDAONE (C Grylls) was slow to begin, then got its head up when making the bend near the 800 metres awkwardly.				
SKYDIVER (T Thornton) raced three wide without cover throughout, and was inclined to lay in from the 600 metres.				
SIR ANDREW (M Du Plessis) over-raced in the middle stages.				
D Johnson admitted a breach of careless riding in that she permitted her mount STELLA VEGA to shift outwards near the				
400 metres when not sufficiently clear of WAIRERE (M Sweeney) which was checked. After hearing submissions the				
Judicial Committee suspended Miss Johnson from the conclusion of racing on Saturday 24 August until the conclusion of				
racing on Friday 30 August, 4 riding days, and in addition imposed a fine of \$600.				
Race 2	BOUTIQUE AGISTMENT 1150			
RED MOON (C Grylls) blundered jumping away.				
KONTIKI (K Leung) lay out shortly after leaving the barriers hampering RED MOON and ELUSIVE DANCER (K Myers).				
THEODORE (M Hills) raced wide without cover.				
READY TO ROCKNROLL (S Collett) was taken out slightly by MRS BROWNS BOY (R Smyth) passing the 500 metres				
hampering EMBLEM (M Sweeney) and EL CORBY (R Norvall).				
ELUSIVE DANCER was held up near the 350 metres making contact with EL CORBY.				
<b>READY TO ROCKNROLL</b> lay in under pressure near the 200 metres with <b>MRS BROWNS BOY</b> shifting away from that runner				
inconveniencing <b>PAJARO</b> (M Du Plessis).				
Race 3	COMMERCIAL HOTEL TE AWAMUTU 1400			
MAYBE LATER (K Myers) and REACHFORTHESTARS (M McNab) were both slow to begin.				

**BORN HAPPY** (M Cheung) shifted in on jumping away forcing **THE ENERGIZER** (A Forbes) on to **HIDDEN KEY** (D Johnson) with that runner losing ground.

**GARDEN OF GOLD** (M Du Plessis) got its head up when over-racing approaching the bend near the 1200 metres and continued to over-race through middle stages.

**THE ENERGIZER** appeared to shy and shifted outwards abruptly passing the 150 metres. Co-trainer Mr H Allen advised that he would be looking to add blinkers to the gelding's gear for its next start.

A post-race veterinary examination of **HIDDEN KEY** (D Johnson) found the gelding to be mildly lame in the right hind leg having suffered a laceration to the pastern.

### Race 4 PAM CROSSWELL 1580

BOGART (D Nolan) was slow to begin.

SWEET 'N' SAVVY (C Grylls) jumped away awkwardly.

FINNYS GOLD (T Thornton) blundered jumping away.

**AMARLIA** (A Collett) began awkwardly and shifted out making firm contact with **I'M ALL YOURS** (R Hutchings) with **PERFECTLY CLEVER** (D Hain) then shifting away from **I'M ALL YOURS** into the line of **ROMPERS** (M Du Plessis) which clipped a heel and blundered.

**MADAME MILLIE** (S Collett) raced keenly in the lead through the early and middle stages and was inclined to lay out throughout the race.

Crossing the junction on to the course proper passing the 1400 metres **BOGART** (D Nolan) had to be steadied when awkwardly placed on the heels of **WAYWARD WONDER** (B R Jones).

When questioned regarding the poor performance of **ROMPERS** rider M Du Plessis advised that the mare had never travelled comfortably. A post-race veterinary examination did not reveal any abnormalities.

#### Race 5 FAIRVIEW MOTORS 1580

**POSTAGE** (K Chiong) and **DUNTOILIN** (M Coleman) were both slow to begin.

**POSTAGE** raced wide throughout.

Race 6 EL HERMANO @ CHEVAL STUD 1580

KAKAHU NELL (S Collett) and NOTTOOBAD (D Johnson) were both slow to begin.

KATI CAT (C Grylls) got its head up when being restrained making the bend near the 1200 metres awkwardly.

MOVE FASTER (D Nolan) was held up near the 400 metres.

**NOTTOOBAD** lay in passing the 400 metres making contact with **CARDON BOY** (T Thornton) which then shifted in away from that runner hampering **CARBONADO** (M Cropp).

Race 7 IRWIN'S TRUCK AND BUS SALES LTD 1150

SUPER THUNDER (S Collett) and DUKE DUMONT (D Johnson) were both slow to begin.

**POGUE** (R Hutchings) lay out shortly after the start hampering **REMINISCING** (M Cameron) which was forced on to **DUKE DUMONT** which lost ground.

**DUKE DUMONT** had to be steadied passing the 1000 metres when racing in restricted room making contact with the hind quarters of **REMINISCING**. As a result **DUKE DUMONT** had to be firmly restrained when forced across the heels of **HUG A GINGA** (N Harris).

Race 8 STEVE HERBERT 2000

When questioned regarding the performance of **TE KINGI** which was a beaten runner passing the 800 metres rider B R Jones advised that the gelding had failed to handle today's track conditions and had hung outwards. A post-race veterinary examination did not reveal any abnormalities.

WATTLE BAY (D Turner) lay out under pressure in the final straight.
