# RACE COMMENTS:

# Race 1 COUNTIES SUPPORTERS CLUB 2200

SINISTA (D Hain) was slow to begin.

PYTHIA (M Dee), PIXIE (L Magorrian) and NOSECONDPRIZE (L Inness) all began awkwardly.

SINISTA (D Hain) travelled wide without cover from near the 1000 metres.

**CATCH ON** (S Spratt) lay in under pressure passing the 300 metres making contact with **THE RECIDIVIST** (A Collett). **THE RECIDIVIST** then raced in restricted room for a distance.

Race 2 KENAMON INVESTMENTS 1200

ALBERTA (B R Jones) was a late scratching at 1.11 pm after refusing to enter the barrier stall. Trainer M Lupton was advised

that the mare is required to barrier trial to the satisfaction of Stewards prior to racing next. Trainer M Lupton indicated that he was unlikely to persevere with the mare as a racing proposition.

SO DANSO (A Collett) shifted in jumping away, crowding IMMIGRATION (C Grylls).

FALKIRK'S HONOUR (M Du Plessis) began awkwardly.

**IMMIGRATION** and **SO DANSO** both over-raced in the early stages.

LEICA MY BLING (T Thornton) made the bend awkwardly passing the 900 metres hanging out.

BORN HAPPY (O Bosson) and RIO SYRAH (S Spratt) raced wide without cover throughout.

**FALKIRK'S HONOUR** raced in restricted room passing the 600 metres.

CRAFTY LOVE (Linnes) was held up early in the final straight shifting out passing the 300 metres to obtain clear running.

When questioned regarding the riding tactics adopted aboard **ALWAYS ON MY MIND** apprentice rider M Dee advised Stewards that he had been instructed to ride the mare forward and try and obtain cover. M Dee further stated that **ALWAYS ON MY MIND** had begun well, but failed to show enough speed in the early stages to take up a prominent position and he had elected to take cover where he could find it.

#### Race 3 ITM GJ WECK & SONS LTD 1200

**FLEDGEKIN** (B R Jones) shifted in jumping away, making contact with **ANOTHER EMPEROR** (M Hills) which became briefly unbalanced.

**SECRET DEW** (S Collett) began awkwardly, losing ground.

**SINISTER MAN** (C Grylls) shifted in after jumping away, making contact with **ROCKNROLLA** (M Cameron) which became briefly unbalanced.

**READY TO RUMBLE** (D Nolan) began awkwardly, losing ground.

Passing the 1100 metres **BLACK MASCARA** (T Thornton) was steadied when racing in restricted room to the inside of **CHANEL NUMBER FIVE** (M McNab) which shifted in and away from **ELUSIVE UNICORN** (S Spratt) which was dictated in by **BRITT EKLAND** (M Dee). M Dee was reprimanded by Stewards and advised that a warning would be placed on his record.

**ROCKNROLLA** commenced to hang outwards approaching the bend near the 1000 metres running wide. As a result **SINISTER MAN** which was racing to the outside of **ROCKNROLLA**, was forced over extra ground. **SINISTER MAN** was then obliged to race three wide without cover for the remainder of the race. **ROCKNROLLA** continued to hang out losing contact with the body of the field. Trainer Mr D Logan was advised that **ROCKNROLLA** would be required to barrier trial to the satisfaction of Stewards before being permitted to race again.

**BRITT EKLAND** was inclined to lay out once placed under pressure approaching the 200 metres, and continued to do so for the remainder of the race.

## Race 4 SO WOTIF PUKEKOHE PARK HORSE OF THE YEAR 1400

**FIROSTEFANI** was a late scratching at 12.08 pm after Trainer G Richardson reported that the filly had been injured in transit to the races.

**FAST LEARNER** (A Collett) jumped in the air at the start, losing ground.

**LONGBEACH** (O Bosson) began awkwardly, shifting out, making contact with **EYE CONTACT** (K Leung) which became briefly unbalanced.

**CHINSKY** (S Spratt) began awkwardly.

Shortly after the start **SHOW MACCOOL** (P Taylor) shifted out abruptly, forcing **CHINSKY** out on to **RISING ROMANCE** (M Coleman) with **CHINSKY** and **RISING ROMANCE** becoming briefly unbalanced.

Approaching the 1200 metres LONGBEACH raced ungenerously when being restrained.

Passing the 1200 metres **DAHLS DELIGHT** (B R Jones) raced fiercely when being restrained, and then over-raced through the middle stages.

I GOTTA HUNCH (M Hills) was inclined to over-race in the early and middle stages.

**RISING ROMANCE** raced wide without cover throughout.

LADY LE FAY (M McNab) was inclined to race greenly when placed under pressure in the final straight.

**CHINSKY** raced greenly throughout.

# Race 5 AUCKLAND THOROUGHBRED BREEDERS GOLF DAY NOV 22 1400

As **SEATHEKLOUDS** was being brought forward to load into the barrier the gelding reared over backwards dislodging Apprentice Jockey K Leung. **SEAKTHEKLOUDS** fractured its neck on impact with the ground, failing to regain consciousness

**MALCOLM** (D Hain) and **FILLE DU ROI** (M McNab) were crowded jumping away, losing ground, between **MADETOMEASURE** (B R Jones) and **DJANGO** (S Spratt) when both those runners shifted ground.

ANNAMEIKA (M Dee) began awkwardly.

**ANNAMEIKA** commenced to hang out when making the bend passing the 1000 metres. **ANNAMEIKA** then continued to hang outwards and was obliged to race three wide without cover.

FILLE DU ROI was held up early in the final straight, improving into a narrow run passing the 350 metres. FILLE DU

**ROI** then raced in restricted room passing the 300 metres.

IT'S GOT TO BE YOU (C Grylls) raced greenly and lay out under pressure over the final 200 metres.

When questioned regarding the performance of **ANNAMEIKA** M Dee explained after the mare had hung out making the first bend she had continued to hang, placing him at a disadvantage for the remainder of the race.

### Race 6 COUNTIES FUNCTION CENTRE 1400

**DILLON HALL** (M Du Plessis) and **FULL MONTY** (C Grylls) both began awkwardly.

**DILLON HALL** raced ungenerously when being restrained in the early and middle stages.

CAV IN THE CASTLE (J Whiteside) was obliged to race wide without cover throughout.

Approaching the 300 metres **FULL MONTY** raced in restricted room to the inside of **ITSFORFREE** (R Smyth) which lay in.

A post-race veterinary examination of **DILLON HALL** failed to find any obvious abnormalities. Rider M Du Plessis reported to Stewards that **DILLON HALL** raced for the majority of the race with its tongue over the bit. Trainer B Purdon advised Stewards that he would experiment with gear changes. **DILLON HALL** lost the off fore plate during the running

When questioned regarding the performance of **SWEET MILLICENT**, rider M Hills advised that the mare would prefer rain-affected footing.

### Race 7 POWELL TRANSPORT LTD 1200

**ADOLAY** (M Dee) and **AIRMAN** (S Spratt) became fractious in their respective barrier stalls and were both removed to undergo veterinary examinations. **ADOLAY** was cleared fit to race and **AIRMAN** declared a late scratching at 4.07 pm acting on veterinary advice.

**SUNBEAM** (M Coleman) began awkwardly making contact with **HE SURE IS** (A Forbes), and then shifted back in abruptly making contact with **BUCKS BACK** (M Cameron) which became unbalanced.

**BRELA BELLE** (M Du Plessis) was hampered leaving the barrier, between **ADOLAY** (M Dee) and **KALEIDOSCOPE** (K Leung) when both those runners shifted ground.

**RED DAKOTA** (L Innes) began awkwardly.

**RED DAKOTA** commenced to over-race passing the 700 metres for a distance.

**KALEIDOSCOPE** over-raced through the middle stages becoming awkwardly placed on heels and shifting out abruptly passing the 650 metres hampering **BRELA BELLE**.

**SUNBEAM** was unable to obtain clear running in the final straight.

**ADOLAY** was held up in the final straight until near the 200 metres.

MRS NEAT (T Wenn) shifted in under pressure over the final 50 metres, crowding RED DAKOTA and KALEIDOSCOPE which had to steady. Apprentice rider T Wenn was reprimanded by Stewards and advised that she must take corrective action sooner than she had on this occasion. Apprentice rider T Wenn had a warning placed on her record.

**KALEIDOSCOPE** lost the off hind plate during the running, and returned to the enclosure with a laceration to the off foreleg which required veterinary attention.

# Race 8 EIF INTERNATIONAL LTD 1600

**EXABELLE** (M Cameron) and **MR RIMFIRE** (D Nolan) both began awkwardly.

**BLACK ATTACK** (S Collett) stumbled, jumping away.

Passing the 150 metres RAP N TAP (C Grylls) was placed in restricted room between MR RIMFIRE (D Nolan) which shifted out and PIAZZETTA (M Coleman) which shifted in, despite the efforts of their respective riders. RAP N TAP had to steady as a result.

MR RIMFIRE and PIAZZETTA made contact inside the final 50 metres when both runners shifted ground.

MR RIMFIRE returned to the enclosure with blood present in both nostrils. After undergoing a veterinary examination MR RIMFIRE was deemed to be a bleeder and as such is subject to the mandatory three month stand down from racing in New Zealand and must be passed fit by a veterinarian after a gallop of at least 1000 metres prior to racing or trialing again.

Rider C Grylls the rider of **RAP N TAP** was reminded of his obligation to ride his mounts fully to the line when circumstances permit him to do so.

## Race 9 MITRE 10 MEGA PUKEKOHE 1600

**HONEYMOON** (M Cameron) proved fractious in the barrier, rearing. **HONEYMOON** was removed to undergo a veterinary examination and cleared fit to race.

VOLCANO (B R Jones), BELLINO (L Magorrian) and EVEN BETTER (S Collett) all began awkwardly.

Approaching the 1100 metres **ETOILE FILANTE** (M Du Plessis) had to steady when placed in restricted room to the inside of **ZINKO** (T Thornton) which shifted in. **ETOILE FILANTE** then raced keenly for a distance. T Thornton was reprimanded and

advised she must exercise greater care when shifting ground.

PAYDAY (A Forbes) raced ungenerously when being restrained near the 1100 metres.

Passing the 900 metres **URBAN ANGEL** (M Dee) raced ungenerously when being restrained off the heels of **AUSPICIOUS** (A Collett).

**URBAN ANGEL** (M Dee) shifted out when looking to obtain clear running passing the 450 metres, making contact with **ETOILE FILANTE** which became briefly unbalanced.

**AUSPICIOUS** returned to the enclosure showing signs of lameness. **AUSPICIOUS** underwent a veterinary examination which revealed the mare to be lame in the left hind leg. Connections advised **AUSPICIOUS** would undergo a further veterinary examination upon return to its stable with results to be forwarded to Stewards.

## Race 10 DHL COUNTIES CUP DAY SAT 23 NOV 1600

PROUD LIFE (O Bosson) began awkwardly.

**MOOZOON** (S Spratt) was crowded jumping away, between **LUSHOTO** (M Du Plessis) and **LABOMBA** (R Smyth) when both of those runners had begun awkwardly, shifting ground.

KING SIZE (T Thornton) was slow away.

**CLOVELLY** (D Nolan) and **CHAZELLE** (S Collett) both began awkwardly making contact with rider D Nolan becoming briefly unbalanced.

Linking on to the course proper near the 1400 metres **PROUD LIFE**, **THE FIRE INSIDE** (M Sweeney), **LUSHOTO** (M Du Plessis), **LABOMBA** and **KING SIZE** all commenced to race greenly with **KING SIZE** and **LABOMBA** shifting out abruptly inconveniencing **CYCLONE TRACY** (M Hills) and **CLOVELLY**.

**ON THE MAT** (M Wenn) raced ungenerously when being restrained in the early stages.

Approaching the 400 metres **LUSHOTO** shifted away from **MY MESTARI** (A Forbes) making contact with **LABOMBA** which was steadied. **LABOMBA** then raced in restricted room.

Approaching the 350 metres CYCLONE TRACY lay in when attempting to improve into a marginal run between EYESLUCKY and CLOVELLY. CYCLONE TRACY was then held up.

**PROUD LIFE** had difficulty obtaining clear running early in the final straight and made contact with **MY MESTARI** passing the 200 metres.

Near the 200 metres **THE FIRE INSIDE** shifted out to obtain clear running, with **ON THE MAT** then shifting away from that runner, making contact with **PROUD LIFE** with both runners becoming briefly unbalanced.

EYESLUCKY (D Hain) raced wide without cover throughout.
