RACE COMMENTS:

Race 1	MILLS REEF WINERY & RESTAURANT 1600
<p>WAYWARD WONDER (B Grylls) was slow to begin.</p> <p>CURSIVE (D Johnson) knuckled when leaving the barrier.</p> <p>A L'ORANGE (M Coleman) got its head up when over racing in the early stages.</p> <p>EN'JOYOUR LINDAUER (J Oliver) raced wide without cover throughout.</p> <p>Passing the 800 metres CHOYSA (M McNab) shifted out when racing ungenerously, making contact with CURSIVE and then shifted back in, becoming awkwardly placed on the heels of WAYWARD WONDER.</p> <p>Passing the 400 metres BAGSAGOLD (T Thornton) became awkwardly placed on the heels of VILLARS (O Bosson) which shifted in, having to steady. Jockey O Bosson was reprimanded and advised by Stewards he must exercise greater care.</p> <p>VILLARS was inclined to lay out when placed under pressure in the final stages.</p>	

CURSIVE shifted in passing the 50 metres inconveniencing **A L'ORANGE**.
When questioned regarding the performance of **BAGSAGOLD** Rider T Thornton could offer no tangible excuse.

Race 2 | **O'CONNOR WARREN INSURANCE 3YO**

BLACK MASCARA (T Thornton), **MATAGOURI** (M Dee) and **COSMIC CUBE** (R Hutchings) all began awkwardly, losing ground.
ALTAI ROSE (C Grylls) began awkwardly.
FAST LEARNER (A Collett) **ALTAI ROSE** and **MATAGOURI** all raced fiercely in the early stages on a moderate pace. Approaching the 900 metres **KENTUCKY SON** (J Jago) shifted out off the heels of **ALTAI ROSE**, forcing **VITESSE ROSE** (S Spratt) to race three wide without cover for the remainder of the race.
ALTI ROSE continued to over-race through the middle stages.
COSMIC CUBE improved forward quickly to sit outside the leader passing the 900 metres.
KENTUCKY SON was denied clear racing room passing the 300 metres when attempting to run outside **COSMIC CUBE**. Passing the 200 metres **ALTAI ROSE** improved into a narrow run between **FAST LEARNER** and **MATAGOURI** with **FAST LEARNER** then shifting out under pressure with **ALTAI ROSE** becoming awkwardly placed on heels having to steady. Apprentice rider A Collett was severely reprimanded by Stewards and advised that a warning would be placed on her record.
BLACK MASCARA raced greenly inside the final 100 metres shifting away from **FRAAJILISTIC** (D Johnson) inconveniencing **COSMIC CUBE**.
When questioned regarding the performance of **COSMIC CUBE** apprentice rider R Hutchings advised that the colt had not responded as it expected once placed under pressure in the final straight and he believed the impost of 59 kilograms had a bearing on the performance.

Race 3 | **GARTSHORE CONSTRUCTION 1400**

Leaving the barriers **RICH'N UNHITCHED** (M Hills) was placed in restricted room when runners to either side shifted ground.
WORTHING (M McNab) shifted out when jumping away, making contact with **FLEUR DE LUNE** (V Gatu).
FLEUR DE LUNE was obliged to race three wide without cover throughout.
SPIN DOCTOR (S Spratt) raced ungenerously when being steadied in the early stages. **SPIN DOCTOR** then raced in restricted room passing the 1000 metres to the inside of **FLEUR DE LUNE** which shifted in with **SPIN DOCTOR** having to steady. Apprentice rider V Gatu was advised she must exercise greater care.
Passing the 300 metres **SPIN DOCTOR** raced in restricted room to the outside of **RICH'N UNHITCHED** which shifted out to obtain clear running. **I DO** (D Turner) then lay in under pressure crowding **SPIN DOCTOR** which made contact with the hind quarters of **RICH'N UNHITCHED** who became unbalanced. Stewards were satisfied the movement from **I DO** was beyond the control of apprentice rider D Turner.
USAINITY (O Bosson) returned to the enclosure showing signs of lameness. **USAINITY** received veterinary attention following the race for a laceration on the front and left hind cannon, with Trainer M Baker undertaking to report the progress of **USAINITY** in days subsequent. **USAINITY** lost the off fore plate during the running

Race 4 | **PACIFIC COAST TECHNICAL INSTITUTE 1200**

TWIST OF FATE (A Collett) was slow to begin.
FLICKA OF GOLD (M Coleman) jumped away awkwardly.
THEBESTOFYOU (M Dee) was obliged to race wide without cover throughout.
SEA MAJOR (T Thornton) raced ungenerously when being steadied in the middle stages and passing the 800 metres became awkwardly placed inside the heels of **POPPAS DELIGHT** (C Grylls). **SEA MAJOR** (T Thornton) then over-raced for a distance.
STITCHENTYNE (O Bosson) was held up early in the final straight shifting out passing the 250 metres and making contact with **POPPAS DELIGHT** which became briefly unbalanced.
Apprentice rider B Grylls the rider of **LITTLE PEPPER** dropped her whip near the 300 metres.
Following the race **FLICKA OF GOLD** dislodged rider M Coleman. After undergoing a medical examination, M Coleman was found to be uninjured.
SCORCHING (K Chiong) lost an off-hind plate.

Race 5 | **SEA CONTAINERS NZ LTD 2100**

INIS ROSE (D Johnson) was slow away.
Passing the winning post on the first occasion, **DELICIANO** (J Riddell), **BEAUTY PERCEPTION** (C Grylls) and **CAPO** (T Thornton) all raced in restricted room to the inside of **BELLINO** (D Nolan) for a distance with **DELICIANO** and **BEAUTY PERCEPTION** both being buffeted and becoming unbalanced. D Nolan was severely reprimanded by Stewards and

advised a warning would be placed on his record.

Passing the 900 metres **CAPO** (T Thornton) and **SAINT COLUMBU** (M Dee) were crowded by **DELICIANO** which shifted in. J Riddell was reprimanded by Stewards and a warning placed on his record.

Rider O Bosson advised that **BELLAZEEL** had never travelled comfortably throughout the race. A post-race veterinary examination of **BELLAZEEL** found the mare to have a respiratory infection and also a slower than normal recovery. Trainer R James was advised that a veterinary clearance would be required prior to the mare racing again.

Rider D Johnson reported that **INIS ROSE** had not been comfortable soon after leaving the barriers with **INIS ROSE** being retired from the race passing the 1500 metres. A post-race veterinary examination found the mare to be suffering from a respiratory complaint with also a slow recovery. L Noble advised Stewards that **INIS ROSE** had undergone a full veterinary examination upon return to his stables and was found to have dirt in the trachea, consistent with having swallowed a clod.

Race 6	KONING WEBSTER LAWYERS TAURANGA 1200

Apprentice rider R Hutchings was fined \$200 after failing to make the contracted weight for **TRENDY**.

CALYPSO underwent a veterinary examination after making heavy contact with the barrier, before being cleared fit to race.

AGENT ZIVA (M Coleman) jumped away awkwardly.

WAINUI PRINCE (T Thornton) was slow to begin.

TRENDY (J Parkes) got its head up making the bend awkwardly near the 800 metres.

WAINUI PRINCE raced ungenerously making the bend near the 800 metres, shifting out, forcing **AGENT ZIVA** (M Coleman) over extra ground. **WAINUI PRINCE** then raced fiercely in the middle stages.

TRENDY was held up for clear running between the 350 metres and 200 metres.

AGENT ZIVA shifted out under pressure passing the 150 metres inconveniencing the tiring **WAINUI PRINCE**.

Race 7	STELLA ARTOIS TAURANGA STAKES

POSTMANS DAUGHTER was withdrawn from the race by order of the Stewards at 3.11pm under Rule 209 (1)(c) when the mare was observed to have an unidentified substance administered to her. An inquiry was opened and adjourned pending further investigation.

SURVIVED (O Bosson) jumped away awkwardly.

MAXIMUM HEIGHT (T Thornton) raced keenly in the early and middle stages.

VIADANA (C Grylls) had to be steadied off the heels of **ZENNISTA** (J Riddell) when the pace eased.

Passing the 1200 metres **HAPPY GUYS** (M Coleman) and **MAXIMUM HEIGHT** raced in restricted room to the inside of **SURVIVED** which shifted in, with **HAPPY GUYS** having to steady. Contributing to the incident with the racing manners of **HAPPY GUYS** and **MAXIMUM HEIGHT** which both over-raced when being restrained.

Race 8	MEDITERRANEAN SHIPPING CO 1600

ETOILE FILANTE (D Johnson) and **ELUSIVE GOLD** (O Bosson) came together leaving the barrier.

OHOPE PRINCE (M Dee) over raced when being restrained for a distance passing the 1100 metres. **OHOPE PRINCE** was then obliged to race wide without cover.

Passing the 500 metres **KATI CAT** (T Thornton) commenced to give ground with **FASTNFREE** (K Chiong) becoming awkwardly place on that runners heels and shifting in, then having to steady.

ELUSIVE GOLD made contact with **OHOPE PRINCE** approaching the 300 metres when looking to obtain clear running.

OHOPE PRINCE became briefly unbalanced as a result.

Race 9	GILMOURS TAURANGA 1600

QUICKASUCAN (R Hutchings) and **SCHRODINGERS CAT** (A Collett) were both slow to begin.

SONOZA (D Johnson) and **MANNY** (M McNab) both shifted in abruptly leaving the barriers crowding **LADY GRANGELEA** (M Sweeney).

SAKHEE'S SOLDIER began awkwardly, shifting out, unbalancing rider O Bosson.

GARDEZ LA FOI (M Dee) over-raced when being restrained in the middle stages.

KEPT IN STYLE (M Wenn) raced wide before improving forward approaching the 700 metres when shifting in and crowding **LADY GRANGELEA** which was hampered. Footage of the incident proved inconclusive with M Wenn being reprimanded by Stewards and advised that a warning would be placed on her record.

SATEKA (C Dell) and **WAIRAKA** (G Grylls) both raced wide without cover throughout.

When questioned regarding the performance of **SAKHEE'S SOLDIER**, rider O Bosson explained that the gelding had raced greenly amongst runners and had not quickened as anticipated once placed under pressure in the final straight. Connections advised that **SAKHEE'S SOLDIER** would now be spelled.
