Race 1 BAY FORD NZ PUNTER OF THE YEAR OCT 5TH

GO PADDY (M Du Plessis) was slow away.

BEAU ZED (B Grylls) was slow away.

ILLUMINATING (K Myers) shifted out at the start simultaneously as **CANTERINO** (L Innes) shifted in resulting in **JABEZ** (C Grylls), **SAVAROSE** (D Walker), and **DAISY LOUISE** (M Cameron) all being tightened.

SAVAROSE raced keenly early.

GO PADDY raced three wide and was inclined to hang inwards throughout.

JABEZ was trapped wide early so was taken forward to lead near the 1300 metres.

Shortly after entering the back straight **DAISY LOUISE** was buffeted for a short distance between **GO PADDY** and **ILLUMINATING**.

KEEPERCROSSED (A Forbes) shifted in under pressure early in the final straight forcing **CITADELLE** (D Bradley) inwards crowding the weakening **JABEZ** which was checked near the 200 metres. A Forbes then straightened his mount but was advised by stewards that he should have done so more quickly than he did on this occasion and was issued with a warning. **CANTERINO** lay in under pressure over the final 150 metres inconveniencing **KEEPERCROSSED** passing the 100 metres.

Race 2 PGG WRIGHTSON PREMIER

STORMING THE TOWER (A Forbes) and **ME AROHA** (V Gatu) bumped heavily at the start resulting in **STORMING THE TOWER** getting back.

CROCODILE CANYON (D Walker) and WILLY DUGGAN (M Dee) were slow away.

BELFAST LAD (M Sweeney) was caught wide early so was taken to lead in the back straight.

CROCODILE CANYON was taken forward after being very wide in the back straight.

JOSEPHINE (M Dravitzki) was held up for some distance in the home straight

Over the final stages ORMOND ROAD (R Myers) and STORMING THE TOWER came together and bumped

When questioned regarding the performance of **WHOSHE** rider B Grylls advised that the mare was unable to quicken in the improved track conditions and in her opinion would be better suited to more rain affected footing.

Race 3 HASTINGS HEART OF HAWKE'S BAY PREMIER

PIRINITETE (R Myers) was bumped at the start and got back.

SIERRA NEVADA (C Grylls) shifted in abruptly at the start and tightened JUST ISHI (J Parkes) which got back.

GAGARIN (L Whelan) raced wide rounding the first turn.

PENCURI (C Johnson) was obliged to race wide without cover throughout.

LES SYLPHIDES (M Dravitzki) improved onto the heels of **LET'S GO FRATELLI** (M Dee) passing the 1000 metres and had to be restrained.

GO JOELI (O Bosson) when improving near the 350 metres shifted out crowding **PENCURI**. O Bosson was advised to exercise care.

JUGGERNAUT ROCK (M Cameron) shifted out under pressure near the 200 metres crowding KEYORA (J Riddell), PIRINTETE, GO JOELI and PENCURI, with PENCURI being checked.

LASSWADE (D Walker) was held up rounding the turn until near the 200 metres.

TRAVELLER shifted in abruptly near the 300 metres bumping with GAGARIN.

SIERRA NEVADA was held up in the early part of the straight and near the 300 metres when attempting a run to the inside of **GAGARIN**, thereafter **SIERRA NEVADA** was denied clear running until near the 100 metres.

Race 4 LITTLE AVONDALE PER INCANTO OPEN 1200

TRAPICHE (M Du Plessis) was slow away.

Passing the 900 metres **TREPIDATION** (K Myers) was severely checked when inside **CAPITAL DIAMOND** (D Bradley) which was taken by **STORMY LASS** (R Myers) which had improved into a run inside **SITARA** (L Innes) which shifted in. L Innes denied a resultant charge of careless riding in that he permitted his mount to shift in when not sufficiently clear.

After all evidence was presented the Judicial Committee dismissed the charge.

YOUTOOFAST (M Sweeney) raced in restricted room over the final 100 metres.

Race 5 HAWKE'S BAY BREEDERS GOLD TRAIL STAKES

COSTA VIVA (M Cameron) was slow to begin.

WHISTLING DIXIE (C Grylls) began awkwardly and momentarily lost its footing.

Rider K Myers admitted a charge of careless riding in that in passing the 900 metres she permitted her mount **FANTASTIC HONOUR** to shift in when not sufficiently clear of **NEUTRON STAR** (N Harris) which was tightened and checked. After consideration the Judicial Committee was suspended Miss Myers licence to ride in races from the conclusion of racing on Saturday 28th September up until the closing of racing on Monday 7th October (6 days).

FASCINATION STREET (A Forbes) had to be steadied off heels near the 600 metres.

Race 6 AON INSURANCE BROKERS PREMIER

KAIRANGA LAD (J Parkes) began awkwardly.

HARVEST (C Johnson) began awkwardly and shifted inwards abruptly from the number one barrier.

OCEANIA (M Dee), EASY STREET (M Coleman) and SIR KINGWOOD (D Bradley) were slow to begin.

MALROSE (T Russell) over-raced when being restrained passing the 1000 metres.

VITO GENOVESE (M Cameron) raced wide without cover and ran off rounding the final bend when hanging badly.

Shortly after straightening SIR KINGSWOOD (D Bradley) shifted in abruptly hampering OCEANIA (M Dee).

KAIRANGA LAD was inclined to run in under pressure in the home straight.

Passing the 100 metres GISELA (C Grylls) lay out onto the heels of HARVEST and had to be steadied.

Post-race veterinary inspection of VITO GENOVESE and SIR KINGSWOOD failed to reveal any abnormality.

Rider of VITO GENOVESE M Cameron was of the opinion his mount was maybe unsuited to left hand racing.

Race 7 STELLA ARTOIS PREMIER

MELODIES WAY (H Tinsley) and SWORNTOPERFECTION (K Myers) were slow away.

BAY DANCER (M Coleman) jumped awkwardly and got back.

TRONIC ROSE (M Du Plessis) shifted out abruptly on jumping and tightened **WHOOPI GEE** (V Gatu) and **CORPORAL LINCOLN** (L Innes).

ZARAGOZA (M Cameron) raced three wide without cover.

MELODIES WAY was held up rounding the final turn.

KNOWING (J Parkes) lay in under pressure early in the home straight hampering **CORPORAL LINCOLN** near the 250 metres.

CORPORAL LINCOLN then shifted in, inconveniencing WHOOPI GEE.

Race 8 WINDSOR PARK PLATE

PIMMS TIME (M Sweeney) and SURVIVED (O Bosson) were slow away.

NASHVILLE (K Myers) raced keenly in the early stages.

CAPONE (N Harris) and **FULL OF SPIRIT** (M Cameron) raced three wide throughout.

SURVIVED (O Bosson) over-raced in the early stages.

PIMMS TIME shifted out under pressure in the final straight.

When questioned regarding the run of **SURVIVED** rider O Bosson stated the gelding felt unsure of its footing in the going which had become shifty after the rain prior to the race.

Rider J Parkes (RANSOMED) reported that his mount had lost its footing on two occasions, once passing the 800 metres and again at the 400 metres.

Following an inspection of the track a meeting of Club Officials, Trainers, Riders and the Judicial Committee was convened where several other riders expressed concerns relating to the lack of traction in this race. It was determined, in the interests of safety, and because conditions had deteriorated that the meeting be abandoned.
