RACE COMMENTS:

Race 1	STELLA ARTOIS PREMIER
<p>EASY STREET (D Johnson) was slow away.</p> <p>BOARDWALK (H Tinsley) raced wide throughout.</p> <p>SACRED SPIN (L Innes) was held up early in the home straight prior to gaining a run passing the 200 metres.</p> <p>EASY STREET was denied a marginal run near the 200 metres so had to be angled out to improve.</p> <p>Passing the 150 metres BUCK CANNON (N Harris) shifted out abruptly when attempting to obtain clear running making contact with HYPNOTIC (S Spratt) which was hampered. N Harris was issued with a warning.</p> <p>HARVEST (T Thornton) returned to the birdcage with blood present in its near side nostril. A subsequent veterinary inspection revealed a laceration to the nostril consistent with the mare striking its head on the barrier.</p> <p>J Riddell rider of FRANKLY (J Riddell) was issued with a warning under after allowing his mount to shift inwards near the 400 metres hampering BUCK CANNON which had to steady.</p>	
Race 2	HASTINGS HEART OF HAWKE'S BAY PREMIER
<p>LEGAL ADVICE (M Cameron) jumped inwards at the start simultaneously as BELLACAT (D Johnson) shifted out resulting in tightening to the following runners: I AM LEO (B Lammas), PIT A PAT (M Sweeney), GOLD MOET (H Tinsley) and</p>	

ROCKWEILER (M Hills). As a result **I AM LEO** and **PIT A PAT** got back. **I AM LEO** as a consequence over-raced in the early and middle stages.

Passing the 1100 metres **LEGAL ADVICE** shifted in and away from **TOLARNO** (S Collett) resulting in **GOLD MOET** being taken inwards into the line of **BELLACAT** which was checked.

ROCKWEILER raced ungenerously in the early and middle stages.

PIT A PAT raced keenly early and middle stages.

DESERT STAR (R Myers) raced wide throughout.

ABSOLUTELY SACRED (L Innes) was inclined to lay in rounding the home turn and near the 400 metres moved in momentarily crowding **LIVING THE DREAM** (M Du Plessis).

THEDEPOT (J Riddell) was held up near the 200 metres.

ABSOLUTELY SACRED was held up passing the 150 metres until the 100 metres.

ROCKWEILER was crowded near the post when racing in restricted room.

BELLACAT which was distanced at the finish underwent a veterinary inspection which failed to reveal any abnormalities.

Race 3	RUSH MUNRO'S SPRING CARNIVAL SPRINT

SHEZGORGEIOUS (S Collett) and **STORMY LASS** (D Bradley) were slow away.

OPEN 'N'SHUT (K Leung), **TRAPICHE** (M Du Plessis) and **MAGIC TRICKS** (B Lammas) began awkwardly.

TOMA VALEA (T Thornton) and **OPEN 'N' SHUT** over-raced in the middle stages.

PRINCESS MARY (A Collett) raced three wide without cover.

Passing the 600 metres **MCLAREN** (J Parkes) improved onto the heels of **TOMA VALEA** and had to be steadied, this resulted in **MCLAREN** shifting out and bumping with **PRINCESS MARY** for a short distance, in consequence **MAGIC TRICKS** which became awkwardly placed inside the heels of **MCLAREN** clipped that runners heel and blundered resulting in the trailing **SILVERDALE** (D Johnson), **TRAPICHE** and **ALDEBARAN STAR** (J Riddell) being hampered.

OPEN 'N'SHUT was held up passing the 600 metres when awkwardly placed on heels.

OPEN 'N' SHUT was then hampered near the 400 metres when awkwardly placed inside the heels of **TRAPICHE** making contact with the hind quarters of that runner.

SHEZGORGEIOUS was held up early in the home straight and had to be taken wider near the 250 metres to obtain clear running.

A post-race veterinary inspection of **YOUTOOFAS** (M Sweeney) confirmed the mare to have bled and as such is subject to the mandatory three month stand down period.

PRINCESS MARY returned to the birdcage with blood present in its nostril and a post-race veterinary inspection revealed a laceration.

Following this race the track was upgraded to Good (3).

Race 4	THE ROBYN MACTAGGART CUP

BELLAZEEL (L Innes) reared at the start and failed to jump on terms taking no further part in the race. When questioned, rider L Innes reported that **BELLAZEEL** had got its tongue over the bit which resulted in him being unable to control the mare. Stable representative Ms L Bertling was advised that **BELLAZEEL** is required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

AUSPICIOUS (M Cameron) shifted out shortly after the start crowding **LAUREN TATE** (R Myers) out onto **PIONEER** (H Tinsley) which resulted in **PIONEER** having to be steadied away from the heels of **GO JOELI** (D Johnson).

VICEROY (M Hills) was slow away.

Passing the 1800 metres **LAUREN TATE** had to steady when in restricted room adjacent to the rail.

Race 5	TRINITY HILL PREMIER MILE

WISECRACK (M Du Plessis) and **SECOND HOPE** (A Collett) were slow away.

I'M NOT TICKLISH (D Bradley) had to be eased when going into the first turn when racing keenly then continued to over-race throughout proving a difficult ride.

ENUFFISENUFF (M Dravitzki) raced three wide without cover throughout.

WISECRACK was obliged to improve wide rounding the home turn.

Prior to the authorisation of dividends, N Harris, rider of the second placed **BREAKING DAWN** viewed Steward's video footage before electing not to proceed with an objection against **IMPERIAL MISS** (M Cameron) which shifted out over the final stages.

Race 6	DHL HAWKE'S BAY GUINEAS

PHILIPA CHARLOTTE (N Harris) and **ALL DECKED OUT** (M Cameron) jumped inwards tightening **LORD TURBO** (D Johnson) which got back.

SALAMANCA (R Myers) began awkwardly.

ALL DECKED OUT had to be steadied off the heels of **DONNIE BRASCO** (S Spratt) near the 1000 metres and in doing so came back onto **LUCKY FEATHER** (T Thornton), **TOUCHE** (J Riddell), **SIR ANDREW** (M Du Plessis) and **WOLFVHISTLE** (L Innes) which all had to take evasive action. S Spratt the rider of **DONNIE BRASCO** admitted a resultant breach under [Rule 638(1)(d)] (careless riding) in that she permitted her mount to shift in when not clear. After consideration the Judicial Committee suspended Miss Spratt's licence to ride in races from close of racing Wednesday 9th October up to and

including racing on Friday 18th October (6 days).

LUCKY FEATHER then began to over-race.

TOUCHE was then obliged to race three wide.

TOUCHE was inclined to lay in under pressure in the final straight.

WOLFWHISTLE was reported to be making abnormal breathing noises, with Trainer J Bridgeman advising that the colt is likely to have a wind operation.

Race 7	DUNDEEL ALL AGED SALVER

ENDOR (M Cameron) was slow away.

THE DOLPHIN (R Stam) raced three wide without cover throughout.

Entering the home straight on the first occasion **TITCH** (L Whelan) commenced to over-race when the pace ahead eased and went back onto **JUGGERNAUT ROCK** (S Spratt) and **ME AROHA** (D Bradley) which had to steady.

GO PADDY (M Du Plessis) bumped with the weakening **THE DOLPHIN** near the 500 metres.

CANTERINO (D Johnson) and **SIERRA NEVADA** (T Thornton) bumped on several occasions down the home straight.

A post-race veterinary inspection of **ENDOR** which raced disappointingly did not reveal any abnormality. Rider M Cameron was unable to offer any excuses.

Race 8	TUMU ITM SPRING SPRINT

ELUSIVE TRACY (L Whelan) began awkwardly and got back.

TAURUS (J Parkes) was slow away.

SPIN DOCTOR (S Spratt) began awkwardly.

SCAPOLO (D Walker) was inclined to over-race in the early and middle stages.

CAPITAL DIAMOND (D Bradley) raced wide without cover.

HISTORIAN (M Cameron) raced keenly in the back straight and had to be restrained off the heels of **ANTONIO LOMBARDO** near the 900 metres and in doing so lay out bumping **FRITZY BOY** (J Riddell) for a distance.

SCAPOLO raced very wide without cover throughout.

BRAVE CENTAUR (M Hills) had to be restrained off heels when racing keenly at the 700 metres.

FRITZY BOY was inconvenienced in the early part of the home straight.

ANTONIO LOMBARDO was held up rounding the turn and near the 200 metres was taken wider to improve however failed to obtain clear running and went to the line without being fully tested.

When questioned regarding the performance of **BRAVE CENTAUR** rider M Hills was unable to offer any excuses, advising that the gelding had finished the race off only fairly. A post-race veterinary inspection failed to reveal any abnormality.

Race 9	THE TURKS SPRING CLASSIC

POSTMAN'S DAUGHTER (D Johnson) bounded at the start and lost ground.

PIMMS TIME (M Sweeney) and **SURVIVED** (H Tinsley) bumped at the start.

THRIVE (M Cameron) was slow away from the outside barrier.

STORMING THE TOWER (R Jones) shifted out on jumping crowding **NASHVILLE** (R Myers) which got back.

Shortly after the start **POSTMAN'S DAUGHTER** and **SORIANO** (N Harris) came together and bumped when in restricted room to the inside of **DEANE MARTIN** (M Coleman) which shifted in and away from **ORMOND ROAD** (T Thornton).

SORIANO then commenced to over-race.

SURVIVED (H Tinsley) raced three wide without cover throughout.

PIMMS TIME raced keenly throughout.

NASHVILLE was obliged to make it finishing run wide rounding the final turn.

SORIANO was held up for a short distance near the 300 metres.

PERO (J Riddell) lay in throughout the final straight and near the 200 metres had to be steadied away from the heels of **ZENNISTA** (M Du Plessis).

Race 10	LET'S GO TO TURKS SPRING FINALE

URUNGA (L Whelan) was crowded shortly after leaving the barriers when runners either side shifted ground.

ZINKO (A Collett) was held up rounding the home turn and denied a marginal run between **MACKA'S BACK** (D Bradley) and **VICTORY DRAGON** (H Tinsley).

URUNGA was checked out of a run near the 150 metres when inside **ZA PAK** (J Riddell) which shifted in.

J Riddell admitted a resultant breach of [Rule 638(1)(d)] (careless riding) and after consideration the Judicial Committee suspended J Riddell's licence to ride in races from the close of racing Saturday 12th October up to and including racing on Saturday 19th October (5 days).
