RACE COMMENTS:

Race 1	FOR HOMES FOR FARMS DASH 1200M
<p>SANGUY dislodged rider M Hudson inside the parade ring and after travelling a short distance was recaptured. SANGUY underwent a veterinary examination behind the barriers and was past fit to start.</p> <p>SANGUY began awkwardly and settled back.</p> <p>ROSE AND CROWN jumped outwards abruptly at the start hampering VIAMAN.</p> <p>GODZILA GIRL began awkwardly and was slow away.</p> <p>SIXTY EIGHT CARAT raced three wide without cover throughout.</p> <p>When questioned into the run of ALI GATOR which finished some distance last, rider M Dee could not offer any excuse.</p>	
Race 2	JAMES BRIDGE RACING STABES FLYERS 1100M
<p>I AM LEO reared at the start.</p> <p>DAL VUITTON raced four wide without cover throughout.</p>	

TINKA TINKA when being ridden out, shifted out abruptly inside the final 50 metres into the line of **I AM LEO**, which was hampered. Also affected in the incident was **ITSA TRU STORY** (M Hudson), resulting in the rider having to stop riding near the finish. Prior to the authorization of dividends, connections of **I AM LEO** (M Dravitzki), (2nd) lodged an objection under Rule 642(1) against the winner **TINKA TINKA** (J Parkes) alleging interference over the final stages. After hearing submissions the protest was dismissed. Rider J Parkes defended a charge of careless riding under Rule 638(1)(d) and after hearing submissions the JCA found the charge proved. J Parkes had his license to ride in races suspended from the conclusion of racing on Saturday, 19 October 2013 up to and including racing on Friday, 25 October 2013 (3 days). When questioned into the run of **PURE OCTAINE**, rider R Myers could not offer any tangible excuse however was of the opinion the mare would improve with the run. Following the event rider M Dravitzki (**I AM LEO**) reported that she had dropped her whip near the top of the straight.

Race 3 | **BAMBRY'S WATER TREADMILL DASH 1200M**

MASSEY DASH stood flatfooted in the gate and lost ground (10L). Connections were advised that the mare must trial to the satisfaction of stewards prior to its next start.

DIAMOND FLUSH was slow away and was then inclined to race greenly.

TONTO MAC hung outwards badly throughout, proving a difficult ride.

Race 4 | **D & G AUTOSPRAY STAYERS 2200M**

KEYORA was slow to begin.

EARL OF DONCASTER shifted out abruptly on jumping away and got back.

RED RUBY, when racing keenly, made the crossing near the 1700 metres awkwardly.

SELWYN raced keenly over the early and middle stages.

EARL OF DONCASTER was obliged to race wide without cover over the final 800 metres.

RED RUBY lay in rounding the final turn and early in the final straight, having to be straightened on several occasions.

J Parkes (**RED RUBY**) was issued with a warning under Rule 638(3)(b) with regard to the use of his whip prior to the 200 metres.

Following the running of Race 4, the track was upgraded to Slow (8).

Race 5 | **WOODVILLE JUMPOUTS ASSOCIATION DISTANCE 2100M**

STRAIGHT AHEAD began awkwardly making contact with **ST'RUTH**.

BLACK DRAGON began awkwardly and shortly after was further hampered when **DIAMOND BELLE** shifted out.

THORA BOB raced wide without cover over the early stages prior to being allowed to stride forward to sit outside the leader near the 1600 metres.

ST'RUTH was obliged to race three wide without cover over the final 1200 metres.

EARL SPENCER was briefly held up rounding the final turn.

STRAIGHT AHEAD was held up for some distance rounding the final turn and obtained clear running passing the 200 metres.

FALSE EMPATHY was held up early in the final straight and had to shift ground outwards near the 250 metres to obtain clear running.

Race 6 | **STEWARDS HANDICAP 1400M**

JOE COOL jumped away awkwardly making contact with the side of the barrier and unbalancing rider K Kalychurun, who lost the use of his near side iron and as a result lost considerable ground (5L).

GOLD'N'CASINO bounded leaving the barrier.

KUZANOV shifted in shortly after the start forcing **BEAU AGEN** into the line of **BAY DANCER**, which in turn was forced inwards on to **NENA GREENA**, which was tightened and lost ground.

KUZANOV over-raced in the early and middle stages when leading.

BEAU AGEN raced three wide without cover throughout.

NENA GREENA had to be steadied and angled wider near the 400 metres when improving up on to the heels of **LITTLE STORM**.

Apprentice jockey M Cheung (**LITTLE STORM**) was issued with a warning under Rule 638(3)(b), with regard to the use of his whip prior to the 200 metres.

Race 7 | **MARTIN BEVERIDGE PAINTING CONTRACTORS 1600M**

B Lammas sustained an injury to his shoulder during the race so stood down for his remaining ride and was advised that a medical clearance is required.

MAN VERSUS WILD raced three wide without cover over the early stages prior to being allowed to improve forward to lead near the 1100 metres.

Race 8	GOURMET STAY METRIC MILE 1600M
<p>Due to the unavailability of a senior rider, B Lammas was replaced by A Frye on FREDERICK WILLIAM. FREDERICK WILLIAM over-raced near the 1400 metres and had to be restrained off the heels of ELEGANT MADAM for a short distance.</p> <p>ELEGANT MADAM when improving near the 800 metres shifted out and forced HOLY SMOKE over extra ground.</p> <p>JUST ISHI was obliged to race three wide without cover throughout.</p> <p>MINI PEARL was held up for some distance rounding the turn.</p> <p>RUMOUR HAS IT NOW hung out rounding the final bend.</p> <p>HOLY SMOKE hung in the home straight.</p> <p>LANGDON had difficulty obtaining clear running early in the home straight but failed to run on when clear.</p> <p>ELEGANT MADAM shifted in near the 300 metres and when being straightened shifted out abruptly hampering ISHIAROSE for a short distance.</p> <p>When questioned into the run of ISHIAROSE, rider A Forbes had no tangible excuse; however he was of the opinion the mare may be better suited to a more rain affected going. Connections advised that ISHIAROSE would now be sent for a spell.</p> <p>When questioned into the run of CHILL BILL, rider M Dee advised that he had got further back than intended and only ran on fairly in the home straight. M Dee was of the opinion the gelding may be better suited to a more rain affected going.</p>	
Race 9	BILL SMITH MEMORIAL 1400M
<p>OCEANIA refused to jump away and missed the start by 100 metres. Connections were advised that OCEANIA must trial to the satisfaction of stewards on more than one occasion prior to its next start. Trainer G Innes advised that he would spell OCEANIA for an extended period and also give consideration to retiring the filly.</p> <p>ARIBASAN was slow to begin.</p> <p>PERRY MASON made the bend near the 800 metres awkwardly. PERRY MASON was obliged to race three wide without cover for the remainder.</p> <p>SARABI shifted out near the 700 metres making contact with ALL GINGA, which became unbalanced briefly.</p> <p>PERRY MASON, the winner, was inclined to shift out in the straight.</p>
