## RACE COMMENTS

## Race 1 McENTEE EVENT HIRE PREMIER (1400 metres)

B Lammas was unable to make the required weight for LA CLAIRETTE; however due to there being no replacement rider available was permitted to ride the mare 1.2 kg over weight. Rider Lammas admitted a resultant breach of Rule 330 (3) (c) and after consideration the Judicial Committee imposed a fine of $\$ 500$.
NO ENEMY shifted out on jumping bumping with PHOENIX TYCOON which in turn bumped with BAM A LAM.
WORKING CLASS raced three-wide without cover throughout.
BARNIE O'MARNIE had to steady passing the 600 metres when attempting to improve into a tight run to the inside of LEGAL ADVICE (L Innes) which lay in. L Innes was advised that when in similar circumstances he is expected to provide sufficient room to runners on the inside.
When questioned on the performance of MEURSAULT, rider K Myers reported that she was of the opinion the mare jarred up in the prevailing track conditions.
When question on the performance of last-start winner LORRAINE, D Bradley could offer no excuses. LORRAINE returned to the enclosure with blood present in the mouth and a subsequent veterinary examination revealed the mare had suffered a laceration to the gum.

THE JEUNEYMAN had to steady passing the 200 metres, when weakening, after MASSALE which was improving on the outside, shifted in when only marginally clear. J Riddell was advised to exercise care when in similar circumstances.
Race $3 \quad$ RICOH PREMIER (2000 metres)

JULIANN made firm contact with the running rail during its preliminary and underwent a veterinary examination at the barrier before being cleared to start.
ANGEL MINE and HER TO ETERNITY were slow to begin.
GREY POWER raced wide in the early stages before being allowed to stride forward to sit outside the leader near the 1200 metres.
FREDRICK WILLIAM was held up throughout the final straight and over the concluding stages was placed in restricted room between MCDAIDS and GREY POWER, which lay out.
HER TO ETERNITY was held up rounding the turn until near the 200 metres.

## Race 4 RICH HILL STUD PREMIER (1400 metres)

KAIRANGA LAD began very awkwardly and lost ground.
WEREGOINGTOGETCHA and WHATWEDO were slow away.
KAWI and FAR FETCHED were tightened when making the junction onto the course proper after there was simultaneous movement from WHATWEDO and FAR FETCHED. WEREGOINGTYOCETCHA which was trailing had to steady in consequence. After questioning riders, no further action was deemed necessary.
FAR FETCHED and ENHANCE over-raced in the early stages.
KAIRANGA LAD got its head up near the 1200 metres when being restrained.
OVERTHERIVER raced three-wide throughout.
ENHANCE had to steady shortly after straightening when attempting to improve into a marginal run to the inside of
KAIRANGA LAD and contacting the hindquarters of that runner. KAIRANGA LAD was in turn forced outwards onto
WEREGOINGYTOGETCHA and clipped that runner's heel. Shortly after, ENHANCE again had to steady was outside KAWI which, when attempting to improve, was taken out by OVERTHERIVER which lay out under pressure. Stewards spoke to advisedly to apprentice M Dee (ENHANCE) with regard to the practice of improving into a run which had not fully developed.
KAWI was then held up for a short distance prior to gaining clear running near the 200 metres.

## Race 5 BROKERWEB RISK SERVICES MANAWATU PREMIER ( $\mathbf{1 2 0 0}$ metres)

DANCER'S TALE shifted out on jumping and then had to be steadied off heels.
BATMAN was slow away.
JERRICO raced keenly in the early stages.
JERRRICO was denied a marginal run near the 300 metres and was then held up only obtaining clear running in the final 100 metres.
SANRIBA raced three-wide without cover throughout.
MANU was inclined to over-race throughout.
SANRIBA lost the near side front plate during the running.
When questioned regarding the run of DANCER'S TALE, rider L Innes could offer no excuses.
Stewards ordered a post-race veterinary examination of REBOUND, which ran last, with this revealing the gelding to be suffering from an irregular heartbeat after the event. Trainer C Wood was advised that the gelding will need a veterinary clearance before next racing.

## Race 6 HOTEL COACHMAN MANAWATU CUP - Gp III (2300 metres)

LADY PLATINUM shifted out on jumping away and tightened ON THE LEVEL.
HELL YEAH raced wide around the first turn.
WHO SHOT THEBARMAN got its head up when being steadied to trail near the 1800 metres.
LADY PLATINUM raced keenly in the middle stages.
SANTOS over-raced in the middle stages.
HELL YEAH had to steady abruptly approaching the 800 metres when CROCODILE CANYON (J Parkes) and WHO SHOT
THEBARMAN improved around the outside and crossed when only marginally clear. After questioning riders it was established that after making forward runs, as a consequence of an indifferent pace, WHO SHOT THEBARMAN, who was proving difficult to restrain, had shifted in and away from CROCODILE CANYON which shifted in when improving. Stewards determined that now further action was necessary other than to remind J Parkes that when in similar circumstances he is expected to provide sufficient room to runners on the inside.
HELL YEAH again had to steady near the 600 metres after becoming awkwardly placed between RE DEEL and WHO SHOT THEBARMAN.
RE DEEL and LADY PLATINUM bumped near the 100 metres with RE DEEL momentarily becoming unbalanced.
BACK IN BLACK was denied clear running in the home straight until near the 100 metres.
A post-race veterinary inspection of ON THE LEVEL, which ran last, revealed no abnormalities.

## Race 7 HARCOURTS PREMIER (1600 metres)

MADONNA MIA and LOCKET were slow to begin.
TRADTRI over-raced in the early stages.
DONTDYEWONDERIN raced three-wide throughout.
THE BACHELOR raced wide from the 1000 metres.
Near the 200 metres LUSTRE and LANDLORD were both tightened when CRIXUS shifted out under pressure
simultaneously as DONTDYEWONDERIN shifted in. C Grylls (DONTDYEWONDERIN) was reminded of his obligations when shifting ground.
MADONNA MIA which was checked passing the 200 metres when outside BRAD THORN (P Turner) which, when taken out to obtain clear running, shifted out.
P Turner defended a charge of careless riding under Rule 638 (1) (d); however after consideration the Judicial Committee found the charge proved, and after hearing submission relating to penalty imposed a suspension of Apprentice Turners licence to ride in races from the close of racing on 26 December 2013 until the close of racing on 31 December 2013 (4 days).

## Race $8 \quad$ CASH CONVERTERS - Gp III (1400 metres)

RINGO was slow to begin.
Stewards questioned rider C Johnson regarding the run of FINAL TOUCH which ran fourth. Mr Johnson stated that the mare had travelled well during the running but when pressured passing the 250 metres had failed to respond as anticipated and was disappointing. Mr Johnson added that FINAL TOUCH had pulled up well following the event. Stewards will be enquiring into the mares progress over coming days.

## Race 9 MURPHY PROPERTIES PREMIER (2300 METRES)

ELLIE'O and SILK CHARDONNAY were slow to begin.
KOOL RETURN ran off near the crossing at the 1500 metres and was pulled up. Trainer M Oulaghan was advised that the gelding must trial before next racing.
SPIKE MILLIGAN (C Grylls) was tightened and checked near the 600 metres. After questioning riders and viewing video footage, it was established that SPIKE MILLIGAN, which was racing immediately to the inside of CORPORAL LINCOLN had hung out simultaneously as CORPORAL LINCOLN was attempting to improve into a marginal run to the inside of
PEACEFULEASYFEELIN and this had resulted in SPIKE MILLIGAN becoming awkwardly placed and having to steady. It was determined that no further action was necessary.
SOUTHERN SECRET was tightened rounding the bend at the 400 metres when THE BEAMA lay out.
SOUTHERN SECRET was inclined to lay out in the early part of the straight.
