| Race 1 | Tulloch Café 1400 |
| <p>EIGHT TO RULE (R Smyth) raced wide without cover throughout. Passing the 400 metres OPT (K Myers) shifted out to obtain clear running making contact with ARANMORE (M Cameron) which was shifting in slightly with both runners becoming briefly unbalanced. PANAMBA (B Grylls) had difficulty obtaining clear running early in the final straight. When questioned into the performance of the well supported ARANMORE Rider M Cameron felt that on this occasion they would attempt to ride the gelding back in an endeavor to get the gelding to finish the race off and also and that the gelding may have been feeling the effects of the firmer nature of today's track conditions.</p> | |
| Race 2 | New Lynn 1600 |
| <p>YULEANNE (C Grylls) and CAPINSKY (L Innes) were both slow to begin. Passing the 1300 DREAMWORLD (S Collett) had to be steadied off the heels of SERENANOVA (B R Jones) which shifted in. DREAMWORLD raced three wide without cover throughout. YULEANNE shifted out passing the 300 metres making contact with SO HIGH (M Cameron) which became briefly unbalanced. YULEANNE then continued to shift out passing the 250 metres inconveniencing SO HIGH and OUR SERAFINA (R Hutchings) both of which were dictated a little wider on the track. SERENANOVA returned to the enclosure with a trickle of blood in the right nostril. After being inspected by the</p> | |

Veterinarian it was found to have a minor laceration in the right nostril.

LADY KALIMARA which was the favourite, finished well back. When questioned, Rider D Johnson could offer no reason for the filly's performance. A post race veterinary examination failed to reveal any obvious abnormalities.

Race 3 | **Avondale Supporters Club 1600**

EPICUREAN (A Forbes) began awkwardly, losing ground.

A PERTE DE VUE (C Dell) was slow to begin.

CORRAL (K Leung) began awkwardly.

Shortly after the start **THE POACHER** (K Joyce) shifted in placing **EPICUREAN** in restricted room.

A PERTE DE VUE (C Dell) raced a little ungenerously in the early stages making the crossing awkwardly when linking on to the Course Proper.

LONGBEACH (R Hutchings) was inclined to lay out when making the bend near the 800 metres, continuing to do so for the remainder of the bend.

Approaching the 400 metres **A PERTE DE VUE** had to be steadied when being asked to improve on to runner's heels. C Dell was advised he must exercise far greater care.

Passing the 150 metres **LIQUID ASSET** (M Cheung) shifted out under pressure making contact with **DIESEL** (A Collett).

Apprentice Rider K Leung was questioned as to the performance of **CORRAL** and could offer no tangible reason for the gelding's performance.

An enquiry was open and adjourned into the ride on **JIGGER INN** (A Taylor) over the concluding stages, A Taylor was charged under Rule 636(1)(d) to which she entered no plea a hearing will be at a date set by the Judicial Control Authority.

Race 4 | **Avondale Business Association 1200**

GIARDINI (O Bosson) and **JUSTTHEANSWER** (D Johnson) both began awkwardly.

JUSTTHEANSWER raced a little ungenerously through the middle stages.

Race 5 | **Functions@TheFalls.co.nz**

HABITUAL OFFENDER was late scratched at 2.30pm due to the upgrade in track conditions.

O Bosson failed to make the weight on **DIAMOND EDGE** and was replaced by D Johnson. O Bosson was fined \$100. The rider change was not updated with the TAB and Course Commentator due to error from the Stewards.

DIAMOND EDGE (D Johnson) began to over-race near the 1200 metres when the pace steadied and continued to do so for some distance.

BEYOND ALL DOUBT (R Hutchings) lost ground in the early stages before catching the body of the field approaching the 1000 metres but failed to run on finishing well back. When questioned R Hutchings said the gelding was reluctant to hit out throughout, possibly feeling the effects of the firmer nature of the track.

Passing the 150 metres **SAM MESI** (B Grylls) had to steady and shift out across the heels of **IT'S GOT TO BE YOU** (C Grylls) which lay in under pressure. **SAM MESI** then had difficulty obtaining clear running for the remainder of the race.

Race 6 | **Ron Murphy Memorial 2200**

CHAZELLE (M Coleman) and **SIR MANAWA** (M Du Plessis) both began awkwardly.

PEFFECT ROSE (R Smyth) and **GRACE O'MALLEY** (K Myers) both over-raced in the early stages.

CURTAIN CALL (T Thornton) raced wide without cover until passing the 900 metres.

ALEZAN (R Hutchings) was held up early in the final straight.

GRACE O'MALLEY was held up entering the final straight.

PERFECT ROSE was crowded passing the 300 metres when **ALEZAN** shifted out to obtain clear running.

Race 7 | **Battersby Funeral Services 1200**

CHALET QUEEN (P Turner) began awkwardly, losing considerable ground.

RUSTY HEIGHTS (M Cheung) shifted out when leaving the barriers making contact with **MINGS MAN** (A Forbes) with **CLOSE UP** (R Hutchings) then shifting away from **MINGS MAN** making contact with **JAJA JILL** (B Grylls).

50 metres after leaving the barriers **FLYING BRIAR** commenced to buck dislodging Rider K Leung. K Leung was uninjured. Trainer R Lang was advised that **FLYING BRIAR** would be required to barrier trial to the satisfaction of Stewards prior to racing next.

WESHALLSEE (A Taylor) over-raced when being restrained in the early stages.

Stewards opened and adjourned an inquiry into the reasons **TURRET HILL** (A Collett) was forced through the running rail near the 900 metres, dislodging rider A Collett. As a result **DALEZINGA** (T Wenn) and **CIRCUS** (A Jones) were hampered being forced wider on the track.

Apprentice Rider A Collett suffered bruising and is to undergo a further medical evaluation and is to produce a medical certificate prior to riding next.

AFFOGATO (C Dell) shifted in approaching the 800 metres crowding **JAJA JILL** (B Grylls) and **MINGS MAN** (A Forbes). C Dell was severely reprimand by Stewards and advised he must exercise better judgement.

RUSTY HEIGHTS over-raced through the middle stages.
