#### **RACE COMMENTS:**

Race 1 JOHN BARY RACING 2YO DASH (800 metres)

**CHATEAU MAROUX** was slow away.

**LENIN THE BROWN** began awkwardly hampering **SABER**, which was bumped outwards, badly hampering **KNIGHT'S PRINCESS**. which lost ground.

SACRED TRUST and ALL CHARM both began awkwardly and came together leaving the barriers.

**LIME STREET** over-raced when being restrained in the middle stages and was inclined to hang outwards rounding the turn. When shifting to the outside of **LENIN THE BROWN**, near the 300 metres, **SABER** was taken out slightly by that runner, with

**CHATEAU MAROUX** then shifting away from **SABER**, making contact with **SACRED TRUST**; **CHATEAU MAROUX** and **SACRED TRUST** both became unbalanced as a result.

R Myers reported that **ALL CHARM** may be better suited to a longer distance.

Race 2 JOHN BARY RACING 2YO DASH (800 metres)

BATTLE CREEK and PRICE TAG were slow to begin.

MAIA'S ANGEL shifted outwards leaving the barriers hampering XCUSES XCUSES, which was forced outwards into the line

of **BATTLE CREEK**, further hampering that runner.

**ANUKA** hung outwards throughout the race.

**LINCOLN STREET** had some difficulty obtaining clear running early in the final straight.

**ROCKAFILLY** was unable to be fully ridden out when racing greenly and being inclined to lay inwards in the straight.

**KASEY BELLE** raced greenly when placed under pressure in the straight.

## Race 3 GAME LODGE 3YO MAIDEN (1200 metres)

**PENTOLADORO** was a late scratching at approximately 10.35am due to transport difficulties.

**HONEY QUEEN** was slow away.

**SUPER SCOT** began awkwardly.

**TOOTHPIC** raced greenly throughout.

ABYSSINIAN MAID raced three wide without cover.

**CHINA STAR** had to be steadied off the heels of **BONETE** when the paced eased passing the 800 metres, going back on to **HONEY QUEEN**, which had to be firmly restrained, hampering **LINCOLN INN** and **SUPER SCOT**. Also having to be steadied at that point of the race with the easing of the pace was **HENI** and **SILVER SHADOW**.

**SUPER SCOT** was steadied when racing in restricted room to the inside of **SILVER SHADOW** near the 600 metres.

When questioned regarding the disappointing performance of **TOOTHPIC**, rider M Cameron advised that the filly had travelled comfortably enough but had been unable to quicken when placed under pressure.

## Race 4 LIQUOR KING NAPIER MAIDEN SPRING (1400 metres)

**GOLDYSOX** was slow to begin.

**CYCLONE TRACY** jumped away awkwardly making heavy contact with **VELAZQUEZ**, which was forced outwards crowding **FAZED**, **REEFED** and **HORIZON**, with **REEFED** and **HORIZON** both having to be steadied, losing ground.

**RHYTHMS OF NATURE** over-raced in the lead through the early and middle stages.

ARMANDO and SEAWEED raced wide without cover.

**DEESSE DE LA MODE** hung outwards rounding the turn.

**STONEMASON** was held up early in the final straight.

## Race 5 WAIKATO STUD 1400 (1400 metres)

**HEART OF DARKNESS** began awkwardly, inconveniencing **RED MAFIA**.

**RED MAFIA** had to be steadled to avoid the heels of **ESQUINA** near the 900 metres when that runner shifted away from **HEART OF DARKNESS** (M Cameron) after being taken in slightly. M Cameron was advised to exercise more care.

**S Doyle** admitted a breach of careless riding under Rule 638(1)(d) in that he permitted his mount **COMMETT** to shift inwards passing the 900 metres when not sufficiently clear of **ALDERBARAN STAR**, which was checked. Hampered as a result was **GENDARME**. After hearing submission the judicial committee suspended S Doyle's licence to ride in races from the conclusion of racing on Saturday 19 July until the conclusion of racing on Wednesday, 30 July (4 riding days). Rider J Parkes had no excuse for the disappointing run of RANI AURORA.

Midel Frances had no excuse for the disappointing run of MAIN AONONA.

A post-race veterinary examination of **RANI AURORA** did not reveal any abnormality.

A post-race veterinary examination of **COMMETT** found the gelding to have suffered superficial lacerations to the left hind leg, with **COMMETT** also having sprung the right front plate.

#### Race 6 MANAWATU SOUND SERVICE SPRINT (1200 metres)

WHOOPI GEE over-raced in the early stages.

Shortly after entering the home straight **ABSOLUTELY SACRED** (J Parkes) was held up and unable to improve, before being angled outwards near the 300 metres when not clear of **DARBY SHAW** (M Dee), which was severely checked, resulting in rider M Dee being dislodged. Also hampered was **SIR KINGWOOD**.

Stewards lodged an information alleging a breach of Rule 637(1)(b), resulting from **ABSOLUTELY SACRED** causing severe interference early in the home straight. After hearing submissions the Judicial Committee determined that **ABSOLUTELY SACRED** be disqualified from first placing. Final placings now read: (1) SIR KINGWOOD, (2) WHOOPI GEE, (3) SNOW **EXCUSE**, (4) NEUTRON STAR, (5) PASSING PARADE.

Rider M Dee (DARBY SHAW) was taken to hospital for further evaluation before being subsequently discharged.

J Parkes (ABSOLUTELY SACRED) admitted a resultant charge under Rule 638(1)(b) (reckless riding) and after deliberations had his licence to ride in races suspended from the conclusion of racing on Saturday, 19 July until the conclusion of racing on Saturday, 30 August (6 Weeks).

**PASSING PARADE** returned to the birdcage with blood present in both nostrils. Following a veterinary inspection **PASSING PARADE** was confirmed as a bleeder and is now subject to the mandatory three month stand down with veterinary clearance required prior to **PASSING PARADE** racing or trialing again.

## Race 7 DEAN ATKINS MILE (1600 metres)

This event was officially put back 5 minutes before running approximately 7 minutes late due to the inquiry in the previous race

PARTY ICE was tightened at the start and got back.

LAVISH PRINCE was slow away.

SPIKE MILIGAN had to be steadied when over-racing at the end of the back straight.

**GOLD WEDDING** raced wide, prior to gaining a run one off near the 800 metres.

When questioned into the run of **ALPHABET STREET**, rider A Jones said the gelding travelled well to the home turn but failed to run on as expected. A post-race veterinary inspection of **ALPHABET STREET** failed to reveal any abnormality.

### Race 8 <u>www.hawkesbayracing.co.nz</u> – FOR SPRING PACKAGES MILE (1600 metres)

This event started at the scheduled time.

JULIETA was slow to begin.

THE MIG shifted outwards leaving the barriers, inconveniencing KALGOORLIE BOMBER.

**GOLD MOET** began awkwardly and then had to be steadied going into the first turn near the 1450 metres when awkwardly placed on heels.

VICEROY raced three wide without cover until near the 800 metres.

**JULIETA** (D Bradley) over-raced in the middle stages. Rider D Bradley (**JULIETA**) said the mare had little left at the finish after over-racing but was nevertheless disappointing. A subsequent veterinary inspection failed to reveal any abnormality. **KAYZED** (R Myers) disappointed, finishing last. Rider R Myers had no excuse. A subsequent veterinary inspection failed to reveal any abnormality.

# Race 9 JB ORGANICS SPRING CARNIVAL STARTS AUG 30<sup>TH</sup> (1200 metres)

SHEZ BUBBLY and DANNY BOY were both hampered when crowded at the start.

BACHELOR MAN was hampered at the start and got back.

**ARCHANGEL** (A Jones) hung badly throughout the race, proving a difficult ride, having to be firmly restrained going into the bend at the 800 metres, when improving into restricted room, despite the efforts of its rider.

PURE BLONDE and JACKSON STREET raced wide without cover.

**ARCHANGEL** continued to hang outwards badly in the final straight, finishing on the extreme outside of the track. S Collett the rider of **SHEZ BUBBLY** had no excuse for the disappointing run of **SHEZ BUBBLY**. A subsequent veterinary inspection failed to reveal any abnormality.
